In consideration of SENATE BILL 1610, SENATE DRAFT 2 RELATING TO OHANA ZONES

Senate Bill 1610, Senate Draft 2 establishes the Ohana Zones Program as a permanent program within the Statewide Office on Homelessness and Housing Solutions (OHHS), exempts ohana zones projects from general excise taxes, requires annual reports to the Legislature, and appropriates funds. The **Department of Land and Natural Resources (Department) offers the following comments.**

This measure requests that OHHS work with appropriate state or county agencies to transfer land determined to be suitable for use as an ohana zone to OHHS. The Department recognizes the need for innovative solutions to the ongoing housing crisis but notes that most lands under the jurisdiction of the Board of Land and Natural Resources which are located in urban areas and have access to infrastructure are already set aside to other government agencies or otherwise under long-term dispositions. The Department remains committed to assisting OHHS in implementing the Ohana Zones Program.

The Department of Taxation (DOTAX) offers the following <u>comments</u> regarding S.B. 1610, S.D. 2, for your consideration.

Section 1 of S.B. 1610, S.D. 2, under chapter 346, Hawaii Revised Statutes (HRS), would establish the Ohana Zones program within the statewide office on homelessness and housing solutions.

Section 2 of the bill amends section 201H-36(a)(2), HRS, to allow the Hawaii Housing Finance and Development Corporation (HHFDC), in accordance with section 237-29, HRS, to approve and certify for exemption from the general excise tax (GET) any qualified person or firm developing a newly constructed, or a moderately or substantially rehabilitated project, under the Ohana Zones program. Section 2 also amends section 201H-36(b)(2), HRS, to condition eligibility for the GET exemption upon Ohana Zone projects entering into a regulatory agreement with HHFDC for a minimum 10-year term. The measure has a defective effective date of December 31, 2050, and would be repealed on June 30, 2026, with sections 201H-36(a) and (b) then reverting to their prior form.

DOTAX can administer this measure with an effective date of July 1, 2025, or later.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the intent of the bill, defers to the Office of Homelessness and Housing Solutions (OHHS), provides comments, and requests clarification. The executive budget includes a request for \$50M for each year of the biennium to the OHHS, and DHS respectfully requests that any appropriation not replace or reduce a priority identified in the executive budget.

PURPOSE: This bill establishes the Ohana Zones Program as a program within the Statewide Office on Homelessness and Housing Solutions. Authorizes the Hawai'i Housing Finance and Development Corporation to exempt ohana zones projects from general excise taxes. Requires annual reports to the Legislature. Appropriates funds. Effective 12/31/2050. Sunsets 6/30/2026. (SD2)

The Committees on Health and Human Services and Housing amended the measure by:

- (1) Inserting language to clarify that "ohana zone" includes a kauhale;
- (2) Inserting an effective date of December 31, 2050, to encourage further discussion; and

The Committee on Ways and Means amended this measure by:

- (1) Deleting the purpose section;
- (2) Adding a definition of the term "kauhale";
- (3) Requiring kauhale to have connections to public utilities, such as water, sewer, and electricity;
- (4) Establishing an unspecified maximum amount of appropriated moneys that may be expended on kauhale;
- (5) Inserting a repeal date of June 30, 2026;
- (6) Amending the appropriations to apply only to the 2025-2026 fiscal year; and
- (7) Making technical nonsubstantive amendments for the purposes of clarity, consistency, and style.

DHS supports the establishment of a permanent Ohana Zone Program to be administered by the State Office on Homelessness & Housing Solutions, as the Ohana Zone Pilot Program was successful in supporting a variety of solutions to address homelessness across the State. The collaboration between the State and County-based initiatives is the notable strength of the Ohana Zone Pilot Program projects, as sustainable efforts were aligned. The Ohana Zone Pilot Program also allowed support for testing and innovating solutions that were not supported by federal funds, especially during the COVID-19 pandemic when state funds were immediately available to support the Homeless Outreach and Navigation for Unsheltered (HONU) program and other efforts to mitigate conditions in congregate shelters.

Regarding the SD2 amendment requiring Kauhale to be hooked to public utilities (page 3, lines 10-13), DHS requests clarification and consideration that this requirement be made a preference when the utilities are currently available in the location.

DHS also requests clarification regarding the inclusion of a repeal date of the Ohana Zone program. As noted above, the Ohana Zone Pilot Program has been successful in large part due to its flexibility to incorporate different innovations and housing solutions, including more permanent housing such as Kauhale or as a contribution to county-based housing projects. Having a permanent program may promote more investment in housing innovation and planning.

DHS notes HB 431 HD2 Relating to Housing takes a different approach to state-funded

housing and homeless solutions. HB 431 HD2 appropriates funds to the Office of the Governor for the Kauhale initiative and authorizes that funds appropriated for the Kauhale initiative may be used for the Ohana Zones Pilot Program projects. HB 431 HD2 also establishes the permanent supportive housing special fund to be administered by the Hawaii Housing Finance & Development Corporation. The special fund aims to finance housing development and supportive services for individuals and families with special needs.

Aloha Chair Marten, Vice Chair Olds, and Members of the House Committee on Human Services and Homelessness:

The Statewide Office on Homelessness and Housing Solutions (SOHHS) thanks the committee for providing the opportunity to comment on S.B. 1610, SD2, Relating to Ohana Zones. Our office appreciates the intent of the bill and respectfully requests that appropriations for Ohana Zone funding be included in the executive budget for the administration's Kauhale initiative as identified in the executive budget.

In light of the current federal funding reductions and future uncertainty, the funding for the administration's Kauhale Initiative allows our state to respond quickly to the much-needed shelter, housing and supportive services to our most vulnerable members in our community. We appreciate the width and breadth of the Ohana Zone program. We recognize the wisdom of the legislature in allowing the administration to test innovative solutions that were not supported by federal funds.

SOHHS prioritizes electrical, sewer and water connections in all development projects. Unfortunately, the electrical utility has not prioritized timely electrical connection with the urgency needed for these crucial projects. Temporary and long-term projects must have the ability to leverage off-grid and temporary technologies. For this reason, the language within the bill that requires that kauhale shall have connections to public utilities such as water, sewer, and electricity, is overly restrictive and will drastically impact SOHHS's executive ability on important homelessness solution projects. We respectfully request the consideration that the language be amended.

SOHHS appreciates your consideration of our request to further our efforts to reduce and prevent homelessness across the state. Thank you for the opportunity to provide comments on this measure.

SUBJECT: GENERAL EXCISE; Ohana Zones Program, General Excise Tax Exemption

BILL NUMBER: SB 1610 SD 2

INTRODUCED BY: Senate Committee on Ways and Means

EXECUTIVE SUMMARY: Establishes the Ohana Zones Program as a program within the Statewide Office on Homelessness and Housing Solutions. Authorizes the Hawai'i Housing Finance and Development Corporation to exempt ohana zones projects from general excise taxes.

SYNOPSIS: Adds a new section to Chapter 346 to establish the Ohana Zones Program to provide temporary housing and services to homeless individuals and families.

Amends section 346-361, HRS, to add definitions of "kauhale" and "ohana zone":

"Kauhale" means:

(1) A program to address the basic needs of individuals experiencing houselessness; and

(2) Affordable housing spaces that are communal living spaces with individual household units and charge monthly rents no more than thirty per cent of the area median income level.

"Ohana zone" means a place:

(1) That has a program to address basic needs of individuals experiencing homelessness; and

(2) Where wrap-around services, social and health care services, transportation, and other services may be offered with the goals of alleviating poverty and transitioning individuals experiencing homelessness into affordable housing.

"Ohana zone" includes a kauhale.

Amends section 201H-36(a) and (b), HRS, to provide the Hawaii Housing Finance and Development Corporation, HHFDC, the ability to approve and certify exemption from general excise tax, in accordance with section 237-29, HRS, any qualified person or firm involved with a newly constructed or moderately or substantially rehabilitated project developed under the Ohana Zones Program.

EFFECTIVE DATE: December 31, 2050; and shall be repealed on June 30, 2026; provided that section 201H-36 (a) and (b), HRS, shall be reenacted in the form it read on the day prior to the effective date of this Act.

STAFF COMMENTS: Currently, HRS section 237-29 provides a general excise tax exemption for the gross income received by qualified persons for planning, design, financing, construction,

sale or lease of a housing project that has been certified or approved by the HHFDC under HRS section 201H-36.

The measure amends Section 201H-36, HRS, to allow HHFDC the ability to approve and certify general excise tax exemptions for projects developed under the newly established Ohana Zones Program. The proposed amendment appears reasonable and consistent with current law for comparable programs administered by HHFDC.
