In consideration of SENATE BILL 1639 RELATING TO HAWAII BEACH DAY

Senate Bill 1639 proposes to designate August 30 each year as "Hawai'i Beach Day," in order to promote awareness about the ecological, cultural, and recreational significance of Hawaii's beaches. The Department of Land and Natural Resources (Department) offers the following comments on the bill.

The bill requires that the Hawaii Tourism Authority (HTA), in collaboration with the Department of Land and Natural Resources (DLNR), organize and support events such as:

- Statewide beach cleanups and restoration projects,
- Educational campaigns on marine conservation and beach stewardship,
- Cultural demonstrations and workshops reflecting Native Hawaiian traditions, and
- Public art and educational exhibits emphasizing the beauty and importance of beaches.

Organizing a statewide festival of this size would require substantial funding and a significant amount of staff time. While Senate Bill 1639 proposes allocating funds from the General Fund, it does not specify an amount.

The Department has no prior experience managing events of this scale and cannot accurately estimate the funds needed to make Hawai'i Beach Day a success. DLNR respectfully requests a commitment to ongoing funding and a clearer definition of the roles and responsibilities of both HTA and DLNR in order to support this bill.

I agree with the intent of this bill but the focus on Hawaii's beaches takes away from its intent of raising awareness about environmental stewardship and the highlight of ecological and cultural significance of Hawaii's environment. We should be promoting a regenerative form of tourism, beneficial to our entire ecosystem, and this bill goes against that.
