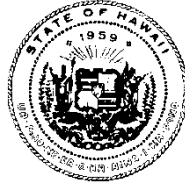

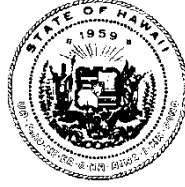

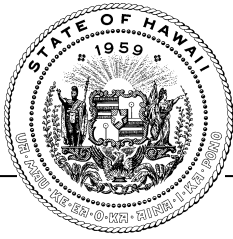

Chair Evslin, Vice Chair Miyake, and members of the Committee.

HHFDC **supports** SB 26 SD2, which establishes the Affordable Housing Land Inventory Task Force within the Hawaii Community Development Authority to update the Affordable Rental Housing Report and Ten-Year Plan maps, tier tables, and inventories of State lands suitable and available for affordable housing development. It also requires a study and report to the Legislature; and appropriates funds. HHFDC supports the measure so long as it does not adversely impact priorities identified in the Executive Budget Request for FY 2026.

HHFDC is named as a member of the task force and agrees that the updates resulting from this bill will be a helpful tool for the development of new affordable housing. We note, however, that it will be challenging to procure a consultant and prepare the report 20 days prior to the convening of the 2026 regular session as required by the bill. We therefore request that the bill be **amended** to require a status report prior to the convening of the 2026 regular session with the complete report due 20 days prior to the convening of the 2027 regular session.

Chair Evslin, Vice Chair Miyake, and Members of the Committee.

The Office of Planning and Sustainable Development (OPSD) supports the bill's intent and **offers comments** on SB 26, SD2, which establishes the Affordable Housing Land Inventory Task Force to update the maps, tier tables, and inventory of State lands suitable and available for affordable housing development in the Affordable Rental Housing Report and Ten-Year Plan, and requires a report to the Legislature. SB26, SD2 would appropriate funds for consulting services and for a staff planner to undertake the work required under the measure.

This effort would build on OPSD's prior work in 2016-2017 with the Special Action Team on Affordable Rental Housing, which reported to the Legislature in 2018. OPSD notes that the SD2 contains language for expanded site feasibility work similar to that proposed in a key recommendation in OPSD's [\*Toward a TOD Housing Investment Strategy, Report to the 2024 State Legislature\*](#) to assess public lands in transit-oriented development areas statewide for their suitability for housing.

Discussions with the Hawai'i Community Development Authority (HCDA) have occurred about the best agency, between HCDA and OPSD, to implement this bill. OPSD is preferred to undertake the tasks contemplated by this bill, provided that sufficient funds are appropriated for consulting services and staff support, and funding does not negatively impact any administration priorities.

**OPSD is concerned that procurement of consultant services, hiring of staff, organization of the task force, and completion of the work set forth in the bill can't realistically be done by the bill's January 2026 report deadline.**

Therefore, OPSD recommends that as the bill moves forward, the timeframe for submittal of the Task Force's final report be extended by up to 24 months to provide sufficient time for the work to be completed as envisioned.

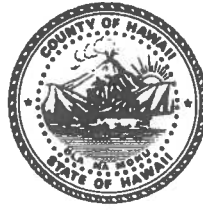
The LUC has taken a position to support measures to facilitate affordable workforce housing and will participate as a member of the Task Force.

Chair Evslin, Vice Chairperson Miyake, and members of the Committee.

The Hawai'i Community Development Authority (HCDA) respectfully offers **comments** on SB26 SD2, for the committee's consideration. This measure establishes the Affordable Housing Land Inventory Task Force within the HCDA to update the Affordable Rental Housing Report and Ten-Year Plan maps, tier tables, and inventories of state lands suitable and available for affordable housing development, conduct a study, and make certain recommendations.

The intent and purpose of the bill is acknowledged, as the work of updating of the tier tables will build on prior efforts by the Office of Planning and Sustainable Development (OPSD) and yield information that could be useful in developing affordable housing statewide.

However, the tasks contemplated by this bill are labor intensive and require analysis for the tier table data to be useful. For context, in considering SCR 55/SR 44 (2024 session), which contained similar tasks to update tier tables, HCDA expressed concerns about being able to fulfill the tasks contained in those resolutions, especially with no funding. Likewise, HCDA expresses the same concerns about the HCDA being

able to complete the tasks, in the time given<sup>1</sup>, even with funding, considering the other work that HCDA is tasked with or could be tasked with.

Discussions with OPSD have occurred about the best agency, among HCDA and OPSD, to implement this bill. OPSD is ready to undertake the tasks contemplated by this bill, provided that sufficient funds are appropriated for consulting services and staff support and funding does not adversely impact any Administration priorities.

Thus, we respectfully recommend that SB26 SD2 be further revised to designate that the “affordable housing land inventory task force” (Task Force) be placed within OPSD for administrative purposes and corresponding conforming changes be made throughout the bill. Of course, HCDA is willing to participate in and be a member of the Task Force.

Thank you for the opportunity to provide our comments on this bill.

<sup>1</sup> The task force is proposed to be dissolved on January 1, 2026 suggesting that the work of the task force must be completed by the end of calendar year 2025 and a report submitted to the Legislature soon thereafter. Assuming that funds to implement this bill are included in the State Budget, taking into consideration the time needed to release the funds, completing a report prior to the start of the 2026 legislative session may be unrealistic.
