Dear Chair San Buenaventura and Vice-Chair Aquino and Members of the Health and Human Services Committee:

Members of AAUW of Hawai'i thank you for this opportunity to testify in strong support of S.B. 297, proposing an amendment to the Hawai'i State Constitution to prohibit the State from denying or interfering with an individual's reproductive freedom, including the right to choose to obtain an abortion and to obtain or use contraceptives.

The *Dobbs v. Jackson Women's Health Organization*, 597 U.S. 215 (2022), provides that a state may regulate or prohibit abortion.

The right to contraception is protected by *Griswold v. Connecticut*, 381 U.S. 479 (1965), and *Eisenstadt v. Baird*, 405 U.S. 438 (1972). In *Griswold*, the U.S. Supreme Court recognized that the constitutional right to privacy includes the right of married people to obtain contraceptives, and in *Eisenstadt*, the U.S. Supreme Court extended the constitutional protections in *Griswold* to unmarried persons. However, after the *Dobbs* decision, the right to contraception is in jeopardy.¹

According to the American College of Obstetricians and Gynecologists, "abortion is an essential component of women's health care. Like all medical matters, decisions regarding abortion should be made by patients in consultation with their health care providers and without undue interference by outside parties. Like all patients, women obtaining abortion are entitled to privacy, dignity, respect, and support."²

Similar to abortion, access to contraceptives and the right to engage in contraception is health care for many people. "The American College of Obstetricians and Gynecologists (the College) supports access to comprehensive contraceptive care and contraceptive methods as an integral component of women's health care and is committed to encouraging and upholding policies and actions that ensure the availability of affordable and accessible contraceptive care and contraceptive methods."³

RE: Opposition to SB297 Proposing a Constitutional Amendment to The Constitution of the State of Hawaii to Protect the Right to Reproductive Freedom.

Hawai'i Family Forum is a non-profit, pro-family education organization committed to preserving and strengthening families in Hawai'i. We strongly oppose SB297 due to its broad terminology and farreaching consequences—particularly for our keiki and the wider community. Moreover, amending our state constitution is unnecessary, as we believe that these rights are already fully protected under existing law.

Overly Broad and Problematic Terminology

SB297 uses vague language that opens the door for extreme interpretations. The term "individual" rather than "woman" or "adult" could be used to eliminate parental notification laws, allowing minors younger than 14 years old to make serious reproductive decisions—including abortion— without parental knowledge or consent.

Additionally, the phrase "reproductive freedom" is undefined and subject to judicial interpretation. This lack of clarity could lead to unintended legal and ethical consequences.

By enshrining an unlimited "right" to "reproductive freedom" in the state constitution, SB297 could end up thwarting basic, common-sense protections for women, girls, and preborn children. This bill is not about securing existing rights—it's about preventing future debate and legislation that supports a culture of life.

Hawai'i Law Already Protects Abortion Rights

The bill text implies that Hawai'i restricts access to abortion and contraception. Women in Hawai'i already have unfettered access to abortion, contraception, and pregnancy-related medical care. Planned Parenthood Action itself confirms on its Hawai'i website, "Abortion is legal in this state. Very few to no restrictions exist, and abortion is accessible."

Hawai'i law.ⁱⁱ explicitly protects the right to abortion for a "non-viable fetus" and allows abortion to "protect the woman's life or health." The Hawai'i State Constitution further upholds privacy rights, ensuring no infringement without a compelling state interestⁱⁱⁱ Simply put, we believe that SB297 is unnecessary because of our constitution's existing right to privacy.



Opposition to SB297 Page Two

Under current law, women in Hawai'i can:

- Obtain contraception without restriction.
- Seek an elective abortion with virtually no limits in the first trimester.
- Access second-trimester abortions with standard legal provisions related to "viability." iv.
- Receive medically necessary interventions throughout pregnancy.

Conclusion

SB297 is unnecessary, vague, and detrimental to the future of pro-life and pro-family policies in Hawai'i. Instead of promoting the well-being of women and children, it opens the door for vague abortion policies while silencing future legislative efforts to provide safeguards for life and family.

SENATE BILL 297, RELATING TO PROPOSING A CONSTITUTIONAL AMENDMENT TO THE CONSTITUTION OF THE STATE OF HAWAII TO PROTECT THE RIGHT TO REPRODUCTIVE FREEDOM

FEBRUARY 5, 2025 · HHS HEARING

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus <u>supports</u> SB 297, which amends the Hawai'i State Constitution to prohibit the State from denying or interfering with an individual's reproductive freedom, including the right to choose to obtain an abortion and to obtain or use contraceptives.

Reproductive care is an essential form of healthcare. In March of 1970, Hawai'i became the first state to legalize abortion, three years before the landmark *Roe v. Wade* decision by the United States Supreme Court protected access to abortion nationwide. In so doing, the state recognized that preserving access to safe and legal reproductive care is a vital public health objective for the islands. Yet, Hawai'i's unique geography and high cost of living present barriers to obtaining reproductive care for potential patients. As of 2022, only three abortion providers exist in the islands and only Oahu and Maui host reproductive care clinics. According to Planned Parenthood, the number of abortion providers in the state has been on the decline since the 1990s.

Moreover, studies show that access to abortion care is linked to financial well-being. According to The Turnaway Study conducted by Advancing New Standards in Reproductive Health at the University of California San Francisco, people who were denied access to an abortion experienced an increase in household poverty lasting at least four years relative to those who received an abortion. Women who lacked access to reproductive care were also found to be less able to pay for basic living expenses, had lower credit scores, and had higher rates of debt and eviction than those with access to abortion care.

The U.S. Supreme Court's disastrous ruling in *Dobbs v. Jackson Women's Health Organization* overturned *Roe v. Wade* and ended the federal constitutional right to abortion care. In overturning *Roe v. Wade*, the U.S. Supreme Court erased nearly fifty years of legal precedent supporting the fundamental right to reproductive freedom, leading to a wave of abortion restrictions enacted by state legislatures across the country. The Court's decision disproportionately harms black, latino, indigenous, and other people of color, for whom access to healthcare and economic opportunities has historically been impeded by systemic racism.

In response to the Supreme Court's catastrophic ruling in *Dobbs v. Jackson Women's Health Organization* and further attacks on abortion care that are expected to be made by the Trump administration, state policymakers must take action to uphold Hawai'i's legacy as a leader in advancing reproductive care and support measures to strengthen reproductive rights in the islands. Accordingly, we support empowering the people of our state to defend reproductive care for generations to come.

Testimony in Strong Support of SB297

Chair Buenaventura, Vice Chair Aquino and members of the committee

UNITE HERE Local 5 represents over 10,000 working people in the hotel, foodservice and healthcare industries across Hawaii. We have always fought to improve the economic lives of our members, their families and their community.

We are in strong support of SB297. Reproductive rights are healthcare rights. A person's healthcare choice is for them and their doctor to decide. Women and men should have the freedom to plan their lives. A government that denies it citizens the right to determine the quality of their personal lives is taking away freedom from its citizens. We are a state that values personal freedoms. A constitutional ballot question to protect abortion and reproductive rights will reflect the will of its citizens.

As a labor union with a long history of worker advocacy we want to emphasize the economic freedom that reproductive choice provides to people; reproductive rights are closely correlated to economic prosperity, and economic prosperity is economic freedom. Secretary of the Treasury Janet Yellen said, *"eliminating the right of women to make decisions about when and whether to have children would have very damaging effects on the economy and would set women back decades."*

The Economic Policy Institute (EPI) found in a 2023 study that states with abortion restrictions or total bans have on average:ⁱ

- lower minimum wages (\$8.17 compared with \$11.92 in the abortion-protected states)
- unionization levels half as high as those in the abortion-protected states
- only three in 10 unemployed people receiving unemployment insurance (compared with 42% in other states)
- lower rates of Medicaid expansion
- an incarceration rate 1.5 times that of the abortion-protected states

The EPI points out that,

"A wide breadth of social science literature demonstrates the range of negative economic consequences of abortion denial, from prolonged financial distress to being trapped in lower paying occupations (ANSIRH 2022; Foster et al. 2018; Miller, Wherry, and Foster 2022; Bahn et al. 2019).5 While the effect of abortion denial is overwhelmingly negative economically, mentally, and physically, there is also strong evidence for the flip side of this argument: that access to abortion is associated with positive economic outcomes, including lower rates of teen births and teen marriages (Myers 2017)."

Furthermore, when citizens across the country voted on state ballot measures to strengthen abortion rights, it became clear that a vast majority American citizens wanted to protect their right for self-determination. Seven out of ten states voted to strengthen abortion rights when given the chanceⁱⁱ.

We urge you to pass SB297 and give Hawaii residents the chance to decide on this important basic human right by putting the question on the ballot. It is both a human right and economic freedom question.

Introduction

The pro-life movement has accomplished many victories in the wake of the Supreme Court's decision in *Dobbs v. Jackson Women's Health Organization*,⁶ while also facing new challenges. Now that the Supreme Court has overturned *Roe v. Wade⁷* and returned the abortion issue to the democratic process, abortion activists have sought to enshrine a "right" to elective abortion in state constitutions across the country. These efforts pose a serious threat to pro-life laws and the protection of preborn human beings, women, and adolescent girls.

Recently, several states amended their state constitutions to enshrine a "right" to elective abortion. This includes Arizona, Colorado, Ohio, Maryland, Michigan, Missouri, Montana, Nevada, and New York. These amendments emboldened abortion activists to challenge life-affirming laws. For example, in the year following Michigan's pro-abortion amendment, the legislature successfully repealed numerous commonsense protections for women and preborn children, including the state's ban on partial-birth abortions and provisions requiring abortion facilities to be licensed and operated under necessary health and safety standards. However, a number of states—Florida, Nebraska, and South Dakota—recognized the harms of enshrining abortion-on-demand in their state constitutions and rejected these radical pro-abortion amendments. Hawaii now has the opportunity to become the fourth state to stand firm against an amendment that threatens the welfare of its citizens.

This legislative session, the people of Hawaii face Senate Bill 297 (SB 297). If the legislature passes the bill and voters subsequently approve it on the ballot, it will amend the Hawaii constitution to state:

The State shall not deny or interfere with an individual's reproductive freedom in their most intimate decisions, including: (1) The right to choose to obtain an abortion of a nonviable fetus; (2) An abortion that is necessary to protect the life or health of the parent; and (3) The right to choose to obtain or use contraceptives.⁸

But SB 297's language is deceptive. First, the misleading phrasing of this amendment makes it appear as though Hawaii currently restricts or is attempting to restrict individuals from making decisions about contraception. This is not true, as the people of Hawaii can freely obtain contraception. Second, current law already permits elective abortions up through viability without restriction as well as authorizes interventions to save the life of the mother or protect the "health of the pregnant person," through all nine months of pregnancy.⁹

In other words, Hawaii residents do not need SB 297. The people of Hawaii, under existing statutes, can lawfully:

- obtain contraception;
- obtain an elective abortion with virtually no restrictions up until viability;
- obtain an elective abortion if the abortionist deems it "necessary to protect the . . . health of the pregnant person" throughout the entire pregnancy; and
- obtain medically necessary interventions to save the life of the mother throughout the entire pregnancy.

No Hawaii law prevents women from receiving any form of lifesaving or medically necessary treatment or intervention during their pregnancy. Nor does any Hawaii law prevent women from receiving any treatment or intervention where the unborn child has not or will not survive the pregnancy, such as in the case of miscarriages or ectopic pregnancies. Yet, the misleading language of the amendment attempts to disguise unregulated access to elective abortion through all nine months of pregnancy as healthcare and makes it nearly impossible for Hawaii to enact any common-sense safeguards to protect women and their unborn children.

Elective abortion is not healthcare. It is the intentional destruction of innocent preborn human life. As the Supreme Court acknowledges in *Dobbs*, states have a legitimate interest in preserving prenatal life, mitigating fetal pain, and protecting maternal health.¹⁰ Thus, Hawaii can regulate abortion in furtherance of these important interests.

But if Hawaii passes SB 297, the fallout will be devastating, especially for the welfare of the women of Hawaii and their preborn children. SB 297 will increase the number of unsafe, elective late-term abortions, threatens to eliminate common-sense and necessary protections for women's welfare and parental involvement laws, will give unlicensed and unsafe abortionists free rein to operate clinics without rational health and safety regulations, will increase intimate partner violence by concealing coerced abortions in Hawaii, and furthers the harmful and false narrative that unregulated, elective abortion is necessary for women to have equality and success in America.

Ultimately, if the legislature passes SB 297, Hawaii will be one step closer to enshrining a constitutional right to elective abortion through all nine months of pregnancy, stripping the voice of the people of Hawaii in protecting women, adolescent girls, and preborn children from the violence of elective abortion.

I. The Hawaii SB 297 Amendment Will Increase the Number of Harmful Late-Term Abortions in the State.

Passage of SB 297 will effectuate abortion-on-demand up until a preborn baby's birth date. Although the proposed amendment includes language that seemingly allows

Hawaii to prohibit abortion after a child can survive outside the womb, it allows for a broad "health" exception. The proposed amendment states that Hawaii may not regulate "[a]n abortion that is necessary to protect the life or health of the parent."¹¹ Courts, including the U.S. Supreme Court, have broadly interpreted this health exception. In *Doe v. Bolton*¹², which was the companion case to *Roe*, the Supreme Court defined "health" in abortion laws as "*all factors—physical, emotional, psychological, familial, and the woman's age—relevant to the well-being of the patient. All these factors may relate to health.*"¹³ Since then, "whenever and wherever used in abortion law, 'health' means 'emotional well-being,' and it's a trap door for any state regulation. A state regulation cannot be applied if 'emotional well-being of the patient—including any minor—might be affected by the regulation."¹⁴

Under the amendment's broad health exception, if a pregnancy is affecting a woman's "emotional well-being" for whatever reason, she can have an abortion up to the date of her unborn child's birth. By including this health exception, Hawaii will be authorizing abortion-on-demand throughout all nine months of pregnancy. The abortionist simply has to find the abortion "necessary"—a word left undefined—to protect the parent's "health." This could be any foreseeable social reason such as the woman's age, the ending of the relationship between the mother and the father of the baby, financial concerns, etc.

Although it is a common misconception that abortions performed under a health exception, or late-term abortions, are only performed in rare circumstances for medically necessary reasons, as the American Association of Pro-Life Obstetricians and Gynecologists ("AAPLOG") states, "most abortions are done for social reasons."¹⁵ "Overall, common exceptions to abortion restrictions are estimated to account for less than five percent of all abortions meaning that 95 percent of abortions are for elective or unspecified reasons."¹⁶ Dr. James Studnicki published a similar outcome in *Health Services Research and Managerial Epidemiology* regarding late-term abortions. As he says, "[t]he Guttmacher Institute has provided a number of reports over 2 decades which have identified the reasons why women choose abortion, and they have consistently reported that childbearing would interfere with their education, work, and ability to

care for existing dependents; would be a financial burden; and would disrupt partner relationships."¹⁷ Accordingly, most abortions occur for elective reasons of the mother, not because of the either the baby's or the mother's medical condition.

By affording unnecessary constitutional protection to elective abortion at all stages of pregnancy, SB 297 will further the state's reputation as an abortion destination, leading to more harmful late-term abortions. In turn, more women and preborn children will be subject to abortion violence.

Additionally, it is a common misconception that late-term abortions are only performed in rare circumstances for medically necessary reasons. It is estimated around 10,000 abortions are performed at 21 weeks' gestation or later each year.¹⁸ However, the total number of late-term abortions is likely higher given that the Centers for Disease Control and Prevention's ("CDC") data is limited by *voluntary* state reporting and abortion destination states, such as California and Hawaii, refuse to provide any data on abortions to the CDC.¹⁹

SB 297 is a thinly veiled attempt to mandate unsafe, elective late-term abortions with virtually no common-sense safeguards for women and adolescent girls into the foundation of Hawaii law. SB 297 will also impede the state's ability to pass laws that decrease the number of unsafe, elective late-term abortions and clear the way for abortion activists to ask courts or the legislature to eliminate protections for women's health and safety, such as limitations on abortion after viability, and conscience protections for hospitals and healthcare providers who object to providing abortions. As a result, with little to no protections in place for women seeking abortions, the number of late-term abortions in the Hawaii will increase.

This will put more women at risk of suffering severe and life-threatening complications from elective abortions, as well as subjecting preborn children with developed nerve endings to painful abortion procedures. As the American Association of Pro-Life Obstetricians and Gynecologists ("AAPLOG") explains, data on abortions shows, "most abortions are done for social reasons."²⁰ "Overall, common exceptions to abortion restrictions are estimated to account for less than five percent of all abortions meaning that 95 percent of abortions are for elective or unspecified reasons."²¹

This data indicates that 95 percent of abortions are elective and *do not* constitute grounds for already-existing statutorily prescribed interventions to save a woman's life or prevent substantial impairment of her health. Dr. James Studnicki published a similar outcome in *Health Services Research and Managerial Epidemiology* regarding late-term abortions. He states,

[t]he Guttmacher Institute has provided a number of reports over 2 decades which have identified the reasons why women choose abortion, and they have consistently reported that childbearing would interfere with their education, work, and ability to care for existing dependents; would be a financial burden; and would disrupt partner relationships.²²

Accordingly, most abortions occur for elective reasons of the mother, and do not qualify as medically-necessary interventions because of either the baby's or the mother's medical condition.

Fundamentally, SB 297 is not in the best interest of women's health and safety, and will effectively deepen the abortion industry's pockets while subjecting women to dangerous elective late-term abortions that ultimately threaten women's physical and emotional well-being.

a. Late-Term Abortions Carry a Higher Risk of Health Complications.

By enshrining constitutional protection for elective late-term abortions in the state, Hawaii will put more women at risk of suffering severe and life-threatening complications. Abortions carry a higher medical risk when done later in pregnancy. Even Planned Parenthood, the largest abortion business in the United States, agrees, stating: "[t]he chances of problems gets higher the later you get the abortion".²³

Gestational age is the strongest risk factor for abortion-related mortality, and the incidence of major complications is significantly higher after 20 weeks' gestation.²⁴ For example, compared to an abortion at 8 weeks' gestation, the relative risk of mortality to the woman increases exponentially by an additional 38 percent each week of gestation.²⁵

Further, researchers have concluded that it may not be possible to reduce the risk of death in later-term abortions because of the "inherently greater technical complexity of later abortions."²⁶ This is because later-term abortions need to dilate the

cervix to a greater degree, and the increased blood flow predisposes women to hemorrhage, and the myometrium relaxes and is more subject to perforation.²⁷

Late-term abortions also pose an increased risk to women's physical and mental health. Some immediate complications from abortion include:

- blood clots,
- hemorrhaging,
- incomplete abortions (part of the preborn child is not removed),
- infection, and
- injury to the cervix and other organs.²⁸

Immediate complications affect approximately 10% of women undergoing abortion, and approximately one in five of these complications are life-threatening to the woman.²⁹

If Hawaii memorializes SB 297 into its constitution and supports unregulated, abortion-on-demand, more women will experience life-threatening complications from late-term abortions.

b. <u>SB 297 Furthers the Psychological Harm of Abortion on Women.</u>

Amending Hawaii's constitution to enshrine a "right" to elective abortion through all nine months of pregnancy will result in more women suffering post-abortive psychological harms. "[P]regnancy loss (natural or induced) is associated with an increased risk of mental health problems."³⁰ "Research on mental health subsequent to early pregnancy loss as a result of elective induced abortions has historically been polarized, but recent research indicates an increased correlation to the genesis or exacerbation of substance abuse and affective disorders including suicidal ideation."³¹

Scholarship shows "that the emotional reaction or grief experience related to miscarriage and abortion can be prolonged, afflict mental health, and/or impact intimate or parental relationships."³² In fact, a recent 2023 study found that American "women whose first pregnancy ends in induced abortion are significantly more likely than women whose first pregnancy ends in a live birth to experience mental health problems throughout their reproductive years."³³

Similarly, "[s]everal recent international studies have demonstrated that repetitive early pregnancy loss, including both miscarriage and induced abortions, is associated

with increased levels of distress, depression, anxiety, and reduced quality of life scores in social and mental health categories."³⁴

SB 297 authorizes dangerous elective abortion procedures on women and adolescent girls that will negatively impact their mental and emotional well-being. By constitutionally protecting abortion-on-demand, the rates of mental health issues—such as depression, anxiety, and suicidal ideation—will increase and diminish their overall quality of life.

c. <u>SB 297 Subjects Preborn Children to Painful Abortion Procedures.</u>

In addition to harming women's physical and mental health, abortion also subjects preborn children to fetal pain. There is ample research on fetal pain in the 50 years after *Roe*. For example, in 2019, scientists found evidence of fetal pain as early as 12 weeks' gestation.³⁵ "Pain receptors [] begin forming at seven weeks' gestational age, with the nerves linking pain receptors to the pain-sensing part of the brain, the thalamus, forming at 12 weeks."³⁶ By twelve weeks' gestation almost every organ and tissue has formed in a preborn baby³⁷ and the baby has arms, legs, fingers, toes, a face, and eyelids.³⁸ The preborn baby is also beginning to form unique fingerprints,³⁹ is able to suck his or her thumb,⁴⁰ and has a fully developed heart.⁴¹

Additionally, a 2010 study found that "the earlier infants are delivered, the stronger their response to pain"⁴² because the "neural mechanisms that inhibit pain sensations do not begin to develop until 34–36 weeks[] and are not complete until a significant time after birth."⁴³ As a result, preborn children display a "hyperresponsiveness" to pain.⁴⁴ According to one group of fetal surgery experts, "[t]he

administration of anesthesia directly to the fetus is critical in open fetal surgery procedures."⁴⁵

Given the medical advancements in fetal medicine and the scientific evidence of fetal pain early in pregnancy, it is well within the state's legitimate interests to enact laws that preserve prenatal life and minimize fetal pain as much as possible.⁴⁶ If SB 297 is passed, Hawaii will not be able to enact or maintain any gestational limit on elective abortion whatsoever. Abortion activists will argue that such laws interfere with women's "right" to abortion under the state constitution, even though the laws further the state's legitimate interest to preserve prenatal life and mitigate fetal pain.

II. SB 297 Leads to the Elimination of Common-Sense Protections for Women, Adolescent Girls, and Preborn Children, and Impedes the State's Ability to Enact Future Safeguards.

Hawaii has little to no life-affirming safeguards for pregnant women, adolescent girls, and their preborn children. However, the passage of SB 297 places the few prolife protections the state has at risk of being struck down by a court, as shown by current activist litigation against pro-life laws across the states, or being removed by the legislature, as shown by Michigan's legislature after a similar constitutional amendment enshrined a "right" to elective abortion.

The Supreme Court in *Dobbs* acknowledges that states have legitimate governmental interests in protecting both the mother and the child when regulating elective abortion. Accordingly, it is good for a state to protect maternal health and safety, to preserve prenatal life, to mitigate fetal pain, to prohibit barbaric medical procedures, to preserve the integrity of the medical profession, and prevent discrimination on the basis of race, sex, or disability.⁴⁷

SB 297 flies in the face of these important governmental interests. By broadly prohibiting the state from "deny[ing] or interfer[ing]" with an unfettered "right to reproductive freedom," SB 297 will make it difficult for Hawaii to pass any protections for women and preborn children even though these laws further the state's legitimate interests to do so. Furthermore, the bill threatens the existence of Hawaii's current life-affirming laws, including the state's prohibition on abortions after viability and its conscience protections for health care professionals and hospitals that object to abortion based on their beliefs and convictions.

These laws, although few, serve to protect women and preborn children from the inherent harms of elective abortion, as well as protect the conscience rights of hospitals and healthcare providers.⁴⁸ However, these laws are subject to being struck down or repealed if SB 297 passes. Abortion activists may argue these commonsense safeguards

"interfere" with a woman's "right to reproductive freedom" pursuant to the constitutional amendment, leading to legislative repeal or judicial injunction.

Michigan residents faced a similar challenge. Only one year after the residents voted to amend their constitution to enshrine a right to elective abortion through all nine months of pregnancy, the legislature repealed several common-sense pro-life policies in the state that were designed to protect women and their unborn children. These include licensing requirements for abortion clinics, abortion reporting requirements, prohibitions on gruesome partial-birth abortions, informed consent for chemical abortions, and legislative enactments favoring childbirth over elective abortion.⁴⁹

The language in Michigan's abortion amendment is similar to the language in SB 297. Michigan's abortion amendment established an "individual right to reproductive freedom," and now prohibits the state from regulating any abortion unless "justified by a compelling state interest achieved by the least restrictive means."⁵⁰ Given the similar nature between Michigan's newly amended constitution and Hawaii's SB 297, the ramifications may be just as devastating or more than those seen in Michigan, leaving mothers and their unborn children without protections.

Ultimately, SB 297 will make it practically impossible to enact any pro-life laws in the future. SB 297 will instill these dangerous practices in Hawaii's constitution, making a pro-family, pro-life culture that promotes the health, safety, and dignity of women, children, and families even more difficult to foster.

III. SB 297 Does Not Prevent Abusers from Coercing Victims into Having Abortions Against their Will.

Sadly, many women and girls are coerced into abortions as a result of abuse or trafficking. For example, a woman "seeking" an abortion may actually be a victim of intimate partner violence (IPV). There are "[h]igh rates of physical, sexual, and emotional IPV . . . among women seeking a[n abortion]."⁵¹ For women seeking abortion, the prevalence of IPV is nearly three times greater than women continuing a pregnancy.⁵² Post-abortive IPV victims also have a "significant association" with "psychosocial problems including depression, suicidal ideation, stress, and disturbing thoughts."⁵³

Similarly, perpetrators of intimate partner violence and abuse, such as partners, family members, and sex traffickers, often assert reproductive control over women,

which are "actions that interfere with a woman's reproductive intentions."⁵⁴ In the context of abortion, reproductive control not only involves coerced abortions, it also implicates pregnancy that results from sexual assault.⁵⁵ Being controlled through coerced abortion is a prevalent issue for women who suffer from intimate partner violence or are victims of human trafficking. "As many as one-quarter of women of reproductive age attending for sexual and reproductive health services give a history of ever having suffered [reproductive control]."⁵⁶

There are several studies that highlight the prevalence of coerced abortions. A recent peer-reviewed study showed that 24% of post-abortive women indicated their abortion was "unwanted or coerced."⁵⁷ 43% of post-abortive women described their abortion as "accepted but inconsistent with their values and preferences."⁵⁸

Another study found that 61% of women reported experiencing "high levels of pressure" to abort their preborn child by "male partners, family members, [and] other persons."⁵⁹ This study found:

These pressures [to abort] . . . are strongly associated with more negative emotions about [a woman's] abortion; more disruptions of their daily life, work, or relationships; more frequent . . . intrusive thoughts about their abortions; more frequent feelings of loss, grief, or sadness about their abortion; . . . [and] a perceived decline in their overall mental health that they attribute to their abortions⁶⁰

Furthermore, victims of sex-trafficking are among women who experience reproductive control by their abusers. A 2014 study on the health consequences for sex-trafficking victims found that 66 sex-trafficking victims had a total of 114 abortions, "[w]ithout accounting for possible underreporting."⁶¹ "The [sex-trafficking] survivors in this study [] reported that they often did not freely choose the abortions they had while being trafficked."⁶² A majority of the 66 sex-trafficking victims "indicated that one or more of their abortions was at least partly forced upon them."⁶³

Given the prevalence of coerced abortions among sex-trafficking victims, the authors of the study note that "[h]ealthcare providers can play a crucial role in the trafficking rescue process by identifying possible victims and following up on those suspicions with careful, strategic questions, and actions that catalyze rescue or help create exit strategies."⁶⁴ The National Institute of Health has explained, "[h]ealth care providers are often the only professionals to interact with trafficking victims who are still in captivity."⁶⁵

And the Administration of Strategic Preparedness and Response has published resources addressing this issue, saying: "[s]tudies have shown that approximately 50% of trafficking victims saw a health professional in captivity. However, healthcare workers, particularly physicians, are rarely engaged or trained to recognize these patients, despite their potential opportunity to intervene."⁶⁶

In the 2014 study of sex-trafficking survivors, 29.6% had contact with a Planned Parenthood clinic, 63.3% were treated at an emergency room or hospital, and 57.1% were treated at a clinic (urgent care, women's health, neighborhood, or Planned Parenthood).⁶⁷ And in Hawaii particularly, the National Human Trafficking Hotline has identified 395 cases of human trafficking, with 898 victims since 2007.⁶⁸ In 2023, 29 cases of human trafficking were identified in Hawaii, with 49 victims identified.⁶⁹

Despite the prevalence of coercive abuse among women seeking abortions, SB 297 will interfere with Hawaii's ability to enact necessary safeguards for survivors of abuse and trafficking, as stated above. To illustrate, in 2023, Michigan's legislature sought to repeal a Michigan law that requires doctors to screen for coercion and provide victims of coercive abuse with helpful resources. Proponents of the repeal argued that the law creates barriers to women's access to abortion. But in reality, this type of law helps identify and rescue victims of intimate partner violence and sex trafficking.

Because abortion activists see *any law* that merely regulates elective abortions as a burden on women, even when the primary purpose is to promote and protect the health and safety of women, girls, and preborn children, Hawaii will experience an onslaught of legal and legislative challenges seeking to eliminate basic, commonsense safeguards. Preventing Hawaii from enacting protections to screen for and stop coerced

abortions effectively incentivizes abusers and traffickers to continue forcing women to obtain abortions. SB 297 will leave women unprotected, victimized, and silenced.

IV. SB 297 Furthers the False Narrative that Elective Abortion is Necessary for Women's Equality in American Society.

By purporting that there should be and is a "right" to all reproductive health issues on demand, including unfettered and unregulated access to unsafe, elective abortions through all nine months of pregnancy, SB 297 furthers the narrative that women "need" elective abortion in order to obtain success and equality in American society. This belief is unfounded and harms women instead of promoting their freedom and support.

First, as stated above, the language used in SB 297 is deceptive and does not describe the reality of what elective abortion is. Elective abortion is not healthcare. It is the intentional destruction of innocent preborn human life. According to the American Association of Pro-life Obstetricians and Gynecologists ("AAPLOG"), "elective abortion is defined as those drugs or procedures used with the primary intent to end the life of the human being in the womb."⁷⁰

Nor are elective abortions medically required, as AAPLOG explains: "[e]lective' . . . refers to inductions done in the absence of some condition of the mother or the fetus which requires separation of the two in order to protect the life of one or the other (or both)."⁷¹ Indeed, "there is no medical indication for elective induced abortion, since it cures no medical disease."⁷²

Despite this, abortion activists often imply that pregnancy itself is some sort of illness or disability, rather than a natural process that many women experience. But "[p]regnancy is not a disease, and the killing of human beings in utero is not medical care."⁷³ Further, "[t]o date, the medical literature offers no support for the claim that abortion improves mental health or offers protection to mental health. In fact, there is evidence to the contrary."⁷⁴

Despite the growing body of evidence on the physical and psychological harms of elective abortion, abortion activists continue to push false narratives about pregnancy and women's alleged "need" for elective abortion through all nine months of pregnancy.

However, the evidence abortion activists rely upon, which "claim[s] to show that abortion has facilitated women's health and equality is feeble and/or scientifically invalid."⁷⁵ Indeed, "the repetition and acceptance of the 'equality' argument for favoring legal abortion," harms women because it "easily communicates that women's pregnancy and parenting is a disability most females suffer. It explicitly or implicitly assumes that the male body and reproductive model is the norm, to which women should conform in order to achieve 'agreed' measures of success."⁷⁶

Pregnancy is neither an illness nor a disability. To imply that it is such results in discriminatory treatment towards women. "A system that undervalues both mothering and fathering severely disadvantages women as well as men and children, and interferes with children receiving the care they require."⁷⁷ This leads to both a "public and private resistance to accommodating motherhood in employment," which "leads to additional disadvantages for women."⁷⁸ "For example, discrimination on the basis of pregnancy and motherhood has succeeded outright discrimination on the basis of sex."⁷⁹

According to a 2022 study of 2200 adults, 20% of mothers reported that they experienced pregnancy discrimination in the workplace.⁸⁰ And this discrimination appears to be worsening. The study found that "13% of Millennial women have experienced pregnancy discrimination, compared to 9% of Gen X women and 5% of Baby Boomer women."⁸¹

Women deserve better than to have the abortion industry subject them to deceptive language surrounding elective abortion which is a life-altering—and at times, life-threatening—decision. By propagating elective abortion as a necessary means to achieve "success," women are effectively told that following the natural course of pregnancy is choosing societal and career failure. Abortion also tells society that it need not aim to foster support for women and families. Pro-family, pro-life policies will support women and children and ultimately help women flourish in their lives.

SB 297 is a poor attempt to perpetuate this myth and strip away all commonsense regulations on abortion. SB 297 seeks to effectively promulgate unregulated access to elective abortion through all nine months of pregnancy, which in turn will detrimentally impact women's health, safety, success, and equality in America.

Conclusion

Enshrining a "right" to elective abortion through all nine months of pregnancy in Hawaii's constitution will negatively impact the welfare of women and preborn children in Hawaii. SB 297 targets and undermines hard-fought, life-affirming policies, potentially leading to legal challenges seeking to strike such laws and legislative repeal of Hawaii's basic, common-sense protections for women, girls, and their preborn children.

Further, enshrining a constitutionally protected "right" to all reproductive matters will make it difficult for Hawaii to enact any future protections for women and girls seeking elective abortion, subjecting women to the well-documented dangers of unregulated abortions.

SB 297 does not give "freedom" to women, but hands control to self-interested, financially-motivated abortionists, as well as to sex-traffickers and abusers who seek to cover up their crimes through abortions.

Simply put, the people of Hawaii do not need SB 297. The only "right" it adds is the intentional termination of life in the womb, and it will only be a means by which abortion activists will strip away the few common-sense and basic regulations Hawaii has in place.

Aloha Chair San Buenaventura, Vice Chair Aquino, and Members of the Committee,

On behalf of the Board of Directors of Pacific Birth Collective, we submit this testimony in strong support of SB297, a proposed constitutional amendment to affirm and protect the right to reproductive freedom in Hawai'i. As a community-based organization dedicated to ensuring access to respectful, culturally rooted, and equitable reproductive care, we believe this amendment is critical to upholding the fundamental rights of individuals and families in our state.

Reproductive autonomy is the cornerstone of personal and family wellbeing. This proposed amendment rightfully enshrines the right to abortion care and contraceptive access, recognizing that decisions regarding pregnancy are deeply personal and should remain free from government interference. However, reproductive freedom extends beyond the right to prevent or terminate pregnancy—it must also include the right to give birth where and with whom one chooses.

We respectfully urge the committee to consider an additional provision within this amendment that explicitly affirms:

(4) The right to choose where and with whom to give birth.

For the majority of cases, birth is a non-medical event and deserves the same constitutional protections of autonomy and bodily integrity as the right to abortion or contraception. Just as an individual has the right to decide whether to carry a pregnancy to term, they must also have the right to determine how and where to give birth—whether in a hospital, a birth center, or at home, and whether attended by a midwife, physician, family member, or chosen birth attendant. Restricting these choices disproportionately affects Native Hawaiian, rural, and historically marginalized communities, further limiting access to safe and culturally appropriate care.

Pacific Birth Collective stands firmly for the expansion of reproductive justice, which includes not only access to contraception and abortion but also the right to birth with dignity and self-determination. We urge the committee to support and advance this legislation while considering its broader implications for birthing rights in Hawai'i.

TESTIMONY IN SUPPORT

Aloha Chair San Buenaventura, Vice Chair Aquino, and Members of the Committee,

I submit this testimony today IN SUPPORT of SB 297.

The days since the U.S. Supreme Court overturned fifty years of precedent and rejected Roe v Wade in 2022, have been trying ones for women and girls in this country. I am the mother of two young women, and I would have never have imagined that the choice for them of where to live, work, and go to school would be limited by the potentially life-altering and life-threatening risks posed by abortion bans in states around the country. I am burdened by the reality that they have fewer rights to bodily autonomy in parts of the country than I did when I was their age. More chillingly, it has become clear in recent days that the Trump administration intends to fully implement the threatened Project 2025 agenda and to roll back civil rights for all Americans and institute a white, male, heterosexual, Christian nationalist autocracy.

This is contrary to our ideals as a community here in Hawai'i. We must unite in opposition to this agenda and do what we can as a state to secure the rights of our citizens. Women are dying in states with abortion plans from denial of care in the event of medical emergencies such as ectopic pregnancies, miscarriage, and the death of the fetus in utero from medical complications. I have a family member in Florida who had a "late-term abortion" (which is also the technical medical term used for all terminations, including miscarriage) as the result of a medical complication experienced by her unborn child that rendered her pregnancy non-viable. This happened before the overturn of Roe v Wade, and so her "late-term abortion" prior to the fetal viability deadline was legally allowed at the time. It was still an extremely difficult situation for her and her family, and navigating "late-term abortion" while going through grief for the loss of a wanted child is not something I would wish on anyone. She was able to receive the medical care she needed, and the outcome, while personally tragic, was not life-threatening. If the same thing happened to her today in Florida, it is very likely that she would have had life-threatening or disabling complications. Abortion bans have been shown by medical research to cause higher instances of sepsis, longer hospital stays, and more days in the ICU. They are rejected by a majority of citizens, included 57% of Florida voters in the referendum last November.

Hawai`i must act NOW to protect the civil rights and bodily autonomy of its citizens. Bodily autonomy is a basic human right. We must enshrine access to reproductive health care in the

Hawai'i State Constitution, the right to contraception, and the right to an abortion up until fetal viability, for the sake of our daughters, mothers, sisters, aunties, friends, and community, so that they are ensured access to necessary health care decisions made with their doctors without government interference.

I request that you stand with the women and girls of Hawai`i and pass SB297 expeditiously.

Thank you for allowing Indivisible Hawai'i this opportunity to testify in **support of HB297** which will allow to be place on the next election ballot a Constitutional Amendment to protect the right to obtain or use contraceptives.

The prohibition of the State from denying or interfering with an 'individual's' 'reproductive freedom,' including the 'right' to choose to obtain an abortion and to obtain or use contraceptives do not align with the full consent of all the citizens of Hawaii to be codified in the Hawaii State Constitution.

This removes the voices and rights of the citizens of the State of Hawaii in the legislative process and places authority in state judge(s) and courts. This 'prohibition' should be determined by the citizens, the people, of our entire state and even subject to ballot voting.

Broad and undefined terms such as 'individual's' rather than defining who these 'individual's' are allows for persons or human beings of all ages including children (under age 18) without parental consent or authority unrestricted autonomy to obtain abortions, obtain contraception, puberty blockers, sterilization, genital mutilation surgery under the guise of 'gender-affirming care.' This measure proposes an amendment to the Hawai'i State Constitution to prohibit the State from denying or interfering with an individual's reproductive freedom, including the right to choose to obtain an abortion and to obtain or use contraceptives.

Founded in 1994 by Hawai'i's community health centers, AlohaCare is a communityrooted, non-profit health plan serving over 70,000 Medicaid and dual-eligible health plan members on all islands. Approximately 37 percent of our members are keiki. We are Hawai'i's only health plan exclusively dedicated to serving Medicaid and Medicaid-Medicare dually-eligible beneficiaries. Our mission is to serve individuals and communities in the true spirit of aloha by ensuring and advocating for access to quality, whole-person care for all.

AlohaCare is committed to improving and advocating for access to care. We fully support this measure because all people in Hawai'i deserve timely, safe, and local access to healthcare, including abortion care and access to contraception. This measure would help to protect access to care for the residents of Hawai'i.
