SB301 SD1 RELATING TO DOGS

Chair Gabbard, Vice Chair Richards, and Members of the Committee,

The Hawaii Cattlemen's Council <u>supports SB301 SD1</u> which establishes an additional penalty for a dog owner whose dog destroys property while on land zoned for agricultural use.

As ranchers consistently deal with dogs on pastures, we appreciate this additional penalty for owners whose dogs destroy property on agricultural land – this negatively impacts the business of rancher and also causes harm to the livestock themselves. Ranchers use low-stress animal handling for animal health and well-being, but the introduction of unmanaged dogs increases stress.

Establishing an additional penalty will motivate dog owners to take more initiative in securing their dogs and preventing damage. Enforcement of this is critical, and in the past it has been difficult to identify the owners of dogs that have trespassed and caused damage. In addition to establishing the additional penalty, more clarity is needed on the appropriate entities to contact when damage is done.

We appreciate the opportunity to testify on this measure. The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.

Aloha Chair Gabbard, Vice-Chair Richards, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 301, SD1, which establishes an additional penalty for dog owners whose dogs destroy property while on land zoned for agricultural use. This measure is an important step toward protecting farmers, ranchers, and agricultural businesses from the financial and operational losses caused by uncontrolled dogs.

Loose and stray dogs have been a persistent problem for agricultural operations, particularly for livestock producers. Attacks on cattle, sheep, goats, poultry, and other livestock can result in devastating losses for farmers and ranchers, with financial impacts that are often not recoverable. Beyond economic losses, these incidents also cause significant animal suffering and distress, disrupt farm operations, and pose safety risks to farm workers and residents.

SB 301, SD1, strengthens existing protections by increasing the penalties for dog owners who fail to properly contain their animals. By holding owners accountable for damage caused by their dogs on agricultural lands, this bill encourages responsible pet ownership while ensuring that farmers and ranchers have the legal support necessary to protect their operations.

Counties already have the authority to regulate dangerous dogs, but enforcement is often inconsistent, and penalties may not be sufficient to deter repeat offenses. By establishing a minimum fine of \$1,000 for violations occurring on agricultural lands, SB 301, SD1,

provides a stronger deterrent against irresponsible dog ownership and reinforces the importance of keeping pets properly contained.

We appreciate the Legislature's recognition of this issue and urge the committee to pass SB 301, SD1, to provide better protections for Hawai'i's agricultural industry and ensure that farmers and ranchers can operate without the constant threat of livestock losses due to uncontrolled dogs.

We deal with loose dogs on our ranch multiple times per month. Over the past 5 years, we have lost about half of our elk herd to either dog injury or stress from dog pressure. This has created the need to replace existing fences with smaller square hog wire and build new boundary fences to try to keep neighbors dogs out of the pastures, costing the ranch over \$100,000 thus far.

Wow. It is about time. We in the livestock business get hit all the time by dogs. Some from hunters who's dogs see a calf jump up out of the grass and either kill it or mame it so bad that we have to . We get cows with ears ripped off, as well as utters preventing them from nursing their calf. I personally have had a pack of 12 dogs roam the ranch and kill 6 to 30 sheep in one spot. Last year we lost 185 sheep that we counted and 75 goats. A month ago I had 65 sheep in a holding paddock to work the next morning. When we got there 22 were dead or had to be put down.Looked like just from one dog as the neighbor across the gulch said he heard just one dog bark then stop then bark again. Dogs unlike wolves and cyotes will kill for sport . Its a game. Once the sheep they are piled up on dies they chase the next one until nothing is moving. The sad thing is finding the animal half dead with maggots that is suffering for 2 or 3 days. If I could attach photos, which I can't, you would see the carnage that they cause. And its not just the packs . I had a guy walking through the pasture with a pit bull and it took off after a calf. The mother went after the dog and it bit her in the tongue as she was bellowing and ripped all but a half inch causing the tongue to hang out of the mouth like a strap. The cow had to be put down as they need their tongue to pull the grass in their mouth. The guy never got charged or paid for any loss.
