Chair Dela Cruz and Members of the Committee:

The Department of the Attorney General provides the following comments regarding this bill.

This bill designates the Hawaii Symphony Orchestra (HSO) as the "State of Hawaii Symphony Orchestra" and exempts it from the qualifying standards and conditions contained in chapter 42F, Hawaii Revised Statutes (HRS), to allow it to regularly receive state funds without filing a grant application as required by chapter 42F in exchange for services to the State to be mutually negotiated.

 A Preamble Should Be Added to Senate Bill No. 441 to Promote the Public's Understanding of the Legislature's Intent of this Bill

We note that the Legislature in Act 382, Session Laws of Hawaii (SLH) 1987, established the Honolulu Symphony Endowment Fund to provide financial support to the Honolulu Symphony. The legislative history of Act 382 stated that the "Honolulu Symphony is a major cultural resource of Hawaii and is deserving of the support provided in this bill." Senate Standing Committee Report No. 802 (1987).

In Act 258, SLH 1988, the name of the Honolulu Symphony Endowment Fund was changed to the State of Hawaii Endowment Fund. Subsequently, in Act 175, SLH 1995, the Legislature, in section 1 of the Act, noted that the purpose of the Act "is to clarify the legislative intent that the income and capital gains of the State of Hawaii

endowment fund are to be used for the production of music by an Oahu-based symphony orchestra." We understand that such moneys have been transferred to the HSO "for the production of music by an Oahu-based symphony orchestra."

Also, we note that the legislative history of Act 175 states that "the legislative intent to establish the endowment was to support a live symphonic orchestra for the residents in Hawaii." Conference Committee Report No. 103 (1995). Consequently, we believe that the HSO serves a public purpose.

Further, article VII, section 4, of the Hawaii Constitution, provides that "[n]o grant of public money or property shall be made except pursuant to standards provided by law." The HSO is a domestic nonprofit corporation. The attempt to statutorily exempt a nonprofit from the chapter 42F, HRS, standards that are constitutionally required is subject to challenge. However, for the HSO, section 40-88, HRS, indicates that there is a "Honolulu Symphony Trust" and the State of Hawaii Endowment Fund with funding through the State Foundation on Culture and the Arts: "There shall be established as a separate fund of the Honolulu symphony trust created by the trust agreement dated December 5, 1986, a fund to be known as the State of Hawaii endowment fund. The income and capital gains from the \$2,000,000 contributed by the State of Hawaii shall be transferred on a quarterly basis to the state foundation on culture and the arts, performing and visual arts events private contribution account to be used for the production of music by an Oahu-based symphony orchestra as determined by the state foundation on culture and the arts." Since the State Foundation of Culture and the Arts is already transferring the income and capital gains from the State of Hawaii Endowment Fund to the HSO, we suggest that the Legislature consider appropriating additional funding to the State of Hawaii Endowment Fund whose income and capital gains could then be used for the HSO.

To effectuate this suggestion, we suggest the following section be added to the bill:

"SECTION . There is appropriated out of the general revenues of the State of Hawaii the sum of \$_____ or so much thereof as may be

necessary for fiscal year 2025-2026, for deposit into the State of Hawaii Endowment Fund.

The sum appropriated shall be expended by the department of accounting and general services for the purposes of this Act."

To facilitate the public's understanding of what the Legislature is trying to accomplish regarding providing public funding for the HSO, we recommend that a findings and purpose section be included in the bill outlining the history of the HSO, the support that the HSO has received from the State of Hawaii Endowment Fund, and the public benefits that have accrued from its existence.

Chapter 42F Exemptions for Nonprofits Other than the HSO are Constitutionally Problematic

We note that granting chapter 42F exemptions to nonprofits other than the HSO is likely to violate article VII, section 4, of the Hawaii Constitution. This is because such nonprofits do not share the same State-established heritage as the HSO. The HSO's unique historical connection to the State gives it a special status that other organizations cannot claim, making exemptions for those other entities constitutionally problematic.

We respectfully ask the Committee to consider our comments.

Chair Dela Cruz and members of the Committee,

the State Foundation on Culture and the Arts (SFCA), is pleased to offer **COMMENTS** on S.B.441 which Designates the Hawai'i Symphony Orchestra as the State of Hawai'i Symphony Orchestra. Requires annual reports to the Legislature. Appropriation.

The performing arts in Hawaii are a vital part of our community and currently receive SFCA support through General Fund appropriations from the legislature and Federal funding from the National Endowment for the Arts. Performing Arts, including cultural presentations, represent 43% of total Biennium Grants awards and 72% of total Artists in the Schools projects. Music and music education are an important part of the cultural landscape. Hawaii, in the center of the Pacific Ocean is blessed with a variety of musical traditions. The Hawaii Symphony Orchestra represents the finest in the orchestral tradition in Hawaii, serving the public and schools statewide.

The Hawaii Symphony Orchestra regularly receives state funds in the form of grants from the State Foundation on Culture and the Arts, Grants in Aid from the Hawaii legislature and quarterly dividends from State funds in the Hawaii Symphony Endowment fund.

The Hawaii Legislature initially gave \$2 million decades ago to establish the Honolulu Symphony Foundation Endowment. Then in 2006, the Hawaii State Legislature passed HB3235 HD1 SD1 CD1 Act 097 appropriating \$4,000,000 to the State of Hawaii Endowment fund to support the Honolulu Symphony Orchestra, now known as the Hawaii Symphony Orchestra. The intent of the grant was to provide regular State support and requires the fund to be matched with private funds. The fund provides regular dividends to support the Hawaii Symphony Orchestra. Understanding the status and performance of the fund is an important step when considering establishing additional State support. Should the legislature appropriate funds, the SFCA recommends the funds go to the endowment.



Comments:

My name is Nicole Ebisu, and I am a music teacher in Hawaii, as the owner of Violin Artistry and an orchestra teacher at Iolani School. I am writing today in strong support of recognizing the Hawaii Symphony Orchestra (HSO) as the official State Orchestra of Hawaii.

In addition to being an educator, I had the honor of serving as a violinist with the Hawaii Symphony Orchestra (and formerly Honolulu Symphony) for the last 19 years. Through my time with the orchestra, I witnessed firsthand the profound impact it has on our community, inspiring audiences of all ages and providing a world-class musical experience that is unique to our islands.

As a teacher, I see how essential the HSO is to the development of young musicians. Many of my students rely on the symphony as a source of inspiration, motivation, and artistic excellence. Attending HSO performances exposes them to live orchestral music at the highest level, broadens their cultural awareness, and encourages them to strive for musical excellence in their own studies. Without the HSO, many young musicians would not have access to the professional mentorship and experiences that are crucial for their growth. They have been able to watch the concerts of famous artists such as Yo-Yo Ma, Lang Lang, Ray Chen, Sarah Chang, Augustin Hadelich, Joshua Bell, and many more.

Beyond the classroom, the HSO plays a crucial role in our community. Their outreach programs bring music into schools, ensuring that students across the state—regardless of background or financial means—have opportunities to engage with professional musicians. These experiences not only enrich students' musical education but also foster a lifelong appreciation for the arts.

I fondly remember a symphony tour to the Hilo, Big Island with Rai'atea Helm and Aaron Mahi about 15 years ago. We all gathered in a big auditorium with thousands of young children. Many of these children had never seen a classical instrument before. On this same trip, we split up into smaller groups to do school visits. I remember when the Symphony was a 42-week season and toured the neighbor islands every season, presenting full orchestra concerts and small ensemble educational programs in schools. I hope that this bill will help us be able to expand our season and return to regular touring, fulfilling our mission of serving the entire state.

Again, I strongly support SB441 and I hope that this will help ensure the future of the HSO for years to come.

I was a musician in the Honolulu/Hawai'i Symphony for 45 years, from 1971 to 2016. In that time I witnessed and participated in many momentous events, both good and bad. Each one left an indelible impression – indeed, changed my life.

One such event was the Symphony's trip to Kaua'i in 1992 in the aftermath of Hurricane 'Iniki. Coconut palms had no fronds; power lines were down, roofs of buildings had blown off, but hundreds of people came to the park to hear the orchestra. They were hugging, singing, and crying when the sounds of "Hawai'i Pono'i" and "Hawai'i Aloha" reached their ears. It was a great moment of healing for the entire island.

Another event was the last public performance by Rosemary Clooney on a HSO Pops Concert. I wrote about it, along with other factors that prove the Hawai'i Symphony's worth, in this excerpt from my book:

To the Editor: On "Does Honolulu Need the Symphony?"

Midweek

Every five years or so somebody dredges up that tired old question again, "Does Honolulu need the symphony?" I thought everybody had already heard the question and already knew the obvious answer. At first I said to myself, why bother to answer this lame question yet again? But then, maybe the columnist who asked the question this time, and perhaps a few others, have been asleep and haven't gotten the word. So here it is.

The columnist asks "whether donors' and taxpayers' monies would be better spent on other social enterprises," and "might we be better off if that symphony donor money went straight into music programs in our schools?" These are meaningless questions, because there are no other social enterprises that address the community need that the symphony does or that could fill the niche of the symphony.

And while school music programs can certainly use money, we are talking apples and oranges here. The objectives of the symphony and of school music programs are not the same, not even close. The symphony exists to present concerts; it serves the entire community, not just school students, and although it does present educational programs, it is not an educational institution, it is an arts institution. By the same token, although school music groups occasionally present public performances as part of the educational process, they exist to serve the students, not the public; schools are not arts institutions, they are educational institutions.

Let me illustrate the value of arts institutions with the Honolulu Symphony's Grammy-nominated CD of its concert with the late Rosemary Clooney. The CD was an archive of a Honolulu Symphony Pops concert, part of the regular pops series that takes place every few weeks on the Blaisdell

Center stage, part of the symphony's ongoing public service mission. It was a magical concert, which ended with a dying Clooney saying, "Thank you for one of the best nights of my life."

There were many forces that made that performance happen at such a magically high artistic level, but it all began with the existence of a resident professional orchestra with the artistic depth and organizational sophistication to bring all those forces together. Simply stated, Honolulu needs an orchestra so that nights like that are possible, so that our citizens can have the opportunity to experience art of the same life-changing quality and power as in every other major city in the world. And it is not enough to listen to CDs or import touring orchestras from elsewhere. We need a resident orchestral institution that is responsive and answerable to the community that owns it.

For that reason, government funding is not just necessary, it is desirable, because it is important that the orchestra be owned by all the people, not just by the moneyed elite, so that all of us can claim a piece of the symphony and share common responsibility for it. If the costs of the symphony are shared broadly over our entire population in the form of donations, ticket purchases, and taxpayer subsidies, each person's burden of keeping the symphony healthy and flourishing is light. Cities that understand this principle have orchestras that have survived much worse trouble than the Honolulu Symphony has ever seen, and have thrived even in the face of occasional deficits.

A CD is not a substitute for live music. Ask any restaurateur if his clientele responds the same way to Musak as to a live band. A recording of a musician's work is like a videotape of a dancer, or a photograph of a painting. It is a categorically different experience from a live concert and cannot replace the real thing. And there is another thing that cannot be replaced: The Honolulu Symphony has created over its 100-year history hundreds of original works and arrangements of Hawaiian music that would not now exist if the Honolulu Symphony did not exist. We have a library of arrangements by legendary Hawaii musicians like former Royal Hawaiian Bandmaster Lloyd Krause and local Filipino composer Angel Peña, as well as orchestral arrangements to accompany virtually all of our great Hawaiian musicians, from Don Ho to the Farden family to the Brothers Cazimero and Keali'i Reichel.

The arts are businesses, with all the same positive economic and societal impacts as other businesses. We need the symphony (and the Royal Hawaiian Band, and the Hawaii Opera Theater, and the Honolulu Academy of Arts, and Diamond Head Theater, and all the other arts) for the same reasons that we need banks, airlines, stores, restaurants, hospitals, schools, and all other enterprises that make our lives happier, healthier, and more satisfying.

Advocacy for the arts is one of the few social issues that enjoys true bi-partisan support. A belief in the value of the arts and a history of generosity in their support is shared across the sociopolitical spectrum. The arts help everyone and hurt no one. So what's the problem?

My name is Lloyd Lim and I am testifying in my individual capacity in strong support of SB 441 providing funding to the Hawaii Symphony Orchestra (HSO). The current HSO is a vastly superior orchestra to the HSO of 20 to 50 years ago. This is an excellent orchestra on the upswing with great future potential for Hawaii. The string section sound would surprise anyone. I have heard live performances by the Vienna Philharmonic, the Berlin Philharmonic, the Concertgebouw of Amsterdam, the Boston Symphony, the Philadelphia Orchestra, the New York Philharmonic, and the St. Louis Symphony. I feel as if I have a basis for comparison.

Many of the orchestra musicians are also music teachers in our community helping to raise our kids. I dropped out of the piano as a kid and turned to the clarinet before taking up piano again after high school. How I wish I had kept at the piano as a kid. My brain would have developed better and faster and I would have been far better prepared for college, graduate school, law school and my career.

But you don't have to take my word for it. *Columbia Magazine* (Spring/Summer 2015) noted that Columbia Medical School considers a music background in admissions because it can assist both diagnosis skills and the motor control needed for surgery. Also, *The Great Courses* class <u>Music and the Brain</u> taught by Professor Anniruddth D. Patel noted that music training also has a significant effect on the development of verbal skills.

I have gone to many HSO concerts and I have been using social media to talk about HSO in the hopes that the word will get out to folks with an interest in classical music who might use it as an excuse to visit Hawaii. I interact with classical music buffs in the US mainland, Japan, Hong Kong, England, Germany and Italy. We live in a troubled world, but because most orchestra music is without words, it can form a basis for relationships that avoids contentious political issues.

As a kid growing up in Honolulu, I took a risk being a classical music buff. It made me suspect. I'd like to see that viewpoint change. Not everyone likes classical music, but that is often because they had a bad initial exposure to it. There is material for pretty much everyone in classical music, and over time you can climb into more of it as you like. Classical music used to be for aristocrats, snobs (let's face it), but with YouTube it is no longer. Ideally, the richest people in Hawaii should contribute to HSO. But how can we ask them to be donors, if the State government won't take up the leadership position?

I'm writing in support of SB 441. The Hawai'i Symphony Orchestra is an invaluable resource to our community, and is an inspiration to our youth statewide.

As you know, I am President & CEO of Hawai'i Youth Symphony, a separate organization which for sixty years has provided quality music education to keiki statewide and serves over 2,500 youth and dozens of public, home, and independent schools annually.

At HYS, our vision—A Hawai'i where Music Is A Right—assumes a reality in which our state has a thriving HSO, and we wholeheartedly collaborate with HSO throughout the year as we work towards this vision.

On a personal note, I was born & raised here on O'ahu, and would like to take you through a bit of how HSO has played a role in my life when I was a youth, and then share how it makes a difference for today's youth in present day and looking forward to a future Hawai'i.

I was first introduced to orchestral music as a keiki, listening to HSO broadcasts on Hawaii Public Radio, later while participating in HYS and taking bass lessons from HSO musicians. As a youth, I was exposed to the high artistic standards required for professional success through access to HSO's open rehearsals, youth concerts, and meeting HSO musicians in a variety of community settings. This exposure subsequently inspired me to seek further training and higher education from institutions that HSO's professionals had attained in their college and career pathways: for example, to Tanglewood (the summer home of the Boston Symphony Orchestra), to the Kennedy Center and the National Symphony Orchestra, and later, to Boston, where I attended New England Conservatory and Harvard University to major in music performance and attain a Master's Degree in Arts in Education, respectively. **Repeated exposure to a world-class musicians inspires young people to cultivate their own personal excellence!**

Although I was the only Hawai'i student at New England Conservatory, in Boston, I was among dozens of other Hawai'i students who had taken private lessons from Honolulu Symphony Orchestra musicians and were regular attendees of HSO concerts. (One need not major in music in order to reap the benefits of intensive musical study.)

Among my college contemporaries were those who graduated from Moanalua, Roosevelt, Kalani, Mililani, Baldwin, Waipahu, 'Iolani, Punahou, and more; all who had benefitted from exposure and access to the HSO back home. A unifying experience was one in which HSO musicians taught us and pushed us to be our best. As we sought our respective paths, while attending renowned colleges like MIT, Harvard, Brown, Wellesley, Smith, Boston University, and Berklee College of Music, we also entered the continent more worldly and more cultured, thanks to the unique melting pot of Hawai'i arts & cultural institutions, which has always included the HSO.

Fast forward 30 years. I recently had a conversation with renowned industry maverick Chad Smith (former CEO of the Los Angeles Philharmonic, and current CEO of the Boston Symphony Orchestra), on the roles that orchestras play in developing the cultural tapestries of our communities. He articulated an idea to me of orchestras being labs/incubators, in which "radical collaboration" can take shape.

We don't need to go as far as LA or Boston to see this in action. It's already happening, right here!

I see "radical collaboration" happening daily in our hometown orchestras, HSO and HYS. There is an incredible malleability, an adaptiveness, and an instinctive passion that Hawai'i inspires, and that both the Hawai'i Youth Symphony and the Hawai'i Symphony Orchestra are able to capture; particularly when we work together.

In 2023, Hawai'i Youth Symphony was recognized by the global entrepreneurship magazine Fast Company as one of the world's Best Workplaces for Innovators. Some of the work for which we were recognized included our collaborations with HSO. Their willingness to engage with Hawai'i Youth Symphony in Side-by-Side collaborations and the Nā Hōkū 'Opio Young Stars competition, for example, are terrific examples of the ways they partner with us to extend very special artistic opportunities to youth.

I would also like to highlight and commend them for their efforts to build bridges between the typically-Euro-centric orchestral world with the multifaceted cultures of Hawai'i. Their commissions of Symphony of the Hawaiian Birds and Symphony of the Hawaiian Forests, their drive to engage local artists in HAPA Symphony projects, and the new commissions of Asia-Pacific composers are all terrific steps towards breaking down the systemic barriers to appreciation and access of orchestral music in Hawai'i. I can't wait to see what HSO does next, and support them in every way. As arts funding diminishes for organizations of all types, I urge you to pass this bill—and also—remember to fund other organizations who are also doing important work to bring equity and access to the arts statewide.
