In consideration of SB47, Relating to State Holidays

Chair Lee, Chair Aquino and the members of the committees:

The Office of Collective Bargaining (OCB) appreciates the intent of SB 47, which designates the day of the second new moon after the winter solstice of every year as the Lunar New Year and establishes the Lunar New Year as a state holiday. However, OCB offers the following comments on this measure:

- 1. While the Legislature is the governing body to both establish and remove official state holidays, the potential impact on public employees is a negotiable matter, subject to collective bargaining pursuant to Hawai'i Revised Statutes (HRS), §89-9.
- 2. Also, the establishment of Lunar New Year, as an official state holiday, would have no effect on public workers unless it is negotiated and mutually agreed to.
- Should this measure pass prompting the exclusive representatives to initiate
  negotiations for inclusion of Lunar New Year as another observed holiday for
  public employees, the employer would have serious concerns regarding the
  operational and financial impact to the State.
