Thank you for the opportunity to testify on this bill. The Campaign Spending Commission (“Commission”) supports the intent of this bill but is concerned about the funding for the public financing program and the Commission’s need for additional personnel to implement the bill’s mandates.

This bill establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices to beginning with the 2028 general election year, appropriates funds to the Hawaii Election Campaign Fund, and appropriates funds to the Commission. This public financing program is modeled after the pilot Hawaii County Council Comprehensive Public Funding Project<sup>1</sup> that ran in 2010 and 2012.

The bill establishes the maximum amount of comprehensive public funds (“CPF Max”) for each office as well as the minimum qualifying \$5 contributions (“\$5 MQC”) that must be raised for each office. The following table shows the \$5 MQC and CPF Max for each office:

If one candidate for each office qualified and received the CPF Max in the 2028 election period, this program will pay out **\$15,110,000** in public financing to the qualified candidates. In contrast, if one candidate for each office qualified to receive partial public funding in the 2026 elections, the state will pay a maximum of **\$2,948,612** in public financing. Under §11-O of the proposed new subpart to Part XIII of Chapter 11, Hawaii Revised Statutes, there must be a minimum of \$30,000,000 in the Hawaii Election Campaign Fund on September 1, 2027, in order for the Commission to run the comprehensive public financing program established by the bill.

The Commission asks that this committee restore the general fund appropriation to the Hawaii Election Campaign Fund in the amount of \$30,200,00 that was in Section 6 of the original bill for the Commission to implement the new comprehensive public financing program and restore the appropriation of \$200,000 in this and the next fiscal years from the Hawaii Election Campaign Fund in Section 7 of the bill for the Commission to hire two full-time equivalent (2.0 FTE) permanent positions to prepare for comprehensive public financing in the 2028 elections. The Commission has not had an increase in personnel for the past 29 years despite the number of candidate committees and noncandidate committees having almost doubled in size. Currently, there are only 5 staff members who oversee 700+ committees that have anywhere from 1-3 officers who require assistance on how to comply with the various requirements of campaign finance law thereby generating hundreds of staff hours assisting committees over the phone, in-person, and by email as well as a number of enforcement actions for violations. Under HRS §11-314(7), one of the Commission's 14 duties is to investigate and hold hearings for receiving evidence of any campaign finance violations. The Commission has no investigator on staff and has had to rely on contracts for investigative services with outside

agencies.<sup>3</sup> In comparison to other State and county good government agencies with compliance and enforcement duties, the Commission has had a modest budget and nominal staff despite a tremendous growth in committees, an expansion in its duties and responsibilities, and enforcement mandates. The Commission respectfully seeks your support so that the Commission may ensure that the integrity and transparency of the campaign finance process is upheld. The Commission requests that these two positions be permanent rather than temporary.<sup>4</sup>

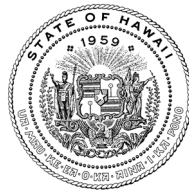
In summary, the balance in the Hawaii Election Campaign Fund is \$2,199,230.60 as of December 31, 2024. Obviously, this amount is insufficient to pay for the comprehensive public funding program, including the additional personnel the Commission will need, and thus, the total appropriation of \$30,200,000 in Section 6 of the bill is necessary.

Respectfully, the Commission requests that this committee address these concerns because there is insufficient funds and personnel to implement a program of this magnitude if it is going to pass this measure.

RELATING TO PUBLIC FINANCING FOR CANDIDATES TO ELECTED OFFICE

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill (S.B.) No. 51, S.D. 1, amends Chapter 11, HRS, by adding a new subpart to Part XIII titled "Comprehensive Public Funding for Candidates to State and County Offices," which establishes a comprehensive system of public financing for all candidates seeking election to State and county public offices in the State of Hawai'i, to begin with the 2026 general election year. Included with the establishment of the Comprehensive Public Funding Program (CPFP) is the creation of a CPFP subaccount within the Hawai'i Election Campaign Fund (HECF) to carry out the purposes of this measure. Deposits to the CPFP subaccount include appropriations made by the Legislature, excess seed money contributions, qualifying contributions, unspent public funds distributed to any certified candidate, fines levied by the commission for violation of the CPFP, and voluntary donations.

This measure also appropriates an unspecified amount in general revenues for FY 26 for deposit into the HECF for expenditure by the Campaign Spending

Commission for the CPFP; and appropriates an unspecified amount out of the HECF for FY 26 and FY 27 to fund an unspecified number of permanent full-time equivalent position and to prepare for the comprehensive public funding of candidates in elections taking place in 2026.

As a matter of general policy, B&F does not support the creation of any special account that requires regular general fund appropriations to support its activities and does not demonstrate the capacity to be financially self-sustaining. Regarding S.B. No. 51, S.D. 1, it is difficult to determine whether the proposed CPFP subaccount would be self-sustaining.

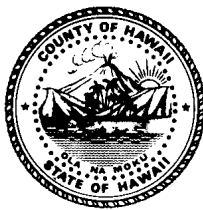
The Office of Hawaiian Affairs (OHA) offers the following **comments on SB51\_SD1**, which establishes a comprehensive system of public financing for candidates running for office in state and county elections.

**OHA generally supports public financing as a good government measure.**

Increased access to publicly financed campaigns makes elections more accessible, open, and fair. However, OHA is concerned about the disparate funding provisions included in this measure. Under the bill, OHA candidates participating in the program would receive up to \$40,000 in public funds. In contrast, candidates for the office of lieutenant governor receives up to \$1,200,000. OHA trustees are required to run statewide election campaigns on par with candidates like the lieutenant governor, and thus, we request that the candidates for OHA receive public funding on par as well.

Specifically, for the program to meet its potential and appropriately fund OHA candidates, **we respectfully request that Section 2 be amended on page 18, at lines 13-15, by increasing the funds available to OHA candidates to \$1,200,000, on par with the lieutenant governor.** An amendment to this section is necessary for candidates for OHA trustee to effectively reach voters statewide and run well-informed and fair elections.

We humbly request that if your committee chooses to pass SB51, that you include our proposed amendment and help us better serve our obligations to the Native Hawaiian community and promote equitable governance. Without these amendments, candidates for OHA do not have equal access to public financing provisions.

Aloha Chair Tarnas, Vice Chair Poepoe, and Committee Members,

I am testifying in strong support of SB 51 SD1 which establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State of Hawaii, to begin with the 2026 general election year, requiring the Campaign Spending Commission to submit reports to the Legislature.

By providing full public financing for qualified candidates, SB 51 SD1 will break the link between private money and electoral success and put efforts to reduce the influence of money in our elections. This will create a fairer and more honest system where elected officials are accountable to their constituents rather than big donors.

A comprehensive system of public financing is more cost-effective. Even if Hawai'i saw higher participation rates than any other state, estimates show the cost would be less than \$10 million per year—just 0.05% of the state budget. That's under \$7 per resident or less than \$1 per tourist—a small price to pay for a more transparent, accountable government.

Passing SB 51 SD1 will ensure that everyday people, not just a wealthy few, have a voice. This bill will restore trust in our democracy, empower candidates to focus on their communities rather than fundraising, and ensure that our government truly serves the people of Hawai'i.

Chair Tarnas and Committee members:

Thank you for the opportunity to provide testimony on Senate Bill 51 SD1.

The Office of the City Clerk takes no position on the merits of financing campaigns with public funds. However, we recommend that the Committee consider the donor qualification model used in a previous version of the bill, in which the Campaign Spending Commission serves as the sole entity responsible for administering the program.

Under that model, no information is transferred between offices, and the Commission is granted limited access to the State's voter registration system to verify qualifying donor contributions. County election offices play only a consultative role, assisting with clarifications related to voter registration records when necessary.

This approach aligns with how other states administer public campaign financing for legislative seats, where verification processes—if required—are handled by a state campaign spending agency or the secretary of state. A similar model exists in Arizona, where a dedicated commission oversees the implementation of public financing (see: <https://www.azcleaselections.gov/>).

As currently drafted, the measure places responsibility on both county election offices and the Campaign Spending Office to verify contributors. Based on our understanding, counties would first verify that contributors are registered voters, followed by final validation by the Campaign Spending Office.

Given the manual effort involved and the potential number of contributors requiring verification, this process cannot be completed with existing staffing levels and timelines. The challenge is further exacerbated by the overlap between peak candidate filing periods and the counties' preparations for the primary election.

Of particular concern to election administrators is that, as currently written, the bill blurs the lines between election administration and campaign-related activities, with the potential effect of disrupting election operations. If the measure moves forward, we urge the Committee to either consider an alternative approach to donor verification or include an appropriation to County Clerks to fund additional staff needed for these verifications.

Chair Tarnas, Vice Chair Poepoe, and Committee members:

Thank you for the opportunity to submit testimony on SB 51, SD 1, which in part establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices, beginning with the 2028 general election.

In 2010 and 2012, the County of Hawai'i Elections Division was tasked with administering the Hawai'i County Council Comprehensive Public Funding Pilot Project.

This pilot project's duties and responsibilities included verifying contributors were lawfully registered voters, verifying that qualifying contributions were duly collected, and transferring qualified documents and contributions to the Campaign Spending Commission.

The Hawai'i County Elections Division currently maintains staff who performed these duties to the best of their abilities. Their collective recollection is that this campaign financing pilot project presented myriad challenges from a logistical and programmatic perspective. Not the least being to ensure that the requirements of this pilot project were carefully followed while also performing day-to-day operational tasks associated with the upcoming primary and general elections.

Additionally, Hawai'i County is uncertain as to how qualifying contributions from counties other than Hawai'i County would be verified, presuming that candidates for state and county public offices would solicit and receive contributions from voters statewide. Coordinating with other counties to ensure proper administration of this program does not currently appear to be contemplated by SB 51, SD1.

If SB 51, SD1 passes in its current form, we would ask the appropriate committee to allocate sufficient appropriations to allow Hawai'i County to acquire additional staff and equipment. Providing an estimate of funds needed requires analysis Hawai'i County has yet to conduct. That analysis will be difficult, given the sheer uncertainty as to how many candidates will opt into this program and the offices those candidates will be seeking.

## **SENATE BILL 51, SD1, RELATING TO PUBLIC FINANCING FOR CANDIDATES TO ELECTED OFFICE**

**POSITION:** Support.

**RATIONALE:** The Democratic Party of Hawai'i Education Caucus supports SB 51, SD1, relating to public financing for candidates for elected office, which establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State of Hawai'i, to begin with the 2028 general election year, and requires the Campaign Spending Commission to submit reports to the Legislature.

Government should work for the public interest, not special interests.

In the 2010 and 2012 election cycles, the Hawai'i Island County Council ran a pilot program for comprehensive public funding. Similarly, Connecticut and Maine have instituted statewide clean elections programs, which have proven successful at increasing electoral participation and reducing candidates' reliance on private donations. Over 70 percent of Democratic legislators use public financing to fund their campaigns in Maine.

Hawai'i continues to be embroiled in public corruption scandals, following the bribery allegations that were levied against former Senate Majority Leader Kalani English and former State Representative Ty Cullen. Other public officials, such as employees at local permitting offices,

have also recently been ensnared in bribery scandals, in some cases with connections to Milton Choy, the lobbyist who was responsible for coordinating the bribery scheme that Sen. English and Rep. Cullen became a part of. These cases show that we have a moral crisis in our public institutions and must do all we can to restore integrity to government.

When candidates for public office are forced to rely on private donations to build relationships, those transactions can cause corruption or create the perception of it. Put simply, legislators are responsive to donors because donors fund their campaigns. Money is crucial to winning. Roughly 91 percent of candidates who outspend their opponents win their elections.

Relatedly, many people choose not to run for public office because they can't afford the cost of a campaign, leaving many incumbents routinely uncontested in their reelection bids. The average winner of a State House seat in Hawai'i spends approximately \$40,000 on their campaign, compared to only \$16,000 for the losing candidate. Over half of all campaign donations in 2022 came from just 980 donors, each of whom contributed at least \$6,000 in candidate donations during the last election cycle.

This bill will eventually create an election system that is fair for our island home. Once a clean elections program is fully effectuated in 2028—more than enough time to fund the system for the next non-gubernatorial election season—candidates will no longer need to rely on contributions from wealthy donors. Instead, they can seek support from their constituents in the form of small donations that verify their credibility and subsequently obtain public funding in an amount sufficient to run effective campaigns. Legislators will, in turn, be empowered to focus on engaging with their communities, rather than wheedling the donor class. Ultimately, this will help our government reflect the will of the people, not the wallets of the privileged.

Aloha Chair Tarnas, Vice Chair Poepoe, and Members of Committee,

My name is Susan RobertsEmery, and I am Co-chair of the Grenn Party of Hawai'i. A level playing field is very important to the Green Party of Hawai'i.

Hawai'i started a partial public funding program after adding it to the State Constitution in 1978. That early effort showed a commitment to ethical elections. This new proposal expands on that foundation. Between 2010 and 2012, the Hawai'i County Council pilot program gave about \$363,000 in public funds to 16 candidates. Many praised the pilot project for reducing reliance on wealthy contributors and for showing that publicly funded elections can work in Hawai'i.

Honorable Members of the Committee,

As a concerned citizen aligned with principles of limited government, individual liberty, and fiscal responsibility—values I believe resonate across party lines—I urge you to vote "No" on S.B. No. 51 (S.D. 1). This bill, which establishes a comprehensive public financing system for candidates to state and county offices starting in 2028, is a well-intentioned but deeply flawed proposal. It threatens taxpayer wallets, undermines electoral fairness, and risks eroding public trust in government—all outcomes we've seen in other states and municipalities that have tried similar experiments. Below, I outline my objections with evidence and appeal to your shared commitment to Hawaii's future.

## **1. Burden on Taxpayers in an Already Strained Economy**

This bill forces Hawaii's hardworking taxpayers to foot the bill for political campaigns, a cost estimated to require at least \$30 million annually in the Hawaii Election Campaign Fund just to certify candidates (Section 11-O). For context, the bill allocates up to \$2.5 million for a gubernatorial candidate alone (Section 11-H). In a state where families already face a high cost of living—among the highest in the nation—this is an unjustifiable burden. Democrats and Republicans alike should agree that public funds should prioritize schools, healthcare, and infrastructure over politicians' megaphones.

Look at Connecticut, which implemented a similar "Citizens' Election Program" in 2008. A [2017 report by the Yankee Institute](#) found that it cost taxpayers over \$50 million in its first decade, yet failed to reduce corruption or increase voter turnout as promised. Instead, it diverted funds from critical services during budget crises. Hawaii cannot afford to repeat this mistake.

## **2. Unfair Advantage to Incumbents and Established Politicians**

Public financing sounds egalitarian, but in practice, it often entrenches the powerful. S.B. No. 51 requires candidates to collect a minimum number of \$5 "qualifying contributions" (e.g., 6,250 for governor, Section 11-F)—a hurdle that favors incumbents and well-connected candidates with existing networks. Grassroots challengers, especially from underserved communities Democrats champion, will struggle to meet these thresholds, leaving them sidelined.

Arizona's Clean Elections system, enacted in 1998, illustrates this flaw. A study by the [Goldwater Institute](#) showed that incumbents benefited disproportionately, winning 85% of publicly funded races between 2000 and 2010. Newcomers, particularly minorities and independents, were squeezed out. This bill risks creating a similar elite club in Hawaii, contradicting its stated goal of "increasing meaningful citizen participation" (Section 11-A).

## **3. Inevitable Waste and Abuse of Public Funds**

The bill's structure invites waste and fraud. Certified candidates receive lump sums (e.g., \$100,000 for a state senator, Section 11-H) with little oversight beyond post-election audits (Section 11-J). History shows these systems are ripe for exploitation. In Maine, under its Clean Election Act, candidates have been caught using public funds for personal expenses—like car repairs and family vacations. A [2019](#)



[investigation by the Maine Ethics Commission](#) fined multiple candidates for such abuses, yet the system's loopholes persist.

Hawaii's bill imposes penalties (Section 11-M), but they're reactive, not preventive. Taxpayers—Republican, Democrat, or Independent—shouldn't be stuck cleaning up after candidates who treat public funds like a personal slush fund. We need accountability, not another bureaucracy.

#### **4. No Evidence It Reduces Corruption or Boosts Trust**

Proponents claim public financing will "restore public confidence" (Section 11-A) and curb special interest influence. But where's the proof? In New York City, which has a robust public funding program since 1988, scandals persist. The [New York Post reported in 2021](#) that candidates still collude with donors to skirt rules, costing taxpayers \$126 million in one election cycle alone. Corruption didn't vanish—it adapted.

Studies, like one from the [Campaign Finance Institute](#), show no consistent link between public funding and higher voter trust or turnout. Hawaii's partial public funding system, in place since 1978, already offers a compromise. Why gamble on a costly overhaul with no guaranteed payoff?

#### **5. Stifles Free Speech and Voter Choice**

This bill restricts candidates who opt in from accepting private donations during their campaign and term in office (Section 11-I), effectively silencing their ability to amplify their message beyond government handouts. For Democrats who value free expression and Republicans who cherish individual liberty, this should raise red flags. Voters lose too—publicly funded candidates might dominate airwaves, drowning out privately funded voices, including third-party candidates who often bring fresh ideas.

North Carolina's judicial public financing program, repealed in 2013, showed this chilling effect. A [report by the Institute for Justice](#) noted that it reduced competition, with fewer candidates running overall. Hawaii's diverse electorate deserves more choices, not fewer.

#### **6. A Solution in Search of a Problem**

Hawaii's current campaign finance laws aren't perfect, but they've kept our elections competitive without breaking the bank. The bill cites Watergate-era reforms (Page 2) and a vague "common belief" about wealthy donors (Section 1), yet offers no data showing a crisis here. Other states adopted public funding after specific scandals—Hawaii hasn't. Why fix what isn't broken, especially when the fix costs millions and risks backfiring?

#### **Conclusion: Vote "No" for Hawaii's Future**

Honorable members, S.B. No. 51 promises a utopian electoral system but delivers a taxpayer-funded boondoggle that favors insiders, invites abuse, and stifles debate. Democrats, consider the strain on working families and the barriers to new voices. Republicans, recognize the assault on liberty and fiscal sanity. Evidence from Connecticut, Arizona, Maine, New York City, and North Carolina screams caution. Let's protect Hawaii's resources and trust in our people—not politicians—to shape our democracy. I respectfully urge you to vote "No."

Aloha Chair Tarnas, Vice Chair Poepoe, and Members of the Committee,

HAPA is submitting testimony in STRONG Support of SB51, which establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State.

It's crucially important that the legislature does everything in its power to remove the influence money has on politics. Candidates work for donations that create relationships that can cause corruption or the perception of it. Money is crucial to winning, for example, 91% of candidates who outspend their opponent go on to win. Many elections are uncontested because potential candidates can't afford the high price tag. Furthermore, the average house winner spends \$40,000 compared to only \$16,000 for the loser.

Publicly financed elections will allow candidates to get support from their constituents rather than wealthy donors. As a result, elections will become more competitive with a more diverse set of candidates. Legislators will be free to act on behalf of voters without being concerned about what their donors think. Candidates will also be able to spend more time with constituents rather than fundraising. Furthermore, a system of fully publicly financed elections is overwhelmingly supported by Hawai'i voters.

Publicly funded elections are already being successfully implemented locally and in other jurisdictions. Hawai'i Island County Council races had this program in 2010 and 2012. Connecticut and Maine have clean elections statewide which are both very popular and successful. Over 70% of Democratic legislators use this program in Maine. Connecticut's program was established to get money out of politics following large corruption scandals.

SB 51 would provide participating candidates with competitive amounts of funding they need to run an effective campaign, and would ban them from receiving any private donations at all. This system worked very well for Hawai'i County Council races in 2010 and 2012, and currently works very well statewide in places like Connecticut and Maine.

Winning publicly financed elections is the single biggest thing we could do to end pay-to-play corruption in our politics and start building a Hawai'i that puts Hawai'i's land and people first — not big money interests.

Chair Tarnas, Vice Chair Poepoe, and Committee Members:

**The League of Women Voters of Hawaii strongly supports SB345 SD1.** The League of Women Voters of the US believes that methods of financing political campaigns should enable candidates to compete equitably for public office and ensure that candidates have sufficient funds to communicate their messages to the public. Hawaii's Partial Public Funding Program (PPFP) is intended to support those goals.

The amount available through the PPFP to publicly funded candidates has not changed in over two decades. Inflation in media prices, postage, and labor costs make the current amounts far less than competitive. The current amounts available to qualified candidates for public funding are far below the amounts spent by privately funded candidates who won election to the same office. Not surprisingly, the number of candidates using the PPFP has decreased every year since at least 2016. The increases proposed in SB345 SD1 unquestionably offer an improvement on the status quo.

In addition, SB345 SD1 cuts the amount of qualifying contributions required to access public funding for several offices, making the program easier to access.

To enable the Campaign Spending Commission (CSC) to fulfill the requirements of this bill as well as its existing duties, SB345 SD1 adds 2 positions to CSC staff and increases the CSC budget by an unspecified amount.

Please pass SB345 SD1.

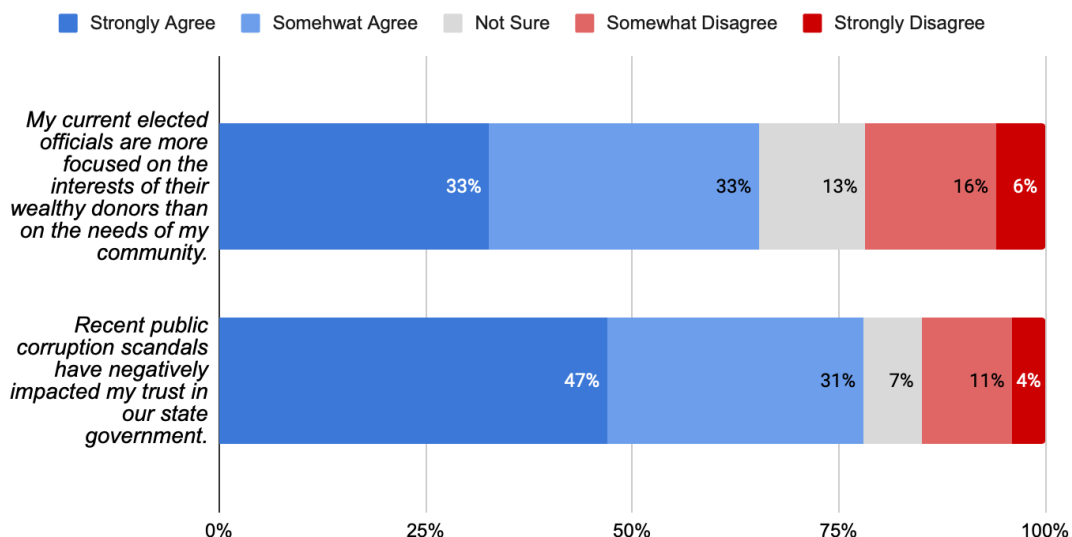
Mahalo for the opportunity to testify before you today. On behalf of Our Hawai'i's over 38,000 members and supporters across the pae 'āina, we write in strong support for Senate Bill SB51, relating to public financing of candidates to elected office.

The crisis of public trust in government has reached a tipping point. After years of the FBI putting our officials in handcuffs, resignations, and scandals, [Hawai'i voters as a whole in the 2022 election ranked government corruption as their number 3 top issue, only behind inflation and affordable housing](#), in a [survey](#) conducted on behalf of Our Hawai'i by the most accurate polling firm in US elections in 2020.

The reforms adopted by the legislature in 2023, while important, did not go far enough on a policy matter or in terms of shifting public perception. Polling conducted in 2024 by the Clean Elections Hawai'i Coalition showed **that two out of three voters (66%) believe that "elected officials care more about wealthy donors than the needs of my community."** 9 out of 10 voters also believe that influence or obligate legislators to some degree, with over half of voters believing that degree is "greatly."

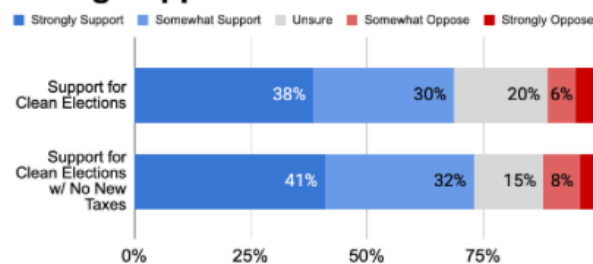

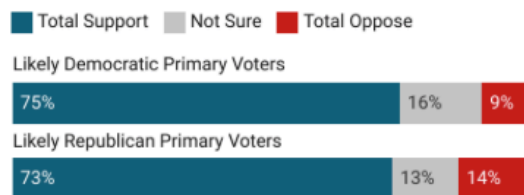
**pay-to-play corruption that has existed at high levels of Hawai'i political leadership. With the article being released towards the end of last legislative session, reform-minded lawmakers did not have time to act, but now you do.**

**Luckily, a solution is on the table for you to solve this problem.** The same voters, across race, ethnicity, income level, and political party, overwhelming support a Clean Elections program when it is described to them in plain terms, with **68% of voters saying they would support passing a law to create a Clean Elections program in Hawai'i.** And they are 4 times more likely to support than oppose a candidate for office who backs and champions such a program as well.

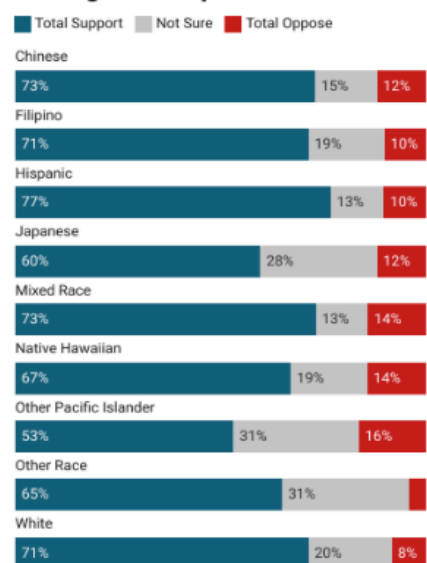
### Strong Support for Clean Elections

**With public trust at an all time low, now is the time for systemic and transformative solutions.** While progress has been made, it is not enough. We need to address the overriding issue of money in our politics where it begins, in our elections.

**SB51 would go as far as is legally possible under the United States constitution by providing a viable alternative to the status quo private money campaign system.** It would level the playing field for candidates who are not wealthy or well-connected, and take a historic step towards getting big money out of our elections.

No longer would legislators have to look over their shoulders, worried about how their donors who will fund their next campaign might react to each and every vote. **Legislators can be fully focused on delivering for their constituents, not campaign donors.**

**Programs like this work, and are cost-effective:** we've seen it in places like Connecticut, Maine, Hawai'i County and cities all around the US. Even if Hawai'i saw higher participation rates than any other State, **estimates show the cost would be less than \$5-10 million per year—just 0.05% of the state budget.** That's just over \$3-6 per resident or less than \$1 per tourist—a small price to pay for a more transparent, accountable government, and an [amount that a majority of those polled said they'd be willing to pay.](#)

**Responding to House Feedback:** We support this bill as written, however, last session the legislation was deferred in this committee, with a number of concerns and feedback raised by members of the House of Representatives. An overview of those concerns are outlined below, with proposed fixes, estimates of impacts of these fixes, and amendment language to make those changes, should you wish to act.

#### **Addressing Costs:**

- 1. Why Should the State Pay for The Counties?** Paying for this program at a County level would represent a much larger percentage of County than State budget funds, however, many House legislators have expressed they believe the State should not be responsible for funding county elections. Moreover, the formula for the partial public funding system already provides sufficient competitive funds for Kauai and Maui County Council races due to their at-large nature, making comprehensive funding less necessary. **Eliminating County Elections from the program would reduce the average annual cost by 36%.**
- 2. Further Addressing Cost:** While we maintain that the price tag of this legislation is well worth it, and is likely to result in cost-savings to the state over time as a result of more efficient lawmaking, the cost of the legislation has been a consistent complaint from House Representatives. The major cost-driving races are Governor and Lieutenant Governor. **By removing Governor & LG races from the program, the average annual cost could be reduced another 19%.**

**These two changes would reduce the program cost by 56% over baseline on an annual basis, bringing the annual cost to ~\$2.1 million.**

#### **Increasing Revenue:**

- 3. Make the Hawai'i Election Campaign Fund Opt-Out:** By switching the Hawai'i Election Campaign Fund that funds the Campaign Spending Commission from a \$3 opt-in tax refund to to a \$3 *opt-out* tax refund, we could create a durable permanent revenue source for the program without raising any additional taxes. At the current estimate of ~1 million individual tax filers (725,000 annual tax filers, with ~40% filing jointly), and assuming a 85% participation rate, **this shift would generate around \$2.59 million annually for the Campaign Fund.** This is up from the current annual revenue to the Fund of ~\$100,000

#### **Equity across qualifying contributions:**

- 4. Proportional calculation for qualifying contributions:** Many legislators have have fairly pointed out that the number of qualifying contributions for different races is arbitrary and non-proportional. You can correct for this by basing the number of qualifying contributions off of the number of registered voters in the district for the previous elections, just as the existing partial public financing system does. Designating the number of qualifying contributions as 1% of that

(a) Every individual whose state income tax liability for any taxable year is \$3 or more may designate \$3 to be paid to the Hawaii election campaign fund.

(b) The director of taxation shall revise the individual income tax return form to provide an option whereby the taxpayer may decline to allocate \$3 to the Hawaii election campaign fund. Unless the taxpayer explicitly declines this allocation by marking the appropriate box, \$3 shall automatically be designated from their state income tax liability to the Hawaii election campaign fund.

(c) If a joint return is filed, each spouse may make a separate designation under subsection (a). If one spouse chooses not to make a designation, that decision shall not affect the other spouse’s opportunity to make a designation.

(d) The \$3 amount designated under this section shall not constitute a reduction in the tax liability of the taxpayer or the amount of refund due to the taxpayer.”

### **Potential Amendment 4: Proportional Qualifying Contributions**

Replace SECTION 2. §11-F(2)(b) with:

(b) The minimum number of qualifying contributions shall be 1% of the number of voters in the last preceding general election registered to vote in each respective state senate and state representative voting district.

On behalf of Our Revolution Hawaii's 5,000 members and supporters statewide, we Stand in Strong Support of SB51 that Establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State of Hawai‘i, to begin with the 2028 general election year. Requires the Campaign Spending Commission to submit reports to the Legislature.

Since the *Citizens United v. Federal Election Commission*, the Supreme Court’s controversial 2010 [decision](#) that swept away more than a century’s worth of campaign finance safeguards, funding for candidates by special interests has grown exponentially. Overwhelming majorities of Americans have consistently [expressed disapproval](#) of the ruling, with at least [22 states and hundreds of cities](#) voting to support a constitutional amendment to overturn it. *Citizens United* reshaped political campaigns in profound ways, giving corporations and billionaire-funded super PACs a central role in U.S. elections and making untraceable dark money a major force in politics.

While the chances for meaningful reform in Congress appear slim, it falls on state governments to lead the charge to make funding elections fairer and more inclusive. The best way to combat special interest money having undue influence on our elections is for Hawaii to join the many jurisdictions across the nations that already offer various types of public financing for elections, the [most powerful solution](#) to the problem of big money in politics.

Hawai‘i started a partial public funding program after adding it to the State Constitution in 1978. That early effort showed a commitment to ethical elections. This new proposal expands on that foundation. Between 2010 and 2012, the Hawai‘i County Council pilot program gave about \$363,000 in public funds to 16 candidates. Many praised the pilot project for reducing reliance on wealthy contributors and for showing that publicly funded elections can work in Hawai‘i.

This investment can help protect the integrity of elections for all residents. Reducing dependence on large private donations can cut the costs linked to corruption or investigations later on.

Dear Chair Tarnas, Vice Chair Poepoe and Committee Members:

The ACLU of Hawai'i **supports SB51 SD1 Relating to Public Financing For Candidates Elected to Office. Specifically, we ask that you fully fund this measure, make it permanent and implement no later than 2026.**

In our view, the answer to concerns over the escalating cost of political campaigns is to expand, not limit, the resources available for political advocacy. **Thus, the ACLU supports a comprehensive and meaningful opt-in system of public financing that would help create a level playing field for every qualified candidate.**

A representative democracy functions best when it closely mirrors the electorate. And this is accomplished when access to public candidacy isn't limited by personal wealth or the deep pockets of private interests.

Financial means, or lack of such, can have a wide array of impacts. Access to wealth often results in better educational and health outcomes over the course of one's life. Those individuals and families impacted by our criminal justice system are predominately those who live in poverty. **So too do financial means impact our electoral system. Those with greater financial means and access to high-quality education are more likely to run for, and win, elected offices.**

Giving potential candidates the option to access a meaningful pool of public money will go a long way toward leveling the playing field against well-funded and entrenched incumbents. And a well-funded public financing system could very-well encourage individuals from these under represented demographics to run for public office.

When our legislative officials have in common shared lived experience, not just geographic proximity, with those they represent we can all be uplifted with bolder public policy that acknowledges our most vulnerable and works to uplift them.


We will continue to advocate for reform of the current system, including in support of our longstanding commitment to public financing of campaigns. In doing so, we will stress fidelity to

My name is Will Caron. I live in Kahalu‘u on O‘ahu's windward side. I am testifying in strong support of SB51 SD1, which would establish a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State of Hawai‘i, to begin with the 2028 general election year.

*Citizens United v. Federal Election Commission* (2010) was a landmark decision in U.S. campaign finance law that has lead to a significant concentration of political power in the hands of wealthy entities, compromising the integrity of our democracy. In the 15 years since that decision, our elections have become increasingly dominated by big-monied interests, which has left the interests of the working class—which cannot afford to purchase political influence—behind.

We’ve created a system where money buys elections. Those who want to serve and represent their communities first need to acquire tons of cash. Without it, there is almost no chance of successfully running for election. This has eroded our democracy to the point that it is now being ransacked by a cabal of billionaire elites led by an authoritarian who has no problem taking away human and civil rights, plundering the natural environment for profit, and sacrificing the health and wellbeing of the rest of us in the process.

There is no easy way to undo the damage caused by *Citizens United*, and the oligarchy that has come roaring into power in the wake of that flawed ruling. We must claw our democracy back one step at a time. Creating a system of elections whereby a candidate can win without relying on big monied interests is one of the biggest steps we can take here at the state level. We need leaders who are accountable to the working class—to the people of Hawai‘i—not to corporations, billionaires, and other special interests.

Hawai'i's political system is broken. The heavy reliance on campaign contributions from wealthy donors and special interests has led to a system where 2 in 3 people believe elected officials are more focused on the interests of their donors than the needs of their communities. As a result, good policies are often blocked while harmful ones move forward. This dynamic erodes public trust and encourages corruption. SB 51 is a critical step toward fixing this broken system by allowing candidates to run competitive campaigns without being dependent on special interest money.

By providing full public financing for qualified candidates, SB 51 will break the link between private money and electoral success. I write to express my strong opposition to SB 51, which seeks to establish a taxpayer-funded public campaign financing system while banning private donations. While campaign finance reform is a laudable goal, SB 51 raises significant constitutional and legal concerns that undermine free speech rights, contravene federal precedent, and infringe on the principles of limited government. Below, I outline the legal foundations for these objections.

**First Amendment Violations**

SB 51's prohibition on private political contributions directly conflicts with *Buckley v. Valeo* (1976), where the U.S. Supreme Court upheld contribution limits but struck down expenditure caps, affirming that political donations are protected speech under the First Amendment. The Court ruled that while contribution limits may prevent corruption, outright bans on private funding unduly restrict political expression. Similarly, in *Citizens United v. FEC* (2010), the Court emphasized that independent expenditures (including those by corporations and unions) cannot be restricted, as they are core to free speech. By eliminating private donations, SB 51 effectively silences individuals and organizations, violating these precedents.

**Federal and State Legal Precedent**

- 1. Federal Election Campaign Act (FECA)**  
Federal law permits private contributions to candidates within regulated limits (e.g., \$3,300 per election to a federal candidate). SB 51's blanket ban exceeds federal standards and conflicts with FECA's framework, which balances anti-corruption measures with free speech rights.

2. **Hawaii Revised Statutes § 11-323**

Existing state law already provides partial public financing for candidates who voluntarily opt in, ensuring transparency without abolishing private participation. SB 51's mandatory taxpayer-funded system disregards this balanced approach.

3. **Hawaii Administrative Rules § 3-162-5**

Current regulations strictly prohibit misuse of public campaign funds (e.g., personal expenses, donations to other candidates). Expanding public financing to all campaigns risks misuse of taxpayer dollars, as seen in existing safeguards that SB 51 does not address.

## **Compelled Speech and Taxpayer Burden**

Forcing taxpayers to fund candidates they oppose violates the First Amendment's prohibition on compelled speech, as established in *Wooley v. Maynard* (1977). The U.S. Supreme Court has repeatedly affirmed that individuals cannot be coerced into subsidizing speech with which they disagree. SB 51's use of public funds for campaigns—without opt-out provisions—imposes ideological burdens on citizens, undermining democratic choice.

## **Proposed Alternatives**

Rather than banning private donations, Hawaii should:

- Strengthen disclosure laws to enhance transparency (e.g., HB 149, requiring corporate political expenditure reports).
- Adopt Connecticut-style pay-to-play reforms to curb contractor influence.
- Expand existing partial public financing (HB 308, SB 345) without eliminating private participation.

## **Conclusion**

SB 51's approach is constitutionally untenable and risks costly litigation. I urge the legislature to uphold First Amendment freedoms and focus on reforms that balance accountability with free speech. For further legal analysis, see *Buckley v. Valeo*, *Citizens United v. FEC*, and Hawaii's existing campaign finance statutes.
