Thank you for the opportunity to testify on this bill. The Campaign Spending Commission ("Commission") supports the intent of this bill but is concerned about the funding for the public financing program and the Commission's need for additional personnel to implement the bill's mandates.

This bill establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices to beginning with the 2028 general election year, appropriates funds to the Hawaii Election Campaign Fund, and appropriates funds to the Commission. This public financing program is modeled after the pilot Hawaii County Council Comprehensive Public Funding Project¹ that ran in 2010 and 2012.

The bill establishes the maximum amount of comprehensive public funds ("CPF Max") for each office as well as the minimum qualifying \$5 contributions ("\$5 MQC") that must be raised for each office. The following table shows the \$5 MQC and CPF Max for each office:

If one candidate for each office qualified and received the CPF Max in the 2028 election period, this program will pay out \$15,110,000 in public financing to the qualified candidates. In contrast, if one candidate for each office qualified to receive partial public funding in the 2026 elections, the state will pay a maximum of \$2,948,612 in public financing. Under §11-O of the proposed new subpart to Part XIII of Chapter 11, Hawaii Revised Statutes, there must be a minimum of \$30,000,000 in the Hawaii Election Campaign Fund on September 1, 2027, in order for the Commission to run the comprehensive public financing program established by the bill.

The Commission asks that this committee restore the general fund appropriation to the Hawaii Election Campaign Fund in the amount of \$30,200,00 that was in Section 6 of the original bill for the Commission to implement the new comprehensive public financing program and restore the appropriation of \$200,000 in this and the next fiscal years from the Hawaii Election Campaign Fund in Section 7 of the bill for the Commission to hire two full-time equivalent (2.0 FTE) permanent positions to prepare for comprehensive public financing in the 2028 elections. The Commission has not had an increase in personnel for the past 29 years despite the number of candidate committees and noncandidate committees having almost doubled in size. Currently, there are only 5 staff members who oversee 700+ committees that have anywhere from 1-3 officers who require assistance on how to comply with the various requirements of campaign finance law thereby generating hundreds of staff hours assisting committees over the phone, in-person, and by email as well as a number of enforcement actions for violations. Under HRS §11-314(7), one of the Commission's 14 duties is to investigate and hold hearings for receiving evidence of any campaign finance violations. The Commission has no investigator on staff and has had to rely on contracts for investigative services with outside

agencies.³ In comparison to other State and county good government agencies with compliance and enforcement duties, the Commission has had a modest budget and nominal staff despite a tremendous growth in committees, an expansion in its duties and responsibilities, and enforcement mandates. The Commission respectfully seeks your support so that the Commission may ensure that the integrity and transparency of the campaign finance process is upheld. The Commission requests that these two positions be permanent rather than temporary.⁴

In summary, the balance in the Hawaii Election Campaign Fund is \$2,199,230.60 as of December 31, 2024. Obviously, this amount is insufficient to pay for the comprehensive public funding program, including the additional personnel the Commission will need, and thus, the total appropriation of \$30,200,000 in Section 6 of the bill is necessary.

Respectfully, the Commission requests that this committee address these concerns because there is insufficient funds and personnel to implement a program of this magnitude if it is going to pass this measure.

TESTIMONY

Beppie Shapiro, Legislative Committee, League of Women Voters of Hawaii

Chair Dela Cruz, Vice Chair Moriwaki, and Committee Members: The League of Women Voters of Hawaii thanks the Committee Chairs and members for hearing this valuable and popular bill.

The League of Women Voters of Hawaii strongly supports SB51 SD1 which: Establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State, to begin with the 2028 general election year; Requires the Campaign Spending Commission to submit a progress and final report to the Legislature; and appropriates funds. We also offer comments.

The League of Women Voters of the United States believes that methods of financing political campaigns should enhance political equality for all citizens; protect representative democracy from being distorted by big spending in election campaigns; ensure the public's right to know who is using money to influence elections; enable candidates to compete equitably for public office; ensure that candidates have sufficient funds to communicate their messages to the public; and combat corruption and undue influence in government.

Delegates and voters in the 1978 Constitutional Convention in Hawaii realized the importance of this concept, resulting in the creation of the Hawaii Election Campaign Fund and Hawaii's partial public funding option. Below is a quote from the Convention during the discussion of the HECF: " . . . if we think these tremendous sums being spent [on elections], these tremendous sums being contributed, are not sums for which we are going to ultimately pay because of poor government . . . and because of undue influence . . .we are fooling ourselves." Delegate Naomi Campbell during the 1978 Constitutional Convention.

Public financing of campaigns for political office is an investment in good governance, like budgeting for the Office of Elections or the Campaign Spending Commission or the Legislature itself. (See the recommendations of the Commission to Improve Standards of Conduct). Public Financing can return the value invested in it by increasing the extent to which elected officials work for the benefit of all state residents, rather than wealthy businesses or individuals; increasing voter confidence in government; and encouraging more citizen participation in elections and communication with their representatives.

The cost of this investment in good governance would not be a major portion of the state budget. The writers of this bill, as well as the Campaign Spending Commission (CSC, testimony on SB51) calculate that to pay for the comprehensive public funding program, even including personnel the CSC would need for implementation, would require an appropriation of \$30,200,000.

It is also probable that legislative spending and state contracts would be more effective and efficient when directed by the needs and values of the population, rather than being swayed by financial relationships with special interests.

Dear Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Committee,

HAPA is submitting testimony in STRONG Support of SB51, which establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State.

It's crucially important that the legislature does everything in its power to remove the influence money has on politics. Candidates work for donations that create relationships that can cause corruption or the perception of it. Money is crucial to winning, for example, 91% of candidates who outspend their opponent go on to win. Many elections are uncontested because potential candidates can't afford the high price tag. Furthermore, the average house winner spends \$40,000 compared to only \$16,000 for the loser.

Publicly financed elections will allow candidates to get support from their constituents rather than wealthy donors. As a result, elections will become more competitive with a more diverse set of candidates. Legislators will be free to act on behalf of voters without being concerned about what their donors think. Candidates will also be able to spend more time with constituents rather than fundraising. Furthermore, a system of fully publicly financed elections is overwhelmingly supported by Hawai'i voters.

Publicly funded elections are already being successfully implemented locally and in other jurisdictions. Hawai'i Island County Council races had this program in 2010 and 2012. Connecticut and Maine have clean elections statewide which are both very popular and successful. Over 70% of Democratic legislators use this program in Maine. Connecticut's program was established to get money out of politics following large corruption scandals.

SB 51 would provide participating candidates with competitive amounts of funding they need to run an effective campaign, and would ban them from receiving any private donations at all. This system worked very well for Hawai'i County Council races in 2010 and 2012, and currently works very well statewide in places like Connecticut and Maine.

Winning publicly financed elections is the single biggest thing we could do to end pay-to-play corruption in our politics and start building a Hawai'i that puts Hawai'is land and people first — not big money interests.


Chair Dela Cruz, Vice Chair Moriwaki, and all Committee members,

Mahalo for the opportunity to testify before you today. On behalf of Our Hawai'i's over 38,000 members and supporters across the pae 'āina, I write in strong support for Senate Bill SB51, relating to public financing of candidates to elected office. Our members and supporters are local people — kama'āina and kānaka maoli, keiki and kūpuna, from Kaua'i to Kohala, Kailua to Kapolei and every place in between. They have joined our movement to fight for a Hawai'i that puts local people — not big money interests — first, because they are deeply worried about the direction of our islands and believe now is the time for change.

Our supporters are not alone. The crisis of public trust in government has reached a tipping point. After years of the FBI putting our officials in handcuffs, resignations, and scandals, Hawai i voters as a whole in the 2022 election ranked government corruption as their number 3 top issue, only behind inflation and affordable housing, in a survey conducted on behalf of Our Hawai'i by the most accurate polling firm in US elections in 2020.

The incomplete reforms adopted by the legislature in 2023, while important, did not go far enough on a policy matter or in terms of shifting public perception. Polling conducted in 2024 by the Clean Elections Hawai'i Coalition, consisting of over 3-dozen local organizations, showed that two out of three voters (66%) believe that "elected officials care more about wealthy donors than the needs of my community." Ouch. 9 out of 10 voters also believe that influence or obligate legislators to some degree, with over half of voters believing that degree is "greatly."

Two Out of Three Voters Say Elected Officials Care More About Wealthy Donors Than Needs of Communities








This poll was conducted in March 2024, right before an April 17th bombshell exposé dropped on the front page of the New York Times, exposing to the world the deep culture of pay-to-play corruption that has existed at high levels of Hawai'i political leadership. The exposé specifically called out the loophole in our campaign finance laws which this legislation and other similar bills introduced this session seek to close. With the article being released towards the end of last legislative session, reform-minded lawmakers did not have time to act, but now you do.

"Great" Concern Over Money In Politics and Private Campaign Spending for Majorities



Luckily, a solution is on the table for you to solve this problem. The same voters, across race, ethnicity, income level, and political party, overwhelming support a Clean Elections program when it is described to them in plain terms, with 68% of voters saying they would support passing a law to create a Clean Elections program in Hawai'i. And they are 4 times more likely to support than oppose a candidate for office who backs and champions such a program as well.

With public trust at an all time low, now is the time for systemic and transformative solutions. While progress has been made, it is not enough. We need to address the overriding issue of money in our politics where it begins, in our elections.

SB51 would go as far as is legally possible under the United States constitution, by providing a viable alternative to the status quo private money campaign system. It would level the playing field for candidates who are not wealthy or well-connected, and take a historic step towards getting big money out of our elections.

No longer would legislators have to look over their shoulders, worried about how their donors who will fund their next campaign might react to each and every vote. **Legislators can be fully focused on delivering for their constituents, not campaign donors.** That's how democracy is supposed to work!

We know that programs like this work, and are cost-effective: we've seen it in places like Connecticut, Maine, Hawai'i County and cities all around the US. Even if Hawai'i saw higher participation rates than any other State, estimates show the cost would be less than \$10 million per year—just 0.05% of the state budget. That's just over \$6 per resident or less than \$1 per tourist—a small price to pay for a more transparent, accountable government, and an amount that a majority of those polled said they'd be willing to pay.

We have the policy. We have the public desire for change. We have the resources. The only question is do we have the political will? That will be up to you to make it so. As you deliberate, know the public is watching.

Mahalo nui loa for your courage and action. Laulima, we can move forward to a better future for our Hawai'i.

POLL: Two Out of Three Voters Say Elected Officials Care More About Wealthy Donors Than Needs of Communities, Want 'Clean Elections' as Solution

71% of voters support a Clean Elections program to publicly fund campaigns, with only 12% opposing.

9 in 10 say campaign contributions influence and obligate legislators, and 66% say elected officials care more about wealthy donors than communities.



HONOLULU, Hawai — More than 3 in 4 (78%) Hawai'i voters believe legislators are influenced and obligated by campaign contributions and have had their trust in government impacted by recent corruption scandals, 2 in 3 (66%) believe elected officials care more about "wealthy donors" than the "needs of their communities," and about the same amount (71%) support a "Clean Elections" publicly-financed elections program as a solution, according to a new poll conducted by SurveyUSA from February 27th - March 6th, 2024 and released by the Clean Elections Hawai'i Coalition. The survey interviewed 1,008 registered and likely voters across Hawai'i and found widespread and deep concern about money in politics and corruption in government, as well as broad and deep support for a "Clean Elections" program of public financing as a reform solution across ethnic and racial, gender, geographical, and political demographics.


"Clearly, the idea of Clean Elections is one with strong appeal to a very broad cross-section of Hawaii voters," said **Ken Alper, President of SurveyUSA** who conducted the poll. "Two thirds of voters say their representatives care more about their donors than they do about local communities – and not coincidentally, two thirds of voters support a Clean Elections program in Hawaii. This tackles a major issue for voters, and that's why you see such strong numbers in support of it."

Poll results show strong support for a "publicly-financed elections" program across all likely voters, across all major ethnic groups, and across political parties, with 3 out of 4 likely Democratic and Republican primary voters supporting the program, and voters being 4 times more likely to support (42%) than oppose (10%) a candidate for office who supports Clean Elections.


Strong Support for Clean Elections



3 in 4 Likely Primary Voters Support Clean Elections




Broad Support for Clean Elections Among all Groups




At the same time, results are alarming as it relates to current concern over money in politics, private campaign financing, and trust in elected officials and the government. A jaw-dropping half or more of all voters think that private campaign contributions are "greatly" influencing or obligating their legislators and are concerned about the financial transparency of candidates running for office, with 9 out of 10 likely voters sharing these concerns to some degree. 2 out 3 likely voters believe elected officials are more focused on wealthy donors than the needs of their community, and 3 out of 4 have had their trust in government shaken by recent corruption scandals.

"This survey should be a wakeup call for our elected officials — ordinary working people do not trust that you are working in our communities' interest." said **Sergio Alcubilla**, **Executive Director of the Hawai'i Workers Center and a spokesperson for the Clean Elections Hawai'i campaign.** "Last year's marginal reforms have not moved the needle on public perception or trust in legislators. But a solution is on the table and ready for legislators to win back the public trust and make meaningful reform to a system that many feel is rigged against them. It's time we put the best interests of the community first. The time for Clean Elections is now."

"Great" Concern Over Money In Politics and Private Campaign Spending for Majorities




Two Out of Three Voters Say Elected Officials Care More About Wealthy Donors Than Needs of Communities



Opponents of Clean Elections in Hawai'i have tried to point to its cost as a deterrent, and suggested that voters would not be willing to shoulder the burden. However, when asked directly about the cost per taxpayer of a Clean Elections program, 58% say the cost is reasonable while less than 1 in 4 believe it is unreasonable. [Maybe: Even when opposition framing which contains falsehoods about cost is shared about Clean Elections, voters still show net support for the program by double digits — 19 percentage points. Furthermore, voters seem enthusiastic about a variety of ways to pay for the program. Early this month, legislation for publicly financed elections described as the "last shot" for legislators to make reform before the elections passed the Hawai'i Senate and was transferred to the House of Representatives, where today it was scheduled for a hearing on Thursday, March 14th in the Judiciary and Hawaiian Affairs committee at 2pm in Capitol Conference Room 325. Members of the media and the public are encouraged to attend.

About SurveyUSA and the Polling Methodology: SurveyUSA is an independent, apolitical and non-partisan research organization that conducts custom, local opinion research for universities, non-profits, local and state governments and small to medium-sized businesses, ad agencies and public relations firms. Nate Silver's fivethirtyeight.com rates 517 polling firms on an ongoing basis, and no research company of any size scores as highly as SurveyUSA on four key metrics: SurveyUSA is in the 94th percentile for absence of partisan bias, the 98th percentile for accuracy, the 98th percentile for predictive value, and the 100th percentile for most prolific.

SurveyUSA interviewed 1,265 adult respondents from the entire state of Hawaii 02/27/24 through 03/06/24. Of the adults, 1,008 were identified by SurveyUSA as being registered to vote and were asked the substantive questions which follow. This research was conducted using a blended sample, mixed mode approach. 71% of registered voters were online panelists chosen randomly who were shown the survey questions on the display of their smartphone, laptop, or tablet. 29% of registered voters were texted on their cell phones by live operators who secured the cooperation of each respondent before linking them to an online survey. The pool of adult respondents was weighted to US Census targets for gender, age, ethnicity, education, and home ownership.

Strong Support in Aloha State for 'Clean Elections' Program to Publicly Fund Campaigns; Majority Says Projected Cost Would be Reasonable; ¾ Of Hawaii Voters Say Legislators Become Obligated to Campaign Donors; Deep Concerns About Financial Transparency of Candidates For Office:

Results of SurveyUSA research conducted exclusively for Clean Elections Hawaii show strong support across the state for a publicly funded system for political campaigns, with two-thirds of voters in favor of such a program as soon as the idea is broached.

68% of registered voters say they would support passing a law to create a Clean Elections program in Hawaii (38% strongly support, 30% somewhat support); only 11% are opposed. Support is no less than 60% among any demographic subgroup.

When asked if they would support or oppose a Clean Elections program if it did not result in new taxes, the percentage supporting increases 5 points, to 73% (41% strongly supporting, 32% somewhat supporting), with the largest increases in support seen among Japanese voters (18 points), Latinos (11 points), and Democrats (9 points).

58% of voters say the estimated \$6 per resident cost of the program is reasonable; just 1 in 4, 23%, say it is unreasonable.

42% of voters say they are more likely to vote for candidate who supports Clean Elections; 31% say it makes no difference in their vote. Only 1 in 10 voters say they would be less likely to vote for such a candidate; White voters and those with 4-year college degrees are the most likely to say they'd be more likely to vote for a candidate who supports Clean Elections; the youngest voters are the most likely to say they'd be less likely to support such a candidate.

⅔ of voters, 66%, agree with this statement: "My current elected officials are more focused on the interests of their wealthy donors than on the needs of my community." 33% strongly agree; 33% somewhat agree. 22% disagree (16% somewhat, 6% strongly). 84% of Republicans agree, compared to 57% of Democrats.

¾ of registered voters, 78%, agree with this statement: "Recent public corruption scandals have negatively impacted my trust in our state government." 47% strongly agree, 31% somewhat agree; only 15% disagree. Agreement is at or above 72% among every demographic subgroup.

A 51% majority say campaign contributions greatly influence the policies supported by legislators; another 27% say contributions have a moderate impact – 78% in all. 11% say they have a slight influence, 3% no influence at all. Voters age 50 to 64 are the most likely to say contributions have at least a moderate influence; those aged 18 to 34 are the least likely.

78% also say legislators become obligated to those who donate money to their campaigns, with 53% saying they become greatly obligated, 25% moderately obligated. 10% say they are only slightly obligated, 3% not at all. No fewer than 70% of voters in any demographic subgroup say legislators become obligated.

By more than 2:1, voters say limiting the size and number of campaign contributions helps to prevent corruption in politics, with 54% feeling that way; 23% say these limits have no impact on corruption. Democrats are more likely to say limits help prevent corruption; Republicans and independents are less likely to say so.

69% are moderately (28%) or greatly (41%) concerned that businesses may not wish to expand in Hawaii if it has a reputation for a lack of ethical conduct, a lack of campaign transparency, or a "pay-to-play" reputation. 12% are just slightly concerned; 7% are not concerned at all. Concern increases with age, from 60% of 18 to 34-year-olds being moderately or greatly concerned, to 69% of 35 to 49-year-olds, to 73% of those age 50+.

79% are concerned (29% moderately, 50% greatly) about the financial transparency of candidates for office; 10% are slightly concerned, 3% not concerned at all. No fewer than 70% of voters in any demographic subgroup are concerned.

This isn't fiscal responsibility; it's a blank check for campaigns, and the \$30 million minimum fund requirement (Section 11-O) proves it's a luxury we can't afford.

2. Stifling Free Speech and Competition

By banning private contributions for participating candidates (Section 11-I), this bill silences the voices of citizens who want to support their chosen leaders with their own money. Democrats, you've championed free expression—why back a system that muzzles grassroots donors while handing bureaucrats control over who gets funded? The free market of ideas thrives on competition, not government handouts. This bill rigs the game, favoring establishment insiders who can navigate its red tape over scrappy outsiders who rely on real voter enthusiasm.

3. A Bureaucratic Nightmare

The complex web of rules—qualifying contributions (Section 11-F), seed money caps (Section 11-E), and endless reporting (Section 11-J)—creates a playground for unelected officials at the Campaign Spending Commission to meddle in elections. Republicans distrust big government overreach, but Democrats should too when it risks corruption or favoritism. With \$5 contributions determining eligibility (e.g., 6,250 for governor), this system invites fraud and

manipulation, undermining the "clean elections" it claims to champion. Do we really trust a commission to fairly dole out millions without bias?

4. Punishing Candidates and Voters, Not Special Interests

The bill claims to curb special interests, but it punishes candidates who opt out by leaving them to face publicly funded opponents with no private backing (Section 11-I). Voters lose too—limited to candidates who play by these rules, not those who reflect their true priorities. Democrats, you've pushed for choice and diversity in politics—why shrink the field with a one-size-fits-all funding scheme? Special interests will still find loopholes; only honest candidates and their supporters get shackled.

5. An Unproven Experiment with Proven Failures

Citing Maine and Arizona (page 2), the bill ignores the mixed results of public funding elsewhere—low participation rates, uneven benefits, and no clear reduction in influence peddling. Hawaii's own pilot spent \$363,060 on just 16 candidates with little evidence of transformative change (page 3). Republicans demand results, not theories, and Democrats should too when taxpayer money is at stake. Why gamble on a system that's more about optics than outcomes?

Conclusion: Vote No for Freedom and Fairness

S.B. No. 51 isn't about restoring trust—it's about consolidating power in a government-run election machine that wastes money, restricts liberty, and fails to deliver. Republicans see it as an attack on free markets and personal choice; Democrats should see it as a betrayal of working families and democratic diversity. I urge you to reject this bill and protect Hawaii's elections from this costly, ill-conceived experiment. **VOTE NO**.

Chair Dela Cruz, Vice Chair Moriwaki, and Committee Members:

I <u>support</u> this bill, which establishes a comprehensive system of public financing for all candidates seeking election to state and county public offices in the State of Hawaii, to begin with the 2028 general election year.

I served on the 2022 State Commission to Improve Standards of Conduct; having a robust public financing of elections program in Hawaii was one of our top priorities, if not the very top priority. Yet three years later the promise of "Improved Standards of Conduct" remains unfulfilled because this foundational recommendation has not been a State priority. While there is no guarantee that improvements in Hawaii's public financing program would prevent public corruption, no reasonable person would deny it would help.

Legitimate concerns have surfaced about this proposed program. The Department of Budget and Finance has previously testified that they do not support the measure because it is difficult to determine whether the program would be self-sustaining. Under the bill, the Hawaii election campaign fund could draw revenue from five sources. True, it is likely the fund will continue to rely on appropriations from the legislature, but if this program reflects the will of the people so be it. Annual reports to the legislature from the Campaign Spending Commission are required, and Section 11-0 of the bill requires a check on the sufficiency of funds available for the next election period, which mitigates running out of funds during the campaign period.

The Honolulu Elections Division has also objected to the bill's requirement that County Clerks assist in verifying donor qualifications as required under the bill. The language of the measure could be changed to specifically allow the Campaign Spending Commission (CSC) access to the State's voter registration system, to permit the CSC to do this verification.

Please appropriate \$30 million for this bill so that a tradition of public service by elected officials can be further separated from the task of raising money from private donors with special interests.

Aloha Mai Kākou, Honorable Members of the Senate,

My name is Tiare Smith, a Native Hawaiian born and raised in Kahalu'u, O'ahu, where I have resided for 45 years. As a kama'āina deeply rooted in this community, I speak not only from personal conviction but also from a profound concern for the democratic integrity of our islands. I stand in firm opposition to SB51, a bill that proposes a comprehensive public financing system for candidates to state and county offices beginning in 2028. While its stated intent—to mitigate the influence of wealthy donors and bolster public confidence in elections—may appear laudable, a closer examination reveals it to be a flawed, impractical, and ultimately disenfranchising measure that undermines the very principles it purports to uphold.

First, SB51 precipitously shifts the burden of electoral funding from voluntary private contributions to a mandatory public dole, siphoning resources from Hawaii's already strained fiscal coffers. The bill predicates its feasibility on a minimum of \$30,000,000 in the Hawaii Election Campaign Fund subaccount, yet it offers no credible mechanism to ensure this threshold is sustainably met. Hawaii's state budget, hovering in the billions, faces perennial demands—housing, education, healthcare, and cultural preservation among them—that far outweigh the speculative benefits of this program. To divert such sums toward a system modeled on Maine's Clean Election Act, a state with a markedly different socio-economic fabric, is to gamble recklessly with taxpayer resources. The legislature's own acknowledgment that costs are "dwarfed" by the budget belies the reality: every dollar allocated here is a dollar denied to pressing needs that directly serve our people.

Second, the bill's structure is antithetical to equitable representation, particularly for grassroots candidates like those from Native Hawaiian and rural communities such as Kahalu'u. The requirement of collecting hundreds—or, in the case of gubernatorial candidates, thousands—of \$5 qualifying contributions imposes a logistical gauntlet that disproportionately burdens those without established networks or urban access. Far from leveling the playing field, SB51 erects a new barrier, one that privileges candidates with pre-existing organizational capacity over those who rely on organic community support. This is not democratization; it is a subtle form of exclusion masquerading as reform. For a state that prides itself on aloha and inclusivity, such a measure risks further alienating voices already marginalized by systemic inequities.

Third, the bill's restrictive covenants—barring certified candidates from accepting private funds not only during campaigns but throughout their terms in office—stifle political agency and innovation. Elected officials, bound by these shackles, would be unable to adapt to unforeseen exigencies or engage in the robust discourse that private support can facilitate. This rigidity contrasts sharply with the flexibility inherent in Hawaii's existing partial public funding system, established in 1978, which balances public interest with practical governance. SB51's absolutism threatens to ossify our electoral process, rendering it less responsive to the dynamic needs of our communities.

Finally, the promise of restored public confidence is illusory. The legislature cites Arizona, Maine, and Connecticut as exemplars, yet evidence from these jurisdictions reveals mixed outcomes at best—participation rates remain uneven, and public trust has not risen commensurately with expenditures. In Hawaii, where familial and cultural ties often shape political allegiance more than financial influence, SB51 misdiagnoses the root of voter skepticism. Rather than addressing transparency or accountability directly, it imposes a costly bureaucratic overlay that may deepen cynicism rather than alleviate it.

As a Native Hawaiian resident who has witnessed O'ahu's evolution over four and a half decades, I urge you to reject SB51. It is not a solution but a distraction—a well-intentioned but ill-conceived experiment that risks disenfranchising the very constituents it aims to empower. Let us instead refine the systems we have, rooted in our unique island values, rather than import untested frameworks that erode our sovereignty and resilience. Mahalo nui loa for your consideration.
