I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SB 522, which authorizes the issuance of general obligation bonds to the Agribusiness Development Corporation (ADC) for the purchase of the Halaula Agricultural Parcel for agricultural development. While we support the intent of this measure to expand agricultural opportunities for ADC, we encourage ADC to broaden its scope to consider potential land acquisitions in both Maui County and Hawai'i Island and to ensure that adequate water resources are available before purchasing any land for agricultural development.

The agricultural industry established the Agribusiness Development Corporation as sugar and pineapple downsized. It was created to help transition Hawai'i's agricultural industry from plantation agriculture to smaller, diversified agricultural operations. Over the past decade, ADC has made significant progress in transitioning Hawai'i's agricultural sector by managing key state agricultural lands, developing irrigation systems, and supporting diversified agriculture on Oahu and Kauai. 

Aloha Chairs Gabbard and DeCoite, Vice-Chairs Richards and Wakai, and members of the Senate Committees on Agriculture and Environments, and Economic Development and Tourism,

The North Kohala Community Development Plan Advisory Group oversees implementation of the 2008 NK-CDP and is in strong support of Senate Bill 522 that authorizes funds to the Agribusiness Development Corporation (ADC) for the purchase of the 50-acre Halaula Agricultural Parcel to promote local agricultural development.

Kohala has a perfect combination of mature soil and relatively abundant water, leading to a long history of successful agriculture. The North Kohala Community Development Plan established a goal of producing locally 50% of the food consumed. Nearly two decades later, this objective remains unmet while Hawaii imports 80-90% of its food. Land is expensive in Kohala and, although 85% is zoned Ag-20, much has gone into the hands of affluent non-farmers, and more remains in danger of being lost to outside developers. All of this while many prospective farmers cannot afford suitable land at the present costs.

This situation underscores the urgent need for strategic investment in our community's agricultural infrastructure to make land available to those wishing to grow food. A lack of available and stable farm leases and licenses has prevented the community from realizing its food production potential. The ADC has a demonstrated record of success in fostering agricultural development in other regions of the state, and we believe their involvement in this project provides an significant step toward achieving our local food security goals.

The purchase of the Halaula Agricultural Parcel by ADC has the potential to open opportunities for Kohala's farmers and increase local food production, a longtime priority of our community that is clearly stated as such throughout the North Kohala Community Development Plan. The Halaula Agricultural Parcel is advantageous for agricultural development because it is relatively flat with fertile soil. It has a plantation era well that could be reactivated, and a highly skilled agricultural workforce that needs land and lives within 10 minutes of the parcel.

SB522 promotes Kohala's future by providing increased agricultural development and employment opportunities as well as local food for our families.

Aloha, Chair DeCoite, Vice Chair Wakai, Chair Gabbard, Vice Chair Richards, and Members of the Senate Committees on Economic Development and Tourism, and Agriculture and Environment

Hawai'i Food+ Policy **submits cautious support for SB522**, which authorizes the issuance of general obligation bonds to the Agribusiness Development Corporation (ADC) to purchase the Halaula Agricultural Parcel in North Kohala for agricultural development. While the goal of expanding agricultural lands is commendable, we remain deeply concerned about ADC's track record in effectively managing lands and ensuring that they benefit local and Native Hawaiian farmers.

Land access in Hawai'i is already a significant issue, with many small-scale and Native Hawaiian farmers struggling to secure affordable agricultural land. The acquisition of the Halaula Agricultural Parcel presents a promising opportunity to bolster local food production, increase food security, and provide economic benefits to rural communities. However, ADC's history of poor transparency and lack of strategic planning, as noted in the <a href="Hawaiii State Auditor's 2021">Hawaiii State Auditor's 2021</a> report, raises concerns about whether this land will be effectively managed to serve Hawaiii's people and not just large agribusiness interests (Hawaiii State Auditor, 2021).

For this acquisition to truly support food self-sufficiency and local farmers, it is imperative that ADC is required to create and publicly release a clear and enforceable land use plan. This plan should prioritize local farmers and Native Hawaiian agricultural practitioners and establish a transparent leasing process that prevents the land from being used for non-food agriculture, such as biofuel production. We also strongly recommend the establishment of an oversight committee to monitor ADC's management of the land and ensure public accountability. Without these safeguards, there is a significant risk that this land acquisition will fail to meet its intended purpose.

Given the scarcity of agricultural land in Hawai'i, it is crucial that this investment is approached with caution and strategic planning. This is to avoid the mismanagement and inefficiencies that have historically plagued ADC. We strongly encourage the committee to include amendments

Aloha Chairs Gabbard and DeCoite, Vice-Chairs Richards and Wakai, and members of the Senate Committees on Agriculture and Environment and Economic Development and Tourism,

My name is Annalene Williams. I am a member of the Agriculture Subgroup of the North Kohala CDP, but I am submitting this testimony in support of SB522 as an individual, which proposes to enable the Agribusiness Development Corporation (ADC) to acquire a roughly 50-acre plot of land in Halaula, North Kohala, for agricultural development. The property features a decommissioned plantation-era well that can be reactivated to supply water for crops.

In 2008, the North Kohala Community Development Plan established a community goal of producing 50% of the food consumed locally. Nearly two decades later, this objective remains unmet. This highlights the need for investment in our community's agricultural infrastructure and capacity building. The ADC has a demonstrated record of success in fostering agricultural development in other regions of the state, and I believe their involvement in this project will be a positive step towards achieving our local food security goals.

Hawaii imports 80-90% of its food, making agricultural self-sufficiency critical. North Kohala, a rural and isolated community, needs a diversified economy beyond tourism. Re-establishing our historical agricultural roots, as evidenced by archaeological records, will enhance food security, create jobs, and build a more resilient community. It will also improve access to nutritious local produce.

Post-COVID-19, our Agriculture Group has been actively engaged with the community to address these critical issues. In 2023, we hosted two AgVision events, providing a platform for residents to share their input and ideas regarding the future of agriculture in North Kohala. The feedback gathered from these events was organized into seven key categories: water, land, production, food access, energy, farmer health and wellness, and farmer housing. We have since been holding monthly meetings to delve into the complexities of each of these areas. We recognize the interconnectedness of these challenges, understanding that progress in one area often depends on advancements in others. In 2024, our water group organized and hosted a Water Summit to educate the community about the complexities of water availability and the various departments involved in ensuring access to water in our region. This demonstrates our

commitment to a collaborative approach to agricultural development guided by community input.

Acquiring the proposed land in Halaula represents a strategic step towards realizing the goals outlined in the North Kohala Community Development Plan and aligns with the priorities identified by our community.
