Statement of MARY ALICE EVANS, Director

in consideration of SB 740 RELATING TO SPECIAL PERMITS.

Chair Inouye, Vice Chair Elefante, and Members of the Senate Committee on Water and Land.

The Office of Planning and Sustainable Development (OPSD) offers **comments** on SB 740, which would authorize the Land Use Commission (LUC) to designate another agency, including but not limited to OPSD, to monitor compliance with any conditions imposed in a special permit approved by the LUC.

OPSD notes that the counties are responsible for enforcing conditions imposed by special permits approved by the LUC as well as special permits for land areas fifteen acres or less approved by the county land use authority. OPSD is not a regulatory body and has neither the authority nor the staff to monitor and enforce special permit restrictions imposed by the LUC.

OPSD would need additional manpower and travel funds to have the capacity to monitor compliance with terms and conditions of Special Permits (SP). At a minimum, one FTE Planner VI (\$80K) and travel funds (12 rt X \$500=\$6K) to inspect SP sites and to attend LUC hearings on the Neighbor Island's where more of the Special Permits are located – because the Neighbor Island counties have a larger proportion of their lands in the State Agricultural District and thus need to locate needed facilities in the Ag District.

Some of the compliance monitoring could be done as a desk audit by calling state and county agencies to inquire if conditions that the agencies requested the LUC to impose in granting the Special Permit were in fact carried out. However, the enforcement authority resides with the LUC, in Chapter 205-12. Enforcement, not OPSD or other state agencies named as in SB 740.

The LUC starts a compliance review with a Status Hearing which, while not a contested case hearing with rules of evidence, may lead to Order to Show Cause, which is a prelude to enforcement and therefore, the evidence collected and reported to the LUC must be verified.

An additional expense relating to designation of OPSD to monitor compliance of Special Permits may be assignment of an additional deputy AG to review motions and filings.

SUGGESTED TESTIMONY POINTS ON CREATING A DROP PROGRAM

Officer Retention

Our police department faces a staffing crisis. And month after month it is only getting worse.

Its harder to get days off, to take vacations. We're working more hours, longer days, sometimes without proper rest in between. The impact on us is taking its toll on our bodies and on our families.

DROP will keep more officers on the job longer. It's a fact. And we desperately need those officers. We all are hopeful that hiring and recruitment will pick up, but we can't wait for that to occur. We're losing officers today.

Investment
