Thank you for the opportunity to provide testimony in strong support of SB 865 SD1 HD1 relating to Agriculture that appropriates funds to establish a permanent Extension agent position within the University of Hawai'i (UH) College of Tropical Agriculture and Human Resilience's (CTAHR) Kona Cooperative Extension.

Coffee has emerged as an important cash crop for growers in Hawai'i. It has also become an important export commodity boosting Hawai'i's economy. CTAHR conducts research and provides research-based information to increase coffee production in the state and improve the economic viability of growers. Although coffee research plots exist at multiple CTAHR stations, CTAHR's Agricultural Research and Extension Station (CARES) in Kona currently has the sole Extension Agent engaged in applied research and outreach on coffee. By investing in this position, Hawaii's coffee sector can achieve:

- Increased productivity and sustainability.
- A steady supply of premium, high-quality coffee
- Continued economic contributions to the state's overall agricultural success.

For these reasons, we urge the House Finance Committee to support SB865 SD1 HD1 and ensure that funding for this critical extension associate position is included this year. I am writing on behalf of Kauai Coffee Company LLC. in full support of **SB865_HD1**. My name is Bronson B. Yadao. I am the Orchard Manager of a 3000-acre coffee plantation on the Westside of Kauai. As many of you know, Hawaii's coffee industry has been decimated by CBB (Coffee Berry Borer) and more recently CLR (Coffee Leaf Rust). Kaua'i was the last major growing region in the State (and world) to be infected by CBB and CLR. The discovery of both took place on our farm in 2020 and 2021 respectively.

Geographic isolation is a blessing in the sense that Hawaii's coffee industry was able to stave off both pests- decades, centuries after most of the prominent growing regions of the world. Now that the entire State has both major pests- geographic isolation is also a curse in the sense that industry experts predominantly reside thousands of miles away in Latin America, Africa, and Asia.

As it stands, UH CTAHR has a single extension agent with extensive coffee expertise residing in the Kona region of Hawaii island. Although she is very knowledgeable, capable and responsive-she is only a single professional- dealing with an ever-growing threat to the industry across the State.

I strongly support appropriating additional funding for much needed support for additional extension agent support to serve the State of Hawaii. The coffee industry in Hawaii has sustained many challenges within the past decade and several farms have already succumbed to the pest pressure- making their operations economically unviable. If Hawaii wants to continue to be a place of rich, thriving agricultural diversity- this position needs to be approved in 2025.

Waimea Coffee Farm LLC Specialty Coffee Producer



Testimony in Support of Bill 865 SB

Aloha Kākou,

My name is Dave Donald, and I am the owner of Waimea Coffee Farm LLC, a specialty coffee producer in Lalamilo Farm Lots in Kamuela, Hawai'i Island.

In 2016, I discovered an unusual-looking coffee shrub on my property. After some research, I learned that it was over 20 years old but only 2 feet tall. It turned out to be an experimental hybrid of Jamaican Blue Mountain and Guatemalan Arabica coffees, created by a University of Hawai'i Hilo professor. Out of 12 original plants, it was the sole survivor.

After six months of care, I nurtured it to 6 feet tall, and for the first time, it flowered and fruited. Wanting to learn how to harvest and process coffee, I turned to YouTube for basic guidance. Then, I sought advice from local cafés and coffee roasters in Kailua-Kona, who introduced me to Pacific Coffee Research (PCR), a Specialty Coffee Association (SCA)-certified lab in South Kona. I brought my green beans to PCR, where they inspected, graded, roasted, cupped, and scored them. **The result? A designation of Specialty Coffee.**

From some of those seeds, I grew 336 seedlings and planted them on my neighbor's farm in Lalamilo. Not knowing much about commercial coffee farming, I reached out to CTAHR, where I met Andrea Kawabata. Over the years, I attended multiple courses at the CTAHR Extension Office & Experimental Coffee Farm, receiving invaluable advice and recommendations. Topics ranged from managing Coffee Berry Borer (CBB), Black Twig Borer (BTB), green scale, black sooty mold, Coffee Leaf Rust (CLR), and root-knot nematodes to pruning, stumping, grafting, irrigation, soil amendments, and foliar micronutrient applications. I also learned about spray equipment calibration, protective gear, farm supply sources, coffee moisture meter calibration and so much more.

Without CTAHR and experts like Andrea Kawabata, it would have taken me **years** to compile this essential knowledge on my own.

Thanks to the guidance and support I received, I won First Place in the Hawai'i District at the 2021 Hawai'i State Coffee Cupping Competition.

In February 2023, I was one of three coffee farmers representing Hawai'i at Gulfood 2023 in Dubai, United Arab Emirates (UAE). My co-participants were a Kona coffee farmer offering 100% Gesha coffee for \$452 per pound wholesale and another selling 100% Kona Typica for \$35 per pound wholesale. When buyers asked what my 100% Waimea-grown coffee was selling for, I replied, "\$100 per pound or \$220 per kilogram." Their response? "How many TONS can I get?"

This experience highlights the growing global demand for **Hawai'i-grown specialty coffee**—but farmers like me **depend**on expert guidance from CTAHR to meet this demand.

Andrea Kawabata's work is **essential** to the success of Hawai'i Island coffee farmers. Her responsibilities are extensive and time-consuming. As a former teacher, I understand the immense effort required to develop and deliver effective courses. Yet, Andrea also manages the Extension's **greenhouses**, **experimental farms**, **countless on-site farm visits**, and provides **critical one-on-one support** to farmers across the island. She is one of the busiest state employees we have.

There are 1,200 coffee farms on Hawai'i Island. Andrea is being pulled in numerous directions, trying to juggle all of her responsibilities while visiting as many coffee farms as possible. She needs help to sustain this essential work.

To ensure that coffee farmers across Hāmākua, Hilo, Ka'ū, Kona, and Waimea continue to receive the support they need, Andrea Kawabata needs an assistant!

My name is Andrea Kawabata and I am a UH-CTAHR Extension Agent working with coffee statewide and the tropical fruit and macadamia nut industries in West Hawaii. I am submitting testimony as a private individual.

I write to you in **STRONG SUPPORT for SB865_HD1** which appropriates funds to establish a full-time, permanent Extension Agent position within the University of Hawai'i College of Tropical Agriculture and Human Resilience's Kona Research Station.

HDOA currently ranks **coffee as the #3 most valuable agricultural commodity in Hawaii**. And yet, extension support for this important industry continues to shrink. Historically and prior to the arrival of the Coffee Berry Borer and Coffee Leaf Rust to Hawaii, the state's coffee industry was supported by two full-time Extension agents, one Extension specialist, one researcher, and six research station technicians - all permanent positions. Today, my position is the only Extension position dedicated to coffee and Kona Research Station's two research technicians divide their time between the Kona and Mealani Research Stations and other non-coffee projects. Any and all coffee and orchard crops Extension program staff are temporarily and 100% funded through grants.

The macadamia nut industry is ranked as Hawaii's #7 most valuable ag commodity and the tropical fruit industry continues to grow. While there was one Extension specialist and one Extension agent dedicated to macadamia and cacao island-wide, and tropical fruit in East Hawaii, this husband and wife team left in 2020 and these full-time, permanent positions have not since been filled. And so, these crops fell back to my program.

60% of the state's orchard crops farms (3,370+) are located in Hawaii County. Further, there are over 1,110 coffee farms on 9,400+ acres throughout the state. This number of farms expected to be served by ONE extension agent is unprecedented and unrealistic. In comparison, FIVE agents statewide serve 866 floriculture, ornamentals, nursery, mushroom, sod, and greenhouse-grown crops farms.

These numbers tell a story that my Extension program is spread too thin and that the coffee and orchard crops industries **are highly underserved.**

In closing, the Extension Agent position described in SB865_HD1 will support Hawaii's top agricultural commodities and provide them with greater opportunities to combat pests and diseases and increase their farm and business' resilience and sustainability. With this position, we hope to mirror other UH-CTAHR Extension programs by **building capacity to better support the coffee, macadamia, and tropical fruit industries one valuable Extension Agent at a time**.

I humbly ask that you support SB865_HD1 by approving and funding the position in 2025. Thank you!

Testimony in Support of SB865-HD1 Relating to Agriculture

Chairperson and Members of the Committee,

My name is SongYi Paik, and I strongly support SB865, which seeks to establish a permanent extension agent position within the University of Hawai'i College of Tropical Agriculture and Human Resources' (CTAHR) Kona Cooperative Extension. This position is essential to strengthening research, outreach, and farmer education efforts to address the critical challenges facing Hawaii's coffee industry and other orchard crops.

Hawai'i's coffee industry is one of the state's most valuable agricultural commodity. However, coffee growers continue to face significant threats, particularly from two devastating pests:

- Coffee Berry Borer (CBB): First detected in Kona in 2010, CBB has since spread to
 multiple islands, reaching Lāna'i in 2020. CBB infestations can cause severe yield losses,
 particularly when harvests are delayed (Barrera, 2008)¹. Effective management requires
 continuous farmer education, research, and outreach to ensure the adoption of best
 practices.
- 2. Coffee Leaf Rust (CLR): First detected in Hawaii in 2020, CLR has now spread to Maui, Hawai'i Island, O'ahu, and Lāna'i. CLR leads to premature leaf drop, weakening plants and significantly reducing coffee cherry production. Further research is urgently needed to identify resistant coffee varieties, assess their viability for Hawaii's unique growing conditions, and educate farmers on effective management strategies.

Despite the industry's statewide presence, coffee growers are underserved due to geographic remoteness and the limited capacity of existing CTAHR personnel. Establishing a permanent extension agent position will provide much-needed assistance to extension faculty, enhance community outreach, and bolster research efforts aimed at mitigating CBB and CLR.

Supporting other orchard crop industries is just as important as supporting the coffee industry. Macadamia, banana, papaya, and other tropical fruits are vital to farm production and local food consumption. However, the Kona Cooperative Extension currently houses only one permanent extension agent for those crops, even though various crops and the number of farms cannot be adequately covered by a single professional. The second extension agent position will address industry challenges more broadly, covering different aspects through collaboration with the existing extension agent.

This new position is not just an investment in research and education; it is an investment in the sustainability of Hawai'i's coffee industry. I respectfully urge the committee to support SB865-HD1 and ensure that coffee and tropical fruit growers across the state receive the assistance they need to protect their livelihoods and maintain the legacy of Hawai'i-grown crops.

This role would provide critical support to the coffee and orchard crops extension and applied research program.

Throughout my career, I've witnessed firsthand how essential timely, science-based guidance is for our coffee producers. Hawai'i's unique status as an island state adds layers of complexity to agricultural management, particularly when it comes to accessing and implementing pest management tools. The need for strong, locally grounded extension services has only grown more urgent in recent years.

Coffee farmers in Hawai'i are facing extraordinary challenges, especially from coffee berry borer (CBB) since 2010 and coffee leaf rust (CLR) since 2020—two of the most damaging pests affecting coffee globally. Managing these pests here requires not only sophisticated, seasonally timed strategies but also a working knowledge of one of the strictest regulatory environments for agricultural inputs in the country. Navigating that landscape successfully takes expertise, relationships, and consistency—things that are hard to maintain without enough boots on the ground.

While the current extension team works incredibly hard, the scope of these challenges is immense. One more dedicated team member would significantly increase their capacity to respond to farmer needs in real time, while also supporting broader efforts in research, outreach, and regulatory advocacy.

Chair Yamashita, Vice Chair Takenouchi, and committee members, my name is Jensen Uyeda. I am submitting testimony as an individual in support of bill SB865, which would appropriate funds to establish a permanent Extension Agent position for CTAHR's Kona Cooperative Extension. I currently serve as a CTAHR Extension Agent on Oahu, working with edible crops, and I understand Cooperative Extension's vital role in our communities.

Cooperative Extension plays a crucial role in sharing science-based information through non-traditional educational programs for the agricultural community. The Kona extension programs serve the coffee industry on Hawaii Island and across the state. This industry ranks among the highest-grossing agricultural sectors, generating over \$48 million. In recent years, it has faced significant production challenges, notably from coffee berry borer (CBB) and coffee leaf rust (CLR), which may lower yields and raise production costs. The education programs offered by the Kona Extension have been essential for growers' success in addressing these obstacles. However, the program's capacity is limited, featuring only one extension agent and a temporary grant-funded educational support associate. Securing funding for a permanent position would enhance the extension program's capability to prioritize research and educational initiatives statewide. Moreover, it would bolster the program's capacity to manage the Kona research station, where much of the research focuses on developing strategies to counteract the issues caused by CBB and CLR.

Testimony in Support of SB865_HD1 - CTAHR Extension Agent Position

Chair Luke and Members of the House Committee on Finance:

My name is Dr. Taya Brown. I am a postdoctoral researcher with an extensive background in coffee farming systems around the world, currently supporting Hawaii's coffee industry. I am writing in strong support of SB865_HD1, which would establish a permanent, full-time Extension Agent position within UH-CTAHR's Kona Cooperative Extension to support the coffee and orchard crops extension and applied research program at the Kona Research Station. I urge the committee to fund this essential position this year.

As a postdoctoral researcher working directly with Hawaii's coffee industry, I can attest to the urgent need for additional extension support. Coffee stands as Hawaii's third most valuable agricultural commodity, while macadamia nuts rank seventh. Together with our expanding tropical fruit industries, these crops represent not just significant economic value, but also form the foundation of Hawaii's agricultural identity and heritage. The reach of this position would extend far beyond coffee, providing vital support to multiple orchard crop industries throughout the state.

Our current extension staff, who are extremely dedicated and hardworking, are overwhelmed by the scope and complexity of challenges facing these industries, as are the producers navigating these issues in the fields and markets:

- Coffee Berry Borer (CBB) has been in Hawaii since 2010 and Coffee Leaf Rust (CLR) since 2020. These are by far the two most antagonistic pests in coffee, globally and throughout history. Now, having finally reached Hawaii, these two immense pressures pose ongoing threats that require intensive, year-round management strategies that must fit well within Hawaii's strict regulatory framework
- Hawaii's unique island ecosystem necessitates exceptionally rigorous controls on both chemical and biological control products, creating complex challenges for making the needed tools available to farmers. The best tools for these pests are in use globally and need to be implemented in Hawaii to maintain production and high cup-quality of Hawaii's coffees to maintain competitiveness on the global market. Currently effective tools: chemical and biological products that effectively combat these pests without causing environmental harm or reducing farm profitability, CLR-resistant coffee varieties (a massive consideration for farmers who need help navigating decisions to implement, and how to implement), cultural field management methods to keep pressures from CBB and CLR as low as possible season-to-season (infected coffee cherry and leaves left in un-picked and un-managed fields become a reservoir for fungal and insect pests, impacting neighboring farms and increasing the pest populations for future years). All of these demand dedicated expertise to navigate at the policy and regulatory level, research to identify the best methods for Hawaii and its varied growing regions, and sustained connection with farmers navigating the issues and trialing methods and tools.
- The scale of our orchard crop industries requires additional extension capacity to maintain consistent contact with farmers and provide timely technical guidance. With current pest pressures and changing rain patterns, amidst unprecedentedly rising costs of

products and services needed to maintain, these industries need help. Hawaii's coffee industry value: \$62.7 million (HDOA, 2024); papaya industry value: \$6.5 million (HDOA, 2023); Mac nut industry value: \$62.7 million (Hawaii Grown, 2022) - this is just monetary value, which is beyond substantial, and doesn't even take into account the cultural value or tourism value driven by interest in these crops.

• Managing multiple high-value crops demands coordinated support across industries to maximize effectiveness and ensure sustainable production and even the literal existence of these industries to any scale whatsoever in this state

A second Extension Agent would significantly enhance our capacity to:

- Provide more frequent and comprehensive on-farm support to understand and address specific grower needs
- Develop and implement pest management strategies tailored to Hawaii's unique conditions
- Coordinate vital research across coffee, macadamia, and tropical fruit industries
- Bridge the gap between regulatory requirements and practical field implementation
- Support farmers in adopting new technologies and best practices for improved productivity

The current strain on our extension resources risks the long-term sustainability of these crucial agricultural and vastly important CULTURAL sectors. Hawaii is the seat for many of these crops in the entirety of the United States - Hawaii is where they are grown and growing these crops here keeps us competitive on the world stage. The position in question represents a critical opportunity to strengthen support for Hawaii's valuable orchard crop industries.

I strongly urge the committee to fund this position in the current fiscal year. This investment is essential for maintaining and (hopefuly) growing these vital agricultural sectors that contribute significantly to our state's economic stability, agricultural diversity, and cultural heritage. In my position have had the pleasure to interact directly coffee farmers on almost all coffee producing islands, and extensively across Hawaii Island where the highest concentration of coffee farmers resides. Just yesterday I met with one of the largest producers of coffee in the Kau region, who was in tears for most of our discussion because of the level of challenge they are up against and the looming decisions that will have to be made given the myriad "perfect storm" of market and natural pressures. They told me they will not be in business in a year without help.

With the new pressures on coffee, amidst a world of tariffs and other issues causing instability in the coffee industry as a whole, coffee will become obsolete in Hawaii if it does not receive support in all the forms mentioned in this letter.

Thank you for the opportunity to submit testimony on this important measure. Thank you so very much for hearing us and doing your part to support our sate's legacy.

Chair Luke and Members of the House Committee on Finance:

I am writing in strong support of SB865_HD1 to establish a permanent, full-time Extension Agent position within UH-CTAHR's Kona Cooperative Extension. As an agricultural product sales representative from Simplot and a long-time member of the Big Island community since 1999, I have a unique perspective on the critical need for additional extension support across our orchard crop industries, which I am happy to share with you today.

In my role serving Hawaii Island's diverse farming communities, I provided \$4.6 million worth of agricultural products and materials in 2024 alone, all directly supporting the viability and profitability of these vital industries. More importantly, I work closely with the individuals and families who comprise these industries - these are not just statistics, but real people facing real challenges.

The current challenges our farmers face include:

- Reliance on outdated research data from other regions of the world that may not apply to Hawaii's unique growing conditions and environmental protections, or to our cultural norms
- Limited access to timely diagnostics and assessments when new pests or diseases emerge, leaving farmers lacking the necessary information with which to make difficult decisions about management
- Difficulty in navigating complex decisions about appropriate agricultural inputs and management strategies and their ramifications and impacts, economically, culturally, and environmentally
- Insufficient technical support for implementing new technologies and best practices, both
 to keep in pace with other parts of the world, and to address newly emerging pressures
 like CBB and CLR in coffee
- Lack of availability of products and materials which are available to farmers in other parts of the world, and long delays in their arrival to Hawaii

In my daily work across multiple sectors - coffee, macadamia nut, papaya, avocado, lychee, rambutan, breadfruit, cacao, and other tropical fruits - I rely heavily on research and expertise from USDA and UH to provide accurate, actionable information to farmers. I've personally witnessed the dramatic difference between having sufficient versus insufficient information when helping farmers navigate critical decisions about their operations.

A dedicated Extension Agent would provide critical support by:

- Conducting Hawaii-specific research to develop locally-adapted solutions that respond to our unique combination of natural environment and cultural landscape
- Offering rapid diagnostic services and management recommendations that keep pace with emerging issues from pests, markets, and other pressures
- Providing evidence-based guidance on agricultural input selection and implementation
- Facilitating knowledge transfer between farmers, industry professionals, research institutions, and product sales outfits like Simplot

As someone who knows these farmers personally and understands their struggles, I can attest that the economic impact of having - or not having - current, locally-relevant information is beyond substantial. Our macadamia nut industry alone, valued at approximately \$50 million annually, requires dedicated support to maintain its competitive edge. Similarly, our coffee industry, as Hawaii's third most valuable agricultural commodity, and the main coffee-producing region of the entire United States, faces unprecedented challenges that demand immediate attention and expertise.

The current gap in extension support often leads to delayed responses and significant economic losses for our farming communities. This has impacts well beyond just these farms and farmers, affecting the tourism they drive to the state and the Big Island, and the families who depend on these industries for their livelihoods.

I strongly urge the committee to fund this position in the current fiscal year. This investment will directly support not just the sustainability and growth of Hawaii's agricultural sector, but the human beings and families who comprise these industries. As someone who has served this community for over 25 years, I can assure you that this support is crucial for the future of both our agricultural industries and the people who make them possible.
