Chair Dela Cruz, Vice Chair Moriwaki, and Members of the Committee:

Thank you for the opportunity to provide testimony in support of the intent of SB 865 SD1 relating to Agriculture that appropriates funds to establish a permanent Educational Support Associate position within the University of Hawai'i (UH) College of Tropical Agriculture and Human Resilience's (CTAHR) Kona Cooperative Extension.

Coffee has emerged as an important cash crop for growers in Hawai'i. It has also become an important export commodity boosting Hawaii's economy. CTAHR conducts research and provides research-based information to increase coffee production in the state and improve the economic viability of growers. Although coffee research plots exist at multiple CTAHR stations, CTAHR's Agricultural Research and Extension Station (CARES) in Kona currently has the sole Extension Agent engaged in applied research and outreach on coffee. Sustainability of coffee production is threatened by the Coffee Leaf Rust and Coffee Berry Borer and additional research and Extension capacity is needed to support the coffee industry throughout the state.

We strongly support the intent of this bill, and respectfully offer comments that it would be advantageous to have an Extension Agent position rather than an APT (Administrative, Professional and Technical) staff position that focuses on coffee, and other orchard crops with export potential such as macadamia nuts, cacao and tea to meet the needs of coffee and other orchard crops growers in the region and statewide.

We strongly support the intent of SB 865 SD1 with comments, provided that its passage does not replace or adversely impact priorities as indicated in our BOR Approved Budget.

#### Comments:

We, the Kau Coffee Growers Cooperative, are writing to advocate for the funding of SB865 for a full-time extension associate at the College of Tropical Agriculture and Human Resources (CTAHR) dedicated to the coffee and orchard crops industries in Hawai'i. According to the 2022 Census of Agriculture, Hawai'i is home to **1,111 coffee farms** covering a total acreage of **9,422 acres**. Coffee has consistently ranked among the top five commodities in the state and is currently ranked **3rd** compared to Macadamia Nut, which is ranked **7th**.

Despite the significant presence and economic importance of coffee farming in Hawai'i, the resources dedicated to this industry are disproportionately low compared to other agricultural sectors. Currently, there is only **one extension agent** assigned to the coffee and orchard crops industries, while floriculture and ornamentals have **five agents**, and livestock has **three agents**. This disparity highlights the urgent need for additional support to ensure the sustainability and growth of the coffee and orchard crops industries.

In spite of coffee being the third most important commodity in the state, historically, the resources allocated to the extension agents at CTAHR have been based on a "grant-funded basis." Grants are typically awarded for specific projects and come with strict guidelines, making the position of a dedicated coffee extension agent highly precarious. This practice has also led to these resources being redistributed to other universities and entities by a local grant Project Director.

Consequently, this reduces the ability of CTAHR to provide substantial and continuous outreach for coffee farmers. It is also worth noting that the sustainable and organic industries have a full-time, permanent extension support staff whose position was funded through regular budget allocations by the Ways and Means Committee. These allocations are more stable and flexible, ensuring continuous support. Given the current uncertainties with staff reductions being pursued by Federal Government of its agencies, we request that the resources in our State are protected by legislative action and that our extension services provided by CTAHR are insulated from unforeseen events.

Investing in a full-time extension associate for the coffee and orchard crops industries will not only benefit individual farmers but also contribute to the overall economic health of the state. By enhancing the productivity and sustainability of these farms, we can ensure a stable supply of high-quality coffee, which is a significant export commodity for Hawai'i.

In conclusion, the funding of a full-time, permanent extension associate at CTAHR's Kona Extension Office dedicated to the coffee and orchard crops industries is a critical step towards supporting the growth and sustainability of this vital sector. I urge you to consider this request and provide the necessary resources to ensure the continued success of Hawai'i's coffee industry.

Cooperative Extension is key in disseminating science-based information through non-traditional educational programs to the agricultural community. The Kona extension programs service the coffee industry on Hawaii Island and throughout the state. This industry is one of the highest grossing agricultural industries, estimated at over \$48 Million. Over the last few years, this industry has been hammered with production challenges such as coffee berry borer (CBB) and coffee leaf rust (CLR), potentially reducing yields and increasing production costs. The educational programs provided to the industry by the Kona Extension programs have been vital to growers' success in overcoming these challenges. The program's capacity is limited, with only one extension agent and a temporary grant-funded educational support associate. If a permanent position is funded, the extension program will increase the ability to prioritize research and educational projects throughout the state. It will also increase the program's capacity to manage the Kona research station, where much of the research is being done to identify strategies to mitigate the problems brought on by CBB and CLR.

Dear Senator Dela Cruz, Senator Moriwaki, and Members of the Ways and Means Committee,

My name is Andrea Kawabata and I am an Extension Agent for Coffee and Orchard Crops with UH-CTAHR's Kona Research and Extension Center in Kealakekua, HI. I write to you as an individual and community member of Hawaii **in strong support of SB865.** 

SB865 and HB500 appropriates funds to establish a permanent Educational Support Associate (APT) position within UH-CTAHR's Kona Cooperative Extension - my place of work - and for the extension program that I manage. For the past two years this position has been requested, but now more than ever, I am pleading to you to approve funding for this position THIS YEAR.

As you may already know, an Extension Agent's program SOLELY (except for \$3,000 from CTAHR) depends on external funding to hire staff, purchase supplies to organize and conduct outreach events, travel to farms, conduct applied research, translate materials, participate in industry conferences, etc. For the past 12 years, I have employed at least one APT annually to support Extension projects that provide outreach to the state's <u>#3</u> agricultural commodity - coffee - and to the tropical fruit industry and to a lesser extent, the macadamia nut (#7) industry. My current and past support staff have been 100% GRANT FUNDED and together, we have provided outreach statewide to over 1,110 COFFEE FARMS on more than 9,420 ACRES, and mac nut and tropical fruit growers in West Hawaii.

Since 2011, my program has brought in more than \$4.6 million in grant funding with other collaborators. My staff and I have conducted hundreds of workshops, webinars, and field day events statewide and I can tell you first-hand that a second person is critical for event set-up, moving tables, chairs, putting up and breaking down tents, traveling with multiple luggages filled with educational booth display items, posting flyers, interacting with growers during public events, creating a monthly newsletter, posting events and announcements online, sending reminders to participants, moderating the chat and muting participants during webinars, taking photos and videos, etc.

Through the years, and an example of our impact, we have helped coffee growers statewide develop and implement an IPM for coffee berry borer (CBB) control which has been successful at lowering CBB damage rates from 40% to less than 5% and keep farmers in business. We

provided outreach on coffee leaf rust (CLR) prior to its arrival and so when it was first found in Maui, we were able to help with its identification and published alerts, field guides, and sanitation and management recommendations immediately. We still have a lot of work to do with CLR, but are gaining ground as research results are provided to us to disseminate. Our own applied research projects have given coffee farmers additional tools for controlling CBB (Delegate WG, pruning, etc.), coffee root-knot nematode ('Meisner' rootstock, replant strategies, etc.), and CLR ('Ito' Catimor hybrid - the first vetted, CLR-resistant trees distributed to farmers, control recommendations, etc.). MUCH of this work would not be possible without staff support and NONE of it can be done without funding from at least THREE GRANT-FUNDED PROJECTS ANNUALLY.

With that said, **my program is in trouble**. Since 2021, my Extension program has been part of a USDA NIFA SCRI coffee leaf rust grant that was awarded over \$6 million for four years. This past November 2024 and without any personal communications from the project director, over \$260,000 from my (contracted) grant outreach budget was diverted and given to researchers at another university and other entities, leaving me with ZERO funding for the final period (9/1/24-8/31/25) of the grant. Because of this action by the PI, I now have over \$66,000+ in budget shortfall for CLR project expenses and a dedicated staff who I am desperately trying to keep employed - this is still true as of this testimonial letter. This \$260K hole in my budget is extremely painful and not only hurts my program and staff, but also our ability to provide the much needed support that Hawaii's farmers deserve. To address this loss of funds, I have already released staff and cut expenses. My next step is to reduce my final staff's position, cut output to growers because of their reduced time commitments, and pursue funding from competitive grants which is never guaranteed.

This APT position described in SB865 will not only support Hawaii's top agricultural commodities, but help my program focus on what's important - Hawaii's farming community. With this permanent APT position, we hope to mirror the UH-CTAHR <u>SOAP</u> program with their full-time, permanent APT provided by legislature in 2018 and be able to expand our program much like the landscape/ornamental/floriculture/potted plant industry has with five Extension Agents throughout the state. And, while I would still seek grant funding to support and conduct educational outreach and applied research throughout the state, this position would greatly alleviate the headache and heartache of letting farmers down because of the decision of others who do not appear to have Hawaii's agricultural industries in their best interest.

This support position is extremely important and will help to ensure farmers remain in business and Hawaii's communities are fed.

I very humbly ask you to fully support SB865 by funding this educational support associate position. Thank you!

# **Testimony in Support of SB865 Relating to Agriculture**

### Chairperson and Members of the Committee,

My name is SongYi Paik, and I strongly support SB865, which seeks to establish a permanent educational support associate position within the University of Hawai'i College of Tropical Agriculture and Human Resources' (CTAHR) Kona Cooperative Extension and Applied Research Program. This position is essential to strengthening research, outreach, and farmer education efforts to address the critical challenges facing Hawaii's coffee industry.

Hawai'i's coffee industry is one of the state's most valuable agricultural commodity. However, coffee growers continue to face significant threats, particularly from two devastating pests:

- Coffee Berry Borer (CBB): First detected in Kona in 2010, CBB has since spread to multiple islands, reaching Lāna'i in 2020. CBB infestations can cause severe yield losses, particularly when harvests are delayed (Barrera, 2008)<sup>1</sup>. Effective management requires continuous farmer education, research, and outreach to ensure the adoption of best practices.
- 2. Coffee Leaf Rust (CLR): First detected in Hawaii in 2020, CLR has now spread to Maui, Hawai'i Island, O'ahu, and Lāna'i. CLR leads to premature leaf drop, weakening plants and significantly reducing coffee cherry production. Further research is urgently needed to identify resistant coffee varieties, assess their viability for Hawaii's unique growing conditions, and educate farmers on effective management strategies.

Despite the industry's statewide presence, coffee growers are underserved due to geographic remoteness and the limited capacity of existing CTAHR personnel. Establishing a permanent educational support associate position will provide much-needed assistance to extension faculty, enhance community outreach, and bolster research efforts aimed at mitigating CBB and CLR.

This position is not just an investment in research and education; it is an investment in the sustainability of Hawai'i's coffee industry. I respectfully urge the committee to support SB865 and ensure that coffee growers across the state receive the assistance they need to protect their livelihoods and maintain the legacy of Hawai'i-grown coffee.

I appreciate the opportunity to provide testimony in support of this important measure.

For the last year I have worked as a postdoctoral researcher studying and supporting coffee systems in Hawaii. In that time, I have seen a vast need for quality information and direct interaction – extension services – on behalf of coffee producers. Hawaii's unique status as an island state creates additional layers of complexity in agricultural management, particularly regarding the availability and implementation of pest control tools and methods.

Hawaii's coffee farmers face unprecedented challenges, particularly from coffee berry borer (CBB) since 2010 and coffee leaf rust (CLR) since 2020 - the two biggest pressures on coffee both historically and globally. Managing these pests requires complex seasonal strategies while navigating Hawaii's exceptionally strict regulatory framework for agricultural inputs. As an isolated island ecosystem, Hawaii maintains rigorous controls on the introduction and use of both chemical and biological control products. This regulatory environment, while necessary for environmental protection, creates unique challenges that require dedicated expertise to navigate effectively.

While our current extension agents and other support staff work tirelessly to assist coffee farmers, the complexity and scope of these challenges strain existing resources. These dedicated professionals need additional support to maximize their effectiveness in serving our coffee farming community. An additional team member would enhance their capacity to address both immediate farmer needs and longer-term industry challenges.

The coffee industry urgently needs a dedicated extension professional who can serve multiple critical functions: maintaining consistent direct contact with farmers to understand their specific needs, advocating for appropriate tools at the policy and regulatory level, and supporting farmers in implementing, monitoring, and evaluating new management strategies as they become available. This role would encompass not only chemical controls but also biological products and pathogen-resistant coffee varieties, requiring comprehensive knowledge of both regulatory requirements and practical field implementation.

The proposed Educational Support Associate position would provide this essential expertise, helping farmers navigate Hawaii's unique regulatory landscape while developing and implementing pest management strategies tailored to Hawaii's specific growing conditions. This dedicated professional would serve as a crucial bridge between regulatory requirements, available management tools, and on-farm implementation, ensuring that our coffee industry can effectively respond to current and future challenges while maintaining compliance with Hawaii's strict environmental protections.

This investment in the future of Hawaii's coffee industry's would help safeguard a crop that contributes significantly to our state's agricultural diversity, cultural heritage, and economic stability. The complexity of Hawaii's regulatory environment, combined with current pest challenges, makes this dedicated position essential for the continued vitality of our coffee sector.

Aloha Chair Dela Cruz, Vice Chair Moriwaki, and Members of the WAM Committee,

Hawaii Food+ Policy supports SB865 SD1 to establish a permanent Educational Support Associate within CTAHR's Kona Cooperative Extension. This investment addresses gaps in agricultural education, support, and pest management.

CTAHR's 2014 analysis reveals 84% of coffee farms (516 operations) earn under \$10,000 annually on 1.67-acre plots, compared to nine large-scale farms generating over \$250K. CTAHR currently sustains these producers through pest management programs and on-site support; however, limited staffing restricts outreach to small farms and schools.

With only one extension agent and temporary grant-funded staff, 30-47% of grants now fund salaries rather than direct farmer resources. A permanent Educational Support Associate will: accelerate applied research on pest-resistant coffee cultivars and biocontrol methods; expand K-12 outreach; stabilize grant allocations; and strengthen small farms (<5 acres) with pest/disease management guidance and climate adaptation strategies

This role bridges CTAHR's research with on-ground needs, enhancing school gardens as STEM learning hubs while supporting coffee producers facing existential threats. Prioritizing permanent staffing ensures continuity in youth agricultural education and farmer field days—critical for an industry where 94% of operations are small-scale.
