Aloha Chair Elefante, Vice-Chair Wakai, and members of the committee:

I am Major General Stephen Logan, Adjutant General and Director of Hawaii Emergency Management Agency, State of Hawaii, Department of Defense.

The Department of Defense provides written testimony in **SUPPORT** of SB88.

We sincerely appreciate the introduction of this measure and are in full concurrence of the bill's language, which ensures that all of our Hawaii National Guard (HING) servicemembers and their families have complete medical coverage that is equivalent with federal active duty when they are ordered to State Active Duty (SAD) for extended periods of time exceeding 30 days in support of the State.

We would like to share with the legislature that recent increase in natural disasters throughout the State have resulted in an increased number of HING servicemembers being ordered to SAD for extended periods. As a result, many servicemembers have been required to take indefinite leaves of absence from their civilian employment, which can create challenges regarding their healthcare coverage. While some civilian employers may choose to continue paying their employees' company-provided healthcare premiums during an absence, this is not universally the case. Consequently,

HING servicemembers risk losing their healthcare benefits after 30 days of being on SAD orders. This situation forces them to continuously evaluate their ability to serve without healthcare coverage or to seek termination of their SAD orders to maintain their company-provided healthcare for themselves and their families.

This bill will help ensure complete healthcare coverage for all HING servicemembers and their families, and support an uninterrupted HING response force capability to the State.

I am Maui Quizon, a retired Senior Master Sergeant, and Immediate Past President of the Hawaii National Guard Enlisted Association, a non-profit veterans organization dedicated to advocating for the welfare of over 4,600 enlisted soldiers and airmen of the Hawaii National Guard. I am submitting this written testimony in favor of HB2395. I am writing to express my strong support for Senate Bill 88 (SB88). As a retired Hawaii National Guardsman, I have a profound appreciation for the sacrifices made by our service members and the importance of ensuring they receive the benefits they have earned. Healthcare Coverage for Our Guardsmen: One of the most significant aspects of SB88 is its provision to authorize the payment of allowances for TRICARE, TRICARE Dental Program, and vision coverage for all officers, warrant officers, and enlisted personnel of the Hawaii National Guard who are ordered to active duty for more than 30 days. This provision is crucial for several reasons:

- 1. Ensuring Comprehensive Care: Access to TRICARE and associated healthcare programs ensures that our service members and their families can receive comprehensive medical, dental, and vision care. Many Guardsmen face challenges when activating for extended periods, and this coverage alleviates some of the stress associated with ensuring their families are cared for while they serve.
- 2. Promoting Readiness and Retention: By providing these essential benefits, we enhance the overall readiness of our National Guard. When service members know that they and their families will have access to healthcare during their activation, they are more likely to commit fully to their duties. This not only improves morale but also helps retain talented individuals within our ranks.
- 3. Supporting Transition to Civilian Life: As service members transition back to civilian life, having access to TRICARE and other healthcare benefits can significantly ease this transition. Many veterans struggle with healthcare access after their service and ensuring that they have coverage during their active duty helps create a smoother path back to civilian life.
- 4. Acknowledging Sacrifice: This bill acknowledges the sacrifices made by our service members who are called to active duty. It recognizes that their commitment extends beyond their time in uniform, impacting their families and communities. Providing healthcare coverage is a necessary step in honoring that commitment.

In conclusion, I strongly urge you to support Senate Bill 88. By passing this bill, we are making a clear statement that we value the service of our Hawaii National Guard personnel and are committed to ensuring they receive the benefits they deserve. Access to TRICARE, dental, and vision coverage will not only support our service members but also strengthen the entire community. Thank you for your attention to this important matter.
