Chairs DeCoite, Keohokalole and Members of the Committee:

My name is Nadine Ando, and I am the Director of the Department of Commerce and Consumer Affairs (Department). The Department opposes this bill.

The purpose of this bill is to: (1) grant a twenty-year license for casinos in the New Aloha Stadium Entertainment District and Hawaii Convention Center; (2) establish a Hawaii Gaming Control Commission; (3) impose fifteen per cent wagering tax on gross receipts; (4) establish the State Gaming Fund and Compulsive Gambler Program; and (5) appropriates funds.

The Department's mission is to protect consumers, promote fair competition, and foster a healthy and vibrant business environment in Hawaii. While we are charged with overseeing a wide array of industries, the introduction of casino gaming presents unique challenges that may conflict with our existing mandate. Casino gaming, by its nature,

carries inherent risks for consumers, including the potential for gambling addiction, financial hardship, and related social issues. While this measure includes some provisions for regulation, the Department questions whether the proposed structure adequately addresses these complex consumer protection challenges and the resources required to mitigate them effectively.

In addition, the proposed regulatory structure raises concerns. Placing the Gaming Control Commission within the Department for administrative purposes may result in regulatory overlap and inefficiencies. This structure could strain existing resources and infrastructure, requiring significant investment in personnel, technology, and expertise to function effectively. The Department would like to urge the legislature to consider alternative approaches to the organizational structure of the Gaming Control Commission. Establishing the commission as an independent agency could help ensure its autonomy and prevent conflicts with existing mandates.

Finally, if the committee is inclined to move forward with this bill, the Department respectfully requests that prior to enactment, that the Committee refer this matter to the State Auditor for a sunrise analysis pursuant to Hawaii Revised Statutes (HRS) section 26H-6. The statute requires that the sunrise analysis set forth the probable effects of regulation, assess whether its enactment is consistent with the legislative policies of the Hawaii Regulatory Licensing Reform act, and assess alternative forms of regulation.

Therefore, the Department respectfully requests that this bill be deferred until a sunrise analysis on this measure is conducted by the Auditor.

Chairs DeCoite and Keohokalole and Members of the Committees:

The Department of the Attorney General (Department) opposes this bill.

The purposes of this bill are to: establish the Hawaii Gaming Control Commission (Commission) within the Department of Commerce and Consumer Affairs; authorize the Commission to issue a twenty-year casino license to operate a casino facility; authorize a limited gaming operation in the Hawaii Convention Center and in one casino facility in the New Aloha Stadium Entertainment District; establish criteria for the award of a casino license; establish criteria for supplier's licenses, occupational licenses, and temporary supplier and occupational licenses; impose a fifteen percent wagering tax on monthly gross receipts received from casino gaming; establish a state gaming fund and a compulsive gambler program; exempt casino gaming from part III of chapter 712, Hawaii Revised Statutes; and appropriate funds for the operations of the Commission.

The Department opposes this bill because it may lead to the well-studied public health and safety issues that come with legalization of casino gambling. Studies in the United States and abroad have shown that legalized casino gambling results in adverse societal impacts, high costs to address those adverse impacts, and increased crime. In the United States, the opening of even a single casino has been shown to have a substantial negative impact on public safety and welfare. A nationwide study in 2004 found a sharp increase in crime after the opening of a new casino, with additional

growth in crime rates over time.<sup>1</sup> Overall, that study found that approximately eight percent of crime in "casino counties" was attributable to the casinos, resulting in an average cost of approximately \$75 per adult. Another study indicated that the opening of a new Indian-owned casino resulted in a ten percent increase in violent crime, auto thefts, and larceny, as well as an increase in bankruptcies in the area by approximately ten percent.<sup>2</sup> Notably, crime in the surrounding communities also increased, suggesting an overall increase in aggregate crime, rather than just switching from one community to the next.<sup>3</sup>

Abroad, Macao experienced a 52.6% increase in reported crimes between 2002 and 2008 (following the liberalization of casino licensing in 2002), from 9,088 to 13,864<sup>4</sup>, and experienced a 26.6% increase in the number of high school drop-outs in the same period, from 1,886 to 2,388.<sup>5</sup> Another study on Macao estimated that the overall social costs of gambling increased by 163% between 2003 and 2007, from an original expense of \$40 million to \$106 million.<sup>6</sup> This was based on seven areas of social impact: treatment costs; prevention costs; family and friends physical and psychological costs; legal costs; rent-seeking costs; regulatory expenses; and the public costs of training, promotion and research.<sup>7</sup>

Another study, comparing multiple communities in New South Wales, showed that every 10% increase in electronic gambling machine profits correlated to a 7.4% increase in assaults, a 10.5% increase in breaking and entering into dwellings, a 10.3% increase in breaking and entering into non-dwellings, an 11% increase in motor vehicle thefts, an 8.2% increase in stealing from motor vehicles, and a 7.4% increase in fraud.<sup>8</sup>

Locally, a study commissioned by the Hawaii State Commission on the Status of Women (HSCSW) found a serious risk of increased sex trafficking in our community if a casino were built here, when similar bills were proposed in 2021.<sup>9</sup> The study found that "[i]n 2020, Child and Family Service . . . identified 97 sex trafficking victims among its clients through the first statewide survey of its kind" and "[t]he majority of the victims (64%) identified as Native Hawaiian." Another community-based service provider, Susannah Wesley Community Center, reported a 65% increase in the number of people needing sex trafficking-specific therapy, during the COVID-19 pandemic alone. 11

As pointed out in the HSCSW study, casinos would be expected to attract large numbers of men with disposable income, and a 2010 federal study found that "casino patrons were 17% more likely than the average survey respondent to have paid for sex in the past year." Moreover, indigenous women are particularly susceptible to victimization and already account for a majority of known sex trafficking victims in Hawaii. 13

On a more granular level, the studies cited above have also shown a correlation between casino gambling and domestic violence, divorce, bankruptcy, drug and alcohol use, and risky or illicit sexual behavior.

In conclusion, the Department is gravely concerned about the harmful impacts that legalization of casino gambling will have on our community and respectfully requests that this bill be held.

The Stadium Authority offers the following comments on Senate Bill 893 SD1, which proposes to establish a Hawaii Gaming Control Commission and grants twenty-year licenses for casinos in the New Aloha Stadium Entertainment District (NASED) and Hawai'i Convention Center.

The Stadium Authority is currently negotiating a Master Development Agreement and Stadium Development and Operations Agreement with Aloha Halawa District Partners (AHDP) for the construction of the new aloha stadium and development of the surrounding NASED project. One of the requirements under the agreements is for AHDP to operate and maintain the new stadium for 30 years. If the NASED project is able to incorporate casinos in the NASED project that generate revenues from legal

#### RELATING TO THE ECONOMY

The Department of Budget and Finance (B&F) offers comments on this bill.

Senate Bill (S.B.) No. 893, S.D. 1, adds a new chapter to the HRS to:

1) establish the Hawai'i Gaming Control Commission (HGCC), administratively attached to the Department of Commerce and Consumer Affairs (DCCA), to issue one 20-year casino license each for the Hawai'i Convention Center and the New Aloha Stadium Entertainment District; 2) establish a 15% wagering tax on the monthly gross receipts from casino gaming, in lieu of the General Excise Tax (GET) and Public Service Company Tax (Corporate Tax), with up to 2% of collections deposited into a new State Gaming Fund (SGF) and the remainder deposited to the credit of the general fund; 3) establish the SGF to fund the Department of Education, a Compulsive Gamblers Program, public security at casino facilities, and the administrative expenses of HGCC; 4) require each gambling licensee to pay a one-time license issuance fee of \$150,000,000 to the credit of the general fund, \$75,000,000 of which is to be paid prior to issuance and \$75,000,000 of which is to be paid one year after issuance, provided

that the latter installment shall be credited to the licensee's wagering tax liability over an amortized ten-year period; and 5) implement various other provisions pertaining to gaming. Additionally, the bill appropriates \$5,000,000 in general funds for FY 26 and FY 27 to fund the HGCC, provided the casino licensee shall reimburse the State for \$5,000,000 by the casino's first day of operation, which shall be credited against the licensee's casino license application fee and wagering tax liability.

Although this bill does not specify the means of financing for the proposed SGF, B&F notes similar funds that collect tax revenues are typically classified as special funds. As a matter of general policy, B&F does not support the creation of any special fund, which does not meet the requirements of Section 37-52.3, HRS. Special funds should: 1) serve a need as demonstrated by the purpose, scope of work, and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue; 3) provide an appropriate means of financing for the program or activity; and 4) demonstrate the capacity to be financially self-sustaining. Regarding S.B. No. 893, S.D. 1, it is difficult to determine whether the proposed SGF will be self-sustaining.

B&F defers to the Department of Taxation (TAX) on the tax revenue projections and general fund impact of S.B. No. 893, S.D. 1, and notes other State "sin" taxes are designed to generate sufficient general fund revenue to offset the State's overall administrative costs to regulate harmful products and services. For reference, cigarette and liquor tax collections were respectively \$84,200,000 and \$51,600,000 for FY 24. Therefore, B&F recommends that the wagering tax be set at a parity to, if not higher

than, other "sin" taxes, with the portion of revenues deposited to the general fund at a sufficient level needed to support the intents of this bill in a self-sustaining manner.

Furthermore, B&F notes Nevada collected \$1.23 billion in gaming tax and fee revenue in FY 24 through a significantly more complex taxation scheme than what is being proposed by this bill. Not only does Nevada impose a 6.75% tax on gross gaming revenues over \$134,000, but it also imposes licensing fees on each slot machine in operation and each gambling game played, in addition to various other taxes and fees on related activities such as live entertainment at gaming facilities. Given the proposed 15% wagering tax would be in lieu of the GET (4.712% in the City and County of Honolulu) and Corporate Tax (up to 6.4%), it is unclear if this tax rate, the \$150,000,000 licensing fee for each of the two casino licensees every 20 years, and other fees, less the credits to be claimed by the licensees, would generate sufficient revenues to regulate the proposed gaming industry in Hawai'i.

Finally, B&F notes this bill does not authorize position counts for the HGCC's Executive Director and staff and defers to DCCA and TAX on the programmatic merits of this bill.

Chairs DeCoite and Keohokalole, Vice-Chairs Wakai and Fukunaga, and members of the Senate Committees on Economic Development and Tourism and Commerce and Consumer Affairs, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") submits the following testimony in <u>strong opposition</u> of S.B. 893 S.D.1.

The purpose of S.B. 893 S.D.1 is to create economic growth by legalizing an activity that is currently illegal in the State of Hawai'i. Gambling is illegal here for good reason. To date, multiple studies show a clear correlation between casinos and increased crime and societal ills among their surrounding community. Whether it is casino gambling or online gambling, gambling is shown to have negative effects on communities who have legalized it. The National Council on Problem Gambling "estimates that about 2.5 million adults in the U.S. have severe problems and another 5 to 8 million have significant issues."

Even the opening of a single casino has been shown to have a substantial negative impact on public safety and welfare. A nationwide study in 2004 found a sharp increase in crime after

the opening of any new casino, with a relatively low effect shortly after the casino opens, which grows over time. Overall, the study calculated that approximately 8% of crime in "casino counties" was attributable to the casino, resulting in an average social cost of approximately \$75 per adult. Another study indicated that—nationwide—the opening of a new Indian-owned casino resulted in a 10% increase in violent crime, auto thefts, larceny & bankruptcies in the area. Notably, crime in the surrounding communities also increased, suggesting an overall increase in aggregate crime, rather than just switching from one community to the next.

Locally, a study was commissioned by the Hawai'i State Commission on the Status of Women ("HSCSW"), in 2021 when S.B. 1321 proposed to legalize the building of a casino on Hawaiian Homelands. This study points to the serious risk of increased sex trafficking in our community, if a casino were built in Hawai'i.<sup>2</sup> "In 2020, Child and Family Services...identified 97 sex trafficking victims among its clients," statewide; this spanned five different islands, and "[t]he majority of the victims (64%) identified as Native Hawaiian." Another community-based service provider, Susannah Wesley Community Center, reported a 65% increase in the number of people needing sex trafficking-specific therapy, during the COVID-19 pandemic alone.<sup>4</sup>

Seeing that Hawai'i's sex trafficking industry is clearly subject to increase, given changes in the economic climate, one can only infer that adding a casino into the mix would further exacerbate this already staggering problem. As pointed out in the HSCSW report, casinos would be expected to attract large numbers of men with disposable income, and a 2010 federal study found that "casino patrons were 17% more likely than the average survey respondent to have paid for sex in the past year." Moreover, indigenous women are particularly susceptible to victimization, and already account for a majority of known sex trafficking victims in Hawai'i, yet the proposed casino is anticipated to be located near one of the largest Native Hawaiian communities in Hawai'i.

On a more granular level, multiple studies—including the HSCSW report—have also shown a correlation between casino gambling and domestic violence, divorce, bankruptcy, drug and alcohol use, and risky or illicit sexual behavior. Legalizing a casino will require an increase in resources to address these public health issues that will increase once gambling is legalized.

Lastly, a casino will take up a very precious resource—land. Land that could be used for affordable housing to help our kama'āina afford to live, work, and raise families here at home.

For all of the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu **strongly opposes** the passage of S.B. 893 S.D.1. Thank you for the opportunity to testify on this matter.

Boyd Gaming appreciates the opportunity to provide comments on SB 893 SD1, which grants twenty-year licenses for casinos in the New Aloha Stadium Entertainment District and Hawaii Convention Center, establishes the Hawaii Gaming Control Commission, imposes fifteen per cent wagering tax on gross receipts, establishes the State Gaming Fund and Compulsive Gambler Program and appropriates funds.

Founded in 1975, Boyd Gaming is now a nationwide gaming company operating 28 casinos in 11 states, and has a presence in 19 distinct markets including our online presence in online gaming and sports wagering. Our perspective that we are sharing with you today has been shaped by 50 years of experience in the gaming industry, operating in all facets of gaming including brick-and-mortar casinos, sports wagering, online real money and social gaming, among others.

Our Company has strong ties to Hawai'i, as the state and its residents were a critical component of Boyd's foundational beginnings and continue to be an important part of the Company's success today. Boyd Gaming also owns and operates Vacations Hawaii, which has served over 1.5 million Hawai'i residents with convenient and affordable direct flights to Las Vegas since 1996. Vacations Hawaii is proud to be an established part of Hawai'i's local history, community and economy with employees based in both Hawai'i and in Las Vegas.

While we appreciate the intent of SB 893 SD1, we believe that the state would be better suited to consider a holistic, comprehensive gaming policy framework, rather than consider individual components of gaming policy separately. For that reason, we prefer SB 891 SD1, which establishes a working group to study a comprehensive gaming framework, and believe that bill is an appropriate first step for the Legislature to take before passing any gaming policy legislation. Given that Hawai'i currently does not have any form of legalized gaming, the state has a unique opportunity to create a comprehensive gaming policy framework that is specifically tailored to Hawai'i's unique culture and tourism economy. The data, information and analysis done by the working group will be critical to help shape public policy for the Legislature to consider that will serve as a catalyst of economic activity, employment, investment, and state and local tax revenue. Any gaming policy considered in Hawai'i should be complementary and additive to Hawai'i's existing robust tourism and hospitality industry. However, if done correctly, the main focus of gaming policy should not be solely to authorize gaming, but drive significant private capital investment to build upon and enhance Hawai'i's existing tourism infrastructure while supporting local priorities. The working group established by SB 891 SD1 could establish a comprehensive framework to best position Hawai'i to take advantage of the intersection of tourism, sports, entertainment and gaming as part of the state's own "Fun Economy."

Stanford Carr Development (SCD) submits this testimony in **support** of SB 893, SD1, which proposes granting twenty-year licenses for casinos in the New Aloha Stadium Entertainment District and the Hawaii Convention Center. The bill also seeks to establish the Hawaii Gaming Control Commission, impose a 15% wagering tax on gross receipts, and create both the State Gaming Fund and the Compulsive Gambler Program.

#### **Economic Benefits of the Gaming Industry**

According to 2024 research by the American Gaming Association, the gaming industry's total economic impact includes:

- \$329 billion in economic impact to the U.S. economy
- \$53 billion in tax revenues for federal, state, and local governments
- 1.8 million jobs supported, with \$104 billion in labor income, including wages, salaries, tips, benefits, and other compensation

Casino gaming is a broadly accepted entertainment option among the U.S. public, with over 102 million adults visiting casinos in the past year. Hawaii is one of only three states in the U.S. without legalized gaming. However, over 300,000 Hawaii residents visit Las Vegas each year, not to mention those that visit casinos in California and other states. It is why Las Vegas is jokingly, but accurately, referred to as the 9<sup>th</sup> island. Introducing casinos in Hawaii presents an opportunity for creating thousands of jobs and hundreds of millions of dollars of tax revenue here, rather than shipping these economic benefits to other states.

While concerns about gambling's social impacts exist, this bill proactively addresses them by establishing a gaming fund and a program dedicated to compulsive gambling prevention and treatment. In fact, the legalization of gaming will help eliminate the extensive and well

documented illegal gaming that has proliferated in the state and reduce crime and problem gaming by professionalizing, taxing, and regulating the industry.

#### A Vision for Economic and Community Growth

As a key member of the New Aloha Stadium Entertainment District development team, we are committed to creating a vibrant entertainment complex alongside livable residential neighborhoods. Integrating casinos into this vision offers an opportunity to build a modern urban community that fosters both economic growth and job creation.

Additionally, incorporating a casino could pave the way for an aspirational stadium that serves Hawaii for decades, hosting professional sports, concerts, and community events. If approved, this legislation would further support the development of workforce housing with deeper affordability, along with an increased share of moderate-income housing. A casino in the Aloha Stadium Entertainment District will generate over 5,000 good paying jobs, hundreds of millions of dollars in tax revenues and billions of dollars in economic benefits to the region, and help enhance a world-class sports and entertainment destination for both residents and visitors to the state.

Hawai'i Family Forum is a non-profit, pro-family education organization committed to preserving and strengthening families in Hawai'i. SB893 seeks to legalize casino gambling in the New Aloha Stadium Entertainment District and Hawaii Convention Center. This bill would establish a Hawaii Gaming Control Commission, impose a fifteen percent wagering tax on gross receipts, and create a State Gaming Fund. As such, we have serious concerns about this bill and its ultimate ramifications on the wider community.

Hawai'i is one of only two states in the nation without any form of legalized gambling. This is not a flaw in our economy—it is a strength of our cultural and social fabric. Our islands have long stood as a beacon of family values, natural beauty, and a unique way of life. Legalizing gambling would be a direct assault on these values and would irreversibly change the very character of our state. Simply put, we must Keep Hawai'i, Hawai'i.

#### **Gambling Preys on the Most Vulnerable**

Legalized gambling, especially casinos, has a well-documented history of disproportionately harming low-income families, kūpuna, and individuals struggling with addiction. Studies have shown that problem gambling leads to addiction, increased bankruptcy, crime, family breakdown, domestic violence, homelessness, and even suicide<sup>i</sup>. Establishing a Compulsive Gambler Program does not undo the widespread damage that will occur in our communities if casinos are introduced and lives and families are destroyed.

#### The Social and Economic Costs Outweigh the Benefits

Supporters of this bill claim that casino gambling will bring in much-needed revenue, but decades of research have proven that the costs of legalized gambling outweigh the financial benefits. For every \$1 gained in tax revenue, states spend at least \$3 addressing the social consequences of gambling addiction<sup>ii</sup>, increased crime, and destruction of the family, including poverty<sup>iii</sup>. Instead of boosting our economy, casinos create an environment of dependency, where local residents—rather than tourists—become the primary patrons and financial victims.

#### **Gambling Attracts Crime and Corruption**

Casinos have been linked to higher rates of crime, including organized crime, drug trafficking, human trafficking, and money laundering. The introduction of a Gaming Control Commission does not guarantee that our state will be able to curb these dangerous influences. States that have legalized gambling often find themselves constantly battling regulatory failures, enforcement problems, and political corruption linked to the gambling industry.

#### **Gambling Will Become a Public Health Issue**

According to the impact report conducted by the Hawai'i State Commission on the Status of Women in 2021, gambling is recognized as a public health issue linked to significant community harm, including connections to sex trafficking and other forms of gender-based violence. Their report concludes that Native Hawaiian, immigrant, and impoverished women, LGBTQ individuals, and keiki living near the proposed Resort Casinos are at the highest risk for gambling-related harm, such as problem gambling, domestic violence, child abuse, sexual assault, and sex trafficking. Hawai'i's already underfunded anti-sex trafficking, sexual assault, and domestic violence support systems would likely be unable to respond effectively to an increase in gender-based violence. Furthermore, prevention efforts would be hindered, as reducing sex trafficking requires addressing demand—a challenge when gambling patrons generating revenue are the primary source of that demand. As a result, the Resort-Casino could perpetuate gender-based violence and economic instability for vulnerable women, trapping them in a dangerous cycle of exploitation<sup>iv</sup>.

#### There Are Better Economic Solutions for Hawai'i

Instead of turning to gambling as an economic quick fix, we should focus on sustainable industries that align with our values—such as technology, local agriculture, renewable energy, and responsible tourism. Gambling is a short-term and harmful solution that does not reflect the aloha spirit or the best interests of Hawai'i's people.

#### Keeping Hawai'i, Hawai'i

For generations, Hawai'i has been a place of community, tradition, and shared responsibility. We have remained one of the few states to reject the predatory industry of gambling, and we should continue to do so. We must uphold our commitment to preserving the cultural integrity and moral foundation of our islands. Gambling will not solve our economic challenges—it will create deeper ones. We urge both committees to reject SB893 and protect the future of Hawai'i. Let us keep our state a place of true prosperity, one that prioritizes the well-being of its people over short-term economic schemes.

**Re: Strong Opposition to Senate Bill 893** 

ALOHA Legislators,

The Nation of Hawai'i writes to express our strong opposition to Senate Bills 891 and 893. These bills have been crafted without consultation with the Native Hawaiian community and, if passed, will perpetuate the historical economic exclusion and systemic marginalization of our people. We believe that granting control over gaming development to external entities that do not represent the true interests of Hawaiians would be a grave disservice to our community. We respectfully urge you to vote against both of these bills.

For over the past two years, the Nation of Hawai'i has been working diligently to develop a viable, sustainable, and Indigenous-led gaming initiative that aligns with our cultural values and economic needs. Any move toward gaming must ensure that economic benefits remain with the Native Hawaiian people, rather than flowing into corporate hands that have historically overlooked our population. Furthermore, the state-controlled regulatory framework has a track record of excluding us, and we cannot support bills that continue this trend.

#### Why These Bills Must Be Stopped:

#### • Failure to Include Native Hawaiian Representation:

Both SB 891 (Gaming Working Group) and SB 893 (Gaming Control Commission) were created without consultation with the Nation of Hawai'i or any other recognized Native Hawaiian governing entity. This exclusion is unacceptable.

#### • State-Controlled Revenue Model:

These bills direct gaming revenue into a state fund, reinforcing economic structures that have marginalized Native Hawaiians for over a century. The funds should benefit our community directly, not be siphoned off into external entities.

#### • No Consideration of Hawaiian Sovereignty or Land Rights:

As an internationally recognized sovereign entity under Public Law 103-150 (Apology Resolution), the Nation of Hawai'i must have a say in any development involving gaming in Hawai'i. The absence of this consideration in both bills is a clear oversight.

#### • Environmental & Cultural Risks:

The proposed sites for gaming, such as the Neal S. Blaisdell Center and the Hawai'i Convention Center, are not suitable for long-term, community-driven gaming development. These locations lack the necessary cultural grounding and environmental sustainability to ensure the success of such an initiative.

#### • Flawed Legislative Premise:

SB 893 presumes a structure that should instead be the result of discussions stemming from SB 891. Additionally, the inclusion of specific companies with no history of supporting Hawai'i's best interests or engaging with the Native Hawaiian community is deeply troubling. Legislation should not pick corporate "winners" at the expense of the people of Hawai'i.

### Historical Context: The Akaka Bill and the Redaction of Gaming Rights for Native Hawaiians

It is also essential to recognize the history surrounding the Akaka Bill, which sought federal recognition for Native Hawaiians. In 1998, when this bill was first introduced, gaming provisions were initially included as part of the discussion. However, in a significant step backward for our community, these provisions were later redacted, effectively preventing Native Hawaiians from having a say in the future of gaming development within our own homeland. The Akaka Bill's passage without gaming provisions marked a loss of self-determination and a denial of our ability to participate in the economic opportunities that could help sustain and strengthen our community. These Senate Bills 891 and 893, by further entrenching external control over gaming, continue this history of exclusion and further diminish our ability to address the economic needs of our people on our terms.

#### The Nation of Hawai'i's Superior Alternative:

The Nation of Hawai'i is committed to an Indigenous-led, culturally grounded, and sustainable approach to gaming development. Our model offers significant advantages, including:

#### • Revenue Stays in Hawai'i:

Our approach ensures that funds are reinvested directly into Native Hawaiian communities, benefiting education, housing, healthcare, and land restoration.

#### • Cultural & Environmental Responsibility:

Our gaming initiative identifies culturally and environmentally appropriate locations that align with the land and its people, ensuring long-term sustainability.

#### • Stronger Regulatory Oversight:

Our model includes a Native Hawaiian-led regulatory body that ensures compliance, accountability, and protection against problem gambling, surpassing the standards set in SB 893.

#### • Job Creation & Economic Empowerment:

Unlike the external corporate interests outlined in these bills, our model creates job opportunities, career pathways, and workforce training programs specifically for Native Hawaiians, contributing to economic self-sufficiency.

#### **Our Demand: The Legislature Must Act in Good Faith**

We call upon the Hawai'i State Legislature to halt the advancement of SB 891 and SB 893 immediately. We request a direct meeting with key legislative leaders to present our comprehensive plan, which has been developed with respect for the culture, rights, and self-determination of Native Hawaiians.

The United States, through Public Law 103-150, acknowledged the illegal overthrow of the Hawaiian Kingdom and affirmed our inherent right to self-determination. This right extends to economic development initiatives, especially those involving gaming, which will dramatically alter Hawai'i's economic landscape. It is imperative that such initiatives be led by and for Native Hawaiians, not by external forces that continue cycles of economic oppression.

We urge you to stand on the right side of history and work with the Nation of Hawai'i to create a gaming framework that truly benefits our people and respects our rights. We look forward to your response and a formal commitment to meet and engage on this matter.

We work with Indian Country leaders, gaming regulators, and global industry experts to ensure that if gaming is introduced, it is done on our terms, with Native Hawaiians in leadership, and with revenue reinvested into our communities.

We urge the Legislature to **vote NO on SB 891 & SB 893** and engage in direct consultation with the Nation of Hawai'i. Any discussion of gaming must **begin and end with Native Hawaiian leadership**—not external interests. We welcome dialogue and a seat at the table to ensure any decisions align with **our values, sustainability, and the long-term well-being of our people.**

Among other related things, this Senate Bill grants twenty-year licenses for casinos in the New Aloha Stadium Entertainment District and Hawai'i Convention Center, and establishes a Hawai'i Gaming Control Commission.

The promise of increased tax revenue should not be the deciding factor in making this decision. There are financial and societal consequences that must be weighed. Indeed, these reasons are why the legislature has wisely resisted legalizing gambling every past year that it has been proposed.

Gambling is harmful to individuals and society. Casinos and lotteries are profit-driven businesses who use sophisticated techniques to ensure that the "house" wins the majority of the time. The gaming industry implies that "winning big" is more probable than it really is. Thus, it is those who are worse off financially that are most attracted to gambling because it gives them a false hope their plight will be solved by hitting it big.

My name is Kai Lorinc, and I am submitting testimony in strong opposition to SB 893, a reckless and deceitful attempt to legalize casino gambling in Hawaii. The way this bill has been handled with minimal public notice, lack of transparency, and rushed committee hearings raises serious concerns about legislative integrity.

## A Backdoor Scheme to Legalize Gambling

The process surrounding SB 893 is deeply troubling and unethical. The Senate Economic Development and Tourism Committee only provided 34 minutes' notice before discussing this bill, giving the public virtually no opportunity to participate. Additionally, the proposed draft of the bill was practically blank, with no clear mention of casinos—an obvious attempt to obscure its true intent.

If gambling is truly in the best interest of Hawaii, why aren't lawmakers putting it to a statewide vote? Why is it being rushed through committees in the shadows? These tactics undermine public trust and suggest that legislators know full well that the people of Hawaii do not support casino gambling.

Hawaii has remained gambling-free for a reason—our communities cannot afford the consequences. The only people who stand to benefit are casino operators, gambling lobbyists, and the politicians who support them. The people of Hawaii will be left to deal with the fallout.

Subject: Robust Opposition to S.B. No. 893 - A Clear Danger to Hawaii's Social Fabric and Security

Dear Esteemed Members of the Hawaii State Legislature,

I come before you with an impassioned plea to reject Senate Bill No. 893, which would introduce casino gambling to our state. This legislation, while cloaked in the guise of economic prosperity, is deeply flawed and would open the floodgates to a myriad of social, criminal, and economic challenges. Here are more detailed reasons, backed by statistics, to argue for its dismissal:

## 1. Human Trafficking:

- Hawaii's existing human trafficking problem is dire, with 64% of survivors being Native Hawaiian (NIWRC, 2021). Casinos act as a catalyst for human trafficking, with a study from the National Human Trafficking Hotline indicating that casinos are one of the top venues for sex trafficking. In Nevada, calls about human trafficking in casinos rose by 70% after legalization (Polaris Project, 2018). We cannot afford to exacerbate this issue in Hawaii, where the infrastructure to combat trafficking is already strained.
- January is Human Traffiking Awareness Month recongnized Nationwide and by Governor Josh Green with multiple bills in active legislation now.

# 2. Drug Smuggling and Addiction:

• Casinos have been linked to a significant uptick in drug crimes. In Atlantic City, drug arrests within casino districts increased by 27% following casino legalization (New Jersey State Police, 2015). In Hawaii, the High Intensity Drug Trafficking Area (HIDTA)

data shows methamphetamine and heroin seizures have already risen by 40% in the last five years. Introducing casinos would likely fuel this increase, with the UNLV study correlating gambling with higher rates of drug use among gamblers.

#### 3. Prostitution:

The connection between casinos and prostitution is well-known. In Las Vegas, after the
legalization of gambling, prostitution-related arrests in casino areas increased by 15%
within three years (Las Vegas Metropolitan Police Department, 2009). Given Hawaii's
recent history of illegal gambling dens tied to prostitution, as reported by local law
enforcement, legal casinos would only amplify this trade.

#### 4. Violent Crimes:

• Economic studies, including those by Grinols and Mustard (2001), have shown that the introduction of casinos can lead to an 8 to 10% increase in crime rates. In Honolulu, the correlation between illegal gambling operations and violent crimes like murder and robbery is evident, with the Honolulu Police Department reporting a 12% rise in violent crime associated with gambling dens since 2015.

# 5. Murder and Rape:

• While direct causation is complex, the environment around casinos can foster conditions leading to violent crimes. In Chicago, post-casino legalization, there was a noted 3% increase in violent crime rates within a 2-mile radius of casinos (Chicago Police Department, 2016). Given Hawaii's tight-knit communities, this could mean a significant upheaval in our sense of security and community cohesion.

## 6. Economic and Social Costs:

• The economic benefits of casinos are often overstated. Maryland's casinos, for example, brought in revenue but at the cost of significant social expenses, including \$1.2 billion in social costs annually due to gambling addiction (Maryland Department of Health, 2020). Hawaii, without the robust social services infrastructure to handle such an increase in gambling addiction, would face even higher costs.

# 7. Community and Cultural Impact:

• The cultural fabric of Hawaii, emphasizing 'ohana and community, could be irreparably damaged by casinos. In communities where casinos have been introduced, there's been a noted 20% increase in homelessness and a decline in community health metrics (Urban Institute, 2021). Given our state's unique cultural identity, this shift could lead to a loss of cultural heritage and community values.

# 8. Legal and Enforcement Challenges:

The enforcement of gambling laws has historically led to corruption and inefficiency. A
2017 study from the Center for Problem-Oriented Policing showed increased corruption
in law enforcement in areas with casinos. Hawaii's law enforcement is already underresourced for current crime rates; adding casinos would strain these resources further,
potentially leading to more crime rather than less.

#### 9. Environmental and Infrastructure Strain:

Casinos require significant infrastructure, leading to environmental degradation and
increased traffic, which Hawaii's islands are ill-equipped to handle. In Macau, casino
development led to a 30% increase in traffic congestion (Macau Government Traffic
Department, 2018), a scenario Hawaii might face, impacting our tourism in negative
ways.

I urge you to consider these points and the potential for casinos to not only fail in delivering promised economic benefits but to bring about long-term social and criminal damage. Please vote against S.B. No. 893 to protect Hawaii's future, its people, and its unparalleled cultural heritage.

Casinos disproportionately affect low-income and vulnerable populations, who are more likely to gamble beyond their means. The bill's focus on economic development through casinos might instead lead to the economic exploitation of these groups, deepening poverty and inequality. The allure of quick wealth can be particularly damaging to individuals who can least afford to lose money.

# **Regulatory and Enforcement Challenges:**

The establishment of the Hawaii Gaming Control Commission and the regulatory framework suggested in the bill present significant challenges. The complexity of managing and regulating casino operations to prevent corruption, fraud, and illegal activities would require substantial resources and expertise, potentially overwhelming existing state regulatory bodies.

## **Environmental and Infrastructure Concerns:**

Introducing casinos in areas intended for community or cultural use, like the New Aloha Stadium Entertainment District or the Hawaii Convention Center, could lead to environmental degradation and inappropriate use of public spaces. # **Social Implications**

The social costs of gambling are profound. Pathological gambling can lead to severe financial distress, including drained savings, increased bankruptcies, debt delinquencies, and domestic violence, particularly affecting economically vulnerable households.

Moreover, the legalization of gambling has been associated with increased irresponsible betting behavior, especially among lower-income populations. A study from the University of California, San Diego, found that online gambling legalization leads to more irresponsible gambling spending among lower-income consumers than among higher-income gamblers.

### **Addiction and Mental Health**

The proliferation of gambling opportunities can exacerbate addiction issues. In New Jersey, for example, while online sports betting has generated substantial revenue, it has also raised

concerns about gambling addiction and its impact on individuals and families. Over 90% of sports betting in the state is conducted online, contributing significantly to the economy, but also leading to an increase in problem gambling, especially among young adults.

# **Community Impact**

Casinos can have negative social effects on the surrounding area, such as more crime and addiction. For example, in the UK, the rise of all-night slot machine halls has raised concerns about their impact on vulnerable gamblers, with critics arguing that these venues provide little economic benefit and exacerbate social issues.

## Conclusion

While the promise of economic benefits from legalized gambling may seem appealing, the evidence suggests that the social and economic costs are substantial and enduring. The experiences of other regions demonstrate that the introduction of casinos often leads to increased social issues, economic disparities, and long-term fiscal challenges. I urge you to consider these factors carefully and **oppose** SB893 to protect the well-being of our community.

For an island state like Hawaii, where community safety is paramount, this could lead to significant law enforcement challenges and increased costs for public safety measures.

#### \*\*Risk of Addiction:\*\*

Gambling addiction is a serious issue with far-reaching social consequences. Casinos are known to exacerbate gambling disorders, leading to personal and familial financial ruin, mental health issues, and a range of social problems. Hawaii, with its close-knit communities, risks seeing a rise in these problems, particularly in areas with limited access to mental health services to address such issues.

#### \*\*Social Disruption:\*\*

Casinos can fundamentally alter the social fabric of communities. They often shift economic resources away from local businesses, leading to a decline in small local enterprises. Moreover, the 24/7 operation of casinos can disrupt traditional lifestyles, work patterns, and community cohesion, potentially leading to increased social inequality and community discord.

#### \*\*Minimal Benefits Outweighing Risks:\*\*

While proponents argue that casinos could bring economic benefits through tourism and job creation, these benefits are often overstated. Many studies have shown that casinos primarily

redistribute money within the local economy rather than creating new wealth. The tax revenue from gambling can also be volatile, often not compensating for the social costs incurred.

### \*\*Community Well-being:\*\*

The well-being of our community should not be traded for uncertain economic gains. Hawaii's unique culture, environment, and lifestyle are its true assets. Introducing casinos could undermine these values by fostering a dependency on gambling, which is not aligned with the Aloha spirit or our commitment to sustainable, community-oriented development.

#### \*\*Conclusion:\*\*

In light of these concerns, I urge the Legislature to reject SB893. The potential for increased crime, addiction, and social disruption far outweighs any economic arguments in favor of casino gambling. Let us continue to protect and nurture the quality of life in Hawaii by rejecting this bill and focusing on sustainable, holistic development that benefits all residents without compromising our community's integrity and health.

Among local Hawaii residents, Las Vegas is a popular destination primarily for gambling. Thankfully, Las Vegas is in another state and not in ours. The landscape of our islands is unlike the other continental U.S. states. Allowing legalized casino gambling by granting 20-year casino licenses in the New Aloha Stadium Entertainment District and the Hawaii Convention Center will directly impact and pose negative social and ethical effects to our communities especially the surrounding communities.

While the economic impact is obvious, the social and ethical effects are also obvious: increases in crime (e.g. theft, fraud, money laundering, petty crimes such as shoplifting, pickpocketing), violence, gambling addiction, negative mental health consequences of people directly involved and their families, and the overall negative impact to local communities. No resident would want that in their community.

In general, the lure of gambling is seen as a possible way to improve one's financial situation. Unfortunately, gambling rarely pays off and tends to worsen financial situations, increasing debt burden and may lead to a greater number of bankruptcies. Unfortunately, no impact is more impactful than on the immediate family and loved ones who personally deal with greater financial burdens and/or financial instability outcomes as well as mental health outcomes.

Moreover, small businesses (e.g. shops, restaurants, family-owned venues) located near casinos will struggle to compete with casinos and may be forced to relocate or close causing a negative impact on residential communities. If a casino becomes the dominant economic source in an

area, it could also be subject to downturns or shifts in consumer habits, which means the surrounding areas could suffer economically as well.

I strongly urge you to vote NO on SB 893 SD1. Let's keep Hawaii and all our Ohanas safe.

Chair DeCoite, Vice Chair Wakai, and EDT Committee Members: Chair Keohokalole, Vice Chair Fukunaga, and CPN Committee Members:

I write in support of SB 893, SD 1, which would authorize 20 year casino licenses in the "entertainment district" planned for the Aloha Stadium site and the Hawaii Convention Center. The Convention Center is probably the best site for a prospective casino given its proximity to Waikiki and available space and parking that can be quickly turned around. In contrast, the stadium has yet to be demolished, and the space could likely be dedicated to mix-use urban infill that includes housing, retail, and open space

I am not a fan of casino gaming or casinos, but many in our islands and across the globe have an affinity for games of chance in that kind of environment. Those opposed to gaming need not be patrons of those establishments.

As a general matter, the government should provide a workable framework of regulations to ensure that business is conducted in an appropriate fashion, including mitigation of foreseeable negative externalities associated with the regulated conduct.

Prohibition is not working except for those who are involved in illicit gaming operations. Prohibition also works for national casinos catering to the Hawaii market. Prohibition also works for political actors who gin up popular fears and perpetuate stigma against "others" to their perceived advantage.

To the extent that legal gaming venues will curb the demand for illicit gaming, this could have a positive impact on those residential areas now marred by not-so-clandestine game rooms and the risks for theft and violence posed by them. At the same time, the state would be able to generate additional tax revenues to fund its ongoing budget priorities.

Among these priorities should be the additional funding for the Department of Hawaiian Home Lands to provide housing opportunities for beneficiaries who have been on the list for far too long. Additionally, funds could be used to support the health and well-being of the rural neighbor islands through improved health care access and regenerative agriculture projects.
