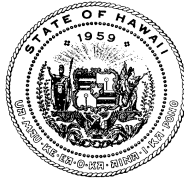

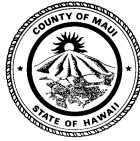

I **support** this measure for the following reasons:

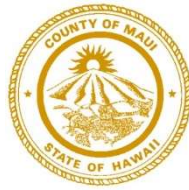
1. By refining discharge regulations, this measure would enable the Central Maui Wastewater Reclamation Facility to move forward without expensive delays.
