SB946, SD1, RELATING TO WASTEWATER MANAGEMENT

I **support** this measure to establish that the prohibition against discharging wastewater or raw sewage into State waters after December 3, 2026 will not apply to treatment plants that have a treatment capacity of less than ten million gallons per day.

The Maui County Council has not had the opportunity to take a formal position on this measure. Therefore, I am providing this testimony in my capacity as an individual member of the Maui County Council.

I **support** this measure for the following reasons:

- 1. The current statute applies broadly to all wastewater dischargers, including small and rural treatment plants. This measure refines the law by exempting facilities under 10 MGD, ensuring fair and practical compliance standards.
- 2. Many smaller treatment plants lack the resources to implement costly anaerobic-digestion and energy-production systems. This measure prevents unnecessary financial strain on county governments and local communities.
- 3. By refining discharge regulations, this measure enables critical projects—such as the Central Maui Wastewater Reclamation Facility—to move forward without costly delays, ultimately supporting affordable-housing and environmental-protection efforts.
