



Since my business's beginning, we have captured continuous growth fueled by our Research and Development (R&D) and product development efforts within a deep-tech industry that is notoriously difficult to conquer for small startup businesses. The Hawaii Technology Development Corporation (HTDC) has been instrumental in assisting Nalu Scientific's growth as they have provided Nalu with pivotal funding to hire talented local professionals and have helped us to commercialize some of our developing products.

Specifically, HTDC's Hawaii Small Business Innovation Research (HSBIR) match grants, which match funding for up to 50% of one each of our phase I and phase II federal SBIR awards annually, has contributed to producing exceptional results for us.
