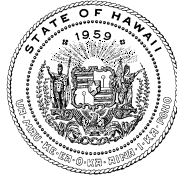

**Comments:**

Aloha Committee members of the Senate Committee on Economic Development and Tourism,

I am testifying in opposition to this resolution.

We do not need a new Aloha Stadium, nor do we need an Entertainment District. We should not be putting forth money towards developing a new Aloha Stadium or an Entertainment District. Hosting football games at the University of Hawaii on Campus is more appropriate and in line with how college sports are nationwide, and the Neil Blaisdel Center and the Hawaii Convention Center are sufficient venues for concerts and large entertainment gatherings, so we do not need to be spending more money to build additional facilities.

Additionally, we are not looking for visitors who simply come to Hawaii to experience something and return to their home, that is the current extractive model and we need to shift away from things that promote that form of tourism. Promoting Hawaii as an “Entertainment” experience or having an “Entertainment District” will not help to improve Hawaii’s relationship with tourism, will put a burden on Hawaii communities, and will do more harm than good (as is currently the case with the tourism industry) for the local communities. Currently, the only residents who support tourism activities are the ones profiting financially from them, which should be a strong indicator of the problem. We need to shift to activities that benefit the communities and environment of Hawaii in order to build a positive relationship with tourism and garner community support of the industry and its activities.

We need to move to a regenerative model of tourism by creating experiences and districts that focus on reforestation efforts, indigenous agriculture, and green-technology advancements, to attract the types of tourists that contribute to our communities, our environment, and our economy in a non-extractive way. Building and promoting these types of activities within our state - to hotels, local media, local channels - as well as nationally and internationally, is where we should be spending our tax dollars to truly improve Hawaii’s economy, environment, and relationship with tourism.

Lets focus on shifting tourism and moving away from extractive process. Lets move away from the same old ideas like a new Aloha Stadium, or an entertainment district. Lets start moving towards real change to improve tourism in Hawaii and the community’s relationship with the industry.
