Thank you for the opportunity to testify on Senate Concurrent Resolution 89 / Senate Resolution 72 requesting the Department of Agriculture to convene a working group to develop a plan to create an educational pathway in the University of Hawaii Community College system to equip interested students with the necessary entry level knowledge, skill set, expertise and advancement potential in the field of meat processing. The Hawaii Department of Agriculture (Department) supports the intent of the resolution and offers comments.

The Department's intent is to reestablish the meat inspection program, however currently there is no Meat Inspection Agreement with USDA-FSIS. The Department is



in the process of establishing meat inspector positions and re-organizing the Division to incorporate the positions within its structure. The Department will be working concurrently with USDA-FSIS to develop the Meat Inspection Agreement and once the positions have been filled and the program has been stood up, a review by USDA-FSIS will need to be conducted.

The Department would recommend that the University of Hawaii be the lead agency as the primary intent is to create an educational pathway for meat processing as meat processing encompasses a much broader area of which meat inspection is only a portion.

Aloha Chairs Gabbard and Kim, Vice-Chairs Richards and Kidani, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawai'i Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,800 farm family members statewide and serves as Hawai'i's voice of agriculture to protect, advocate, and advance the social, economic, and educational interests of our diverse agricultural community.

The Hawai'i Farm Bureau supports SCR 89 / SR 72, which calls for the development of an educational pathway in the University of Hawai'i Community College System to prepare students for careers in meat processing.

HFB has long supported efforts to expand local meat processing capacity as a critical component of Hawai'i's food security, invasive species management, and economic diversification. As outlined in our previous testimony on meat inspection and grant programs, our farmers and ranchers face persistent challenges due to limited processing infrastructure, regulatory barriers, and workforce shortages.

Workforce development is key. One of the major constraints facing local meat producers is the lack of trained meat processors. Without a qualified labor force, even expanded facilities will struggle to operate at capacity. SCR 89 / SR 72 offers a forward-thinking approach to this issue by proposing a comprehensive educational pathway that equips students with both technical skills and real-world experience in meat processing.

We especially support the resolution's emphasis on:

- Hands-on training and internships to prepare students for immediate employment;
- Instruction on food safety, carcass evaluation, and regulatory compliance;
- Inclusion of sustainability and responsible resource use in the curriculum;

• Collaboration between industry and educational institutions to ensure workforce readiness.

Building this educational foundation can help Hawai'i grow its local protein supply, reduce reliance on imports, and improve the economic viability of farming and ranching across the islands.

We appreciate the Legislature's recognition of this workforce gap and urge the swift convening of the working group to move this plan forward.

The Hawaii Cattlemen's Council **supports SCR 89/SR 72** which requests the Department of Agriculture to convene a working group to develop a plan to create an educational pathway in the University of Hawaii Community College system to equip interested students with the necessary entry knowledge, skill set, expertise, and advancement potential in the field of meat processing.

Increasing the resources to enter the field of meat processing is aligned with the State's goals to increase local food production. A butcher is versed on how to handle, store, and cut, and process meat – all critical factors in getting Hawaii's beef from the pasture to the plate. As the demand for local beef increases, we will need increase capacity at our meat processing facilities. This will also allow us to better meet the demand for the Farm to School program and processing of small animals, notably the invasive axis deer. An educational pathway focused on meat processing will ensure a strong pipeline of talent into the field.

We appreciate the opportunity to testify on this measure. The Hawaii Cattlemen's Council (HCC) is the Statewide umbrella organization comprised of the four county-level Cattlemen's Associations. Our member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 750 thousand acres of land in Hawaii, or 20% of the State's total land mass. We represent the interests of Hawaii's cattle producers.
