The East-West Center is pleased that the Thirty-third Legislature of the State of Hawai'i recognizes our efforts to serve as a bridge between Hawai'i, Pacific Island Nations, and other countries around the world in the areas of tropical agriculture, food security, public health, education, clean energy, and sustainable development.

We will continue to collaborate with governments, organizations, universities, and community stakeholders to fulfill our mission promoting better relations and understanding among the people and nations of the United States, Asia, and the Pacific through cooperative study, research, and dialogue.

For example, the Pacific Islands Development Program (PIDP) was formed at the specific request of the region's island leaders, including the Governor of the State of Hawai'i, George Ariyoshi. Since 1980, PIDP has served as a forum through which Pacific leaders discuss critical issues of development with interested countries, donors, nongovernmental organizations, and the private sector. On four occasions heads of governments, under the auspices of the Pacific Islands Conference of Leaders (PICL), have met with presidents of the United States at the East-West Center.

PIDP is the only East-West Center program whose activities have a defined geographic focus informed by both the area studies and disciplinary expertise of its staff and participants. PIDP activities draw heavily upon the expertise in other areas of the East-West Center.

We respectfully recommend a technical edit to Page 1, Lines 12 to 15, to include mention that the United States Agency for International Development has also played a significant role in good governance and capacity building as it relates to the free press and media professionals.

This resolution, which we strongly **SUPPORT**, is a critical step toward building stronger relations among the people of Hawai'i, Asia, and the Pacific. Thank you for your consideration.

Aloha. I have been a member of the EWC's Asian Studies Development Program, attending institutes on South Asia in 2010, China and Japan in 2012, and Korea in 2019. I have also been involved with the ASDP Alumni Chapter for the last 10 years, as Secretary, Vice-President-President-Elect, President, and now Past-President. I have also been involved in higher education, both as a professor and an administrator for 25 years. The multiweek workshops provided by the EWC and the ASDP in particular, have helped me design courses and coursework for my college and university students in areas in which I would have had no real academic training in before these workshops. This has included specific courses on Japanese Samurai in Film, Television and Culture, a course on British India, and lectures on Korean history and culture, on Korean politics, on Chinese literary censorship, and on numerous conference papers I would not have otherwise been involved with.

Moreover, the ASDP Alumni Chapter represents more than 3000 alumni who have attended institutes, workshops, and conferences sponsored by the EWC, and these educators have followed similar trajectories that I have done, providing information that helps to bridge East and West and brings people together with a greater understanding of the other's society and culture. By training these college educators to infuse their learning into their own courses, they have increased the reach of the EWC and the ASDP far beyond the direct work done in Hawaii.

This work needs to continue, especially in light of current tensions between the US and Asia, especially China.
