The Hague Treaty refers to the convention, adopted in the Hague in 1961, that created a simplified form of document certification for countries that joined the convention. Multiple accounts for the Apostilles and Certifications Special Fund were created and these have been consolidated into S-XX-300-S. The funds being transferred into S-XX-300-S was effectuated in order to centralize the accounts. This account S-XX-355-S will be discontinued and S-XX-300-S will be the account used for FY27 and onwards.
