STATEMENT OF OBJECTIONS TO SENATE BILL NO. 1102

Honorable Members
Thirty-Third Legislature
State of Hawai'i

Pursuant to Section 16 of Article III of the Constitution of the State of Hawai'i, I am returning herewith, without my approval, Senate Bill No. 1102, entitled "A Bill for an Act Relating to the Aircraft Rescue Fire Fighting Unit."

The purpose of this bill is to specify the appointment process and term for the Fire Chief of the Hawaii State Aircraft Rescue Fire Fighting Unit (Fire Chief) within the Department of Transportation Airports Division.

This bill is objectionable because the appointment process proposed in the bill is inconsistent with the selection process for other department leadership positions. Further, the need to obtain legislative approval for the appointment of the Fire Chief may delay the appointment of this critical leadership position and impact airport operations, safety, and readiness.

For the foregoing reasons, I am returning Senate Bill No. 1102 without my approval.

A BILL FOR AN ACT

RELATING TO THE AIRCRAFT RESCUE FIRE FIGHTING UNIT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 261, Hawaii Revised Statutes, is
2 amended by adding a new section to be appropriately designated
3 and to read as follows:

4 "§261- Hawaii state aircraft rescue fire fighting unit;
5 chief; term limits. (a) The director of transportation shall
6 appoint the fire chief of the Hawaii state aircraft rescue fire
7 fighting unit of the airports division of the department of
8 transportation from a list of three qualified candidates
9 submitted for consideration by the state fire council, subject
10 to the advice and consent of the senate.

11 (b) Each appointed fire chief of the Hawaii state aircraft
12 rescue fire fighting unit of the airports division of the
13 department of transportation shall serve a term of four years.
14 No fire chief shall be appointed to more than two consecutive
15 terms."

16 SECTION 2. New statutory material is underscored.






