# A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 PART I

2 SECTION 1. There are appropriated from the sources of  
3 funding indicated below to collective bargaining statewide (BUF  
4 102) the following sums or so much thereof as may be necessary  
5 to fund for fiscal biennium 2025-2027 all collective bargaining  
6 cost items in the agreement negotiated with the exclusive  
7 representative of collective bargaining unit (6):

13 SECTION 2. Funds appropriated by this part shall be  
14 allotted by the director of finance to the appropriate state  
15 departments for expenditure in the respective fiscal year for

2 SECTION 3. There are appropriated from the sources of  
3 funding indicated below to collective bargaining statewide (BUF  
4 102) the following sums or so much thereof as may be necessary  
5 to fund for fiscal biennium 2025-2027 the salary increases and  
6 other cost adjustments authorized by chapter 89C, Hawaii Revised  
7 Statutes, for state officers and employees who are excluded from  
8 collective bargaining and belong to the same compensation plans  
9 as those officers and employees within bargaining unit (6):

15 SECTION 4. Funds appropriated by this part shall be  
16 allotted by the director of finance to the appropriate state

20 SECTION 5. Salary increases and cost adjustments provided  
21 in this Act for any officer or employee whose compensation is



1 paid, in whole or in part, from federal, special, or other funds  
2 shall be paid wholly or proportionately, as the case may be,  
3 from the respective funds.

4 SECTION 6. Funds appropriated or authorized by this Act  
5 that are not expended or encumbered by June 30, 2026, and  
6 June 30, 2027, of the respective fiscal years, shall lapse as of  
7 those dates.

8 SECTION 7. This Act shall take effect on July 1, 3000.
