
A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated from the sources of
3 funding indicated below to collective bargaining statewide (BUF
4 102) the following sums or so much thereof as may be necessary
5 to fund for fiscal biennium 2025-2027 all collective bargaining
6 cost items in the agreement negotiated with the exclusive
7 representative of collective bargaining unit (14):

3 indicated below to collective bargaining statewide (BUF 102) the
4 following sums or so much thereof as may be necessary to fund
5 for fiscal biennium 2025-2027 the salary increases and other
6 cost adjustments authorized by chapter 89C, Hawaii Revised
7 Statutes, for state officers and employees who are excluded from
8 collective bargaining and belong to the same compensation plans
9 as those officers and employees within bargaining unit (14):

21 in this Act for any officer or employee whose compensation is



1 paid, in whole or in part, from federal, special, or other funds
2 shall be paid wholly or proportionately, as the case may be,
3 from the respective funds.

4 SECTION 6. Funds appropriated or authorized by this Act
5 that are not expended or encumbered by June 30, 2026, and
6 June 30, 2027, of the respective fiscal years, shall lapse as of
7 those dates.

8 SECTION 7. This Act shall take effect on July 1, 3000.
