RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Act 124, Session Laws of Hawaii 2015,
2	authorized the department of education until June 30, 2020, to
3	award high school diplomas to qualified persons who did not
4	receive a high school diploma as a result of compulsory
5	induction into active service in the armed services.
6	The purpose of this Act is to authorize the department of
7	education to award high school diplomas to qualified persons who
8	did not receive a high school diploma as a result of
9	compulsorily or voluntarily induction into active service in the
10	armed services of the United States or any person whose high
11	school education was interrupted due to wartime practices during
12	World War II, Korean War, or Vietnam War.
13	SECTION 2. Chapter 302A, Hawaii Revised Statutes, is
14	amended by adding to part II a new section to part II to be
15	appropriately designated and to read as follows:
16	"§302A- High school diploma for armed services veterans
17	and others. (a) The department is authorized to establish a

Veterans; High School Diploma; DOE

Description:

Authorizes the Department of Education to establish a program to award a high school diploma to qualified persons who did not receive a high school diploma as a result of compulsorily or voluntarily induction into the armed services of the United States and to persons whose high school education was interrupted due to wartime practices.

TITLE:

A BILL FOR AN ACT RELATING TO EDUCATION.

PURPOSE:

To authorize the Department to award high school diplomas to qualified persons who did not receive a high school diploma as a result of compulsory or voluntary induction into active service in the armed services of the United States or any person whose high school education was interrupted due to wartime practices during World War II, Korean War, or Vietnam War.

MEANS:

Add a new section to part II of chapter 302A, Hawaii Revised Statutes (HRS).

JUSTIFICATION:

Individuals whose high school education was interrupted during wartime periods did not have the opportunity to complete their high school education.

The Department was allowed to provide veterans a high school diploma pursuant to section 302A-431.9, HRS. However, this section expired on June 30, 2020. The Department would like to restart this diploma program for veterans and other individuals whose high school education was interrupted during wartime periods.

Impact on the public: For those individuals who were affected by wartime and were not able to complete their high school education, this bill would allow them to receive the high school diploma they would have earned. For veterans who were compulsorily or voluntarily inducted into the armed services during high school, a high school diploma acknowledges their commitment and sacrifice while also recognizing the skills and experience they gained during service. Receiving a diploma can have a significant positive impact on a

veteran's self-esteem, sense of accomplishment, and access to opportunities.

Impact on the department and other agencies:
The passage of this bill would allow the
Department to confer a high school diploma
on qualified individuals who were not able
to complete their education due to wartime
service or other circumstances during
wartime. The Department will vet each
candidate to ensure each candidate's
qualifications before conferring the
diploma.
