## A BILL FOR AN ACT

RELATING TO VIRAL HEPATITIS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of
- 2 health reports that hepatitis B and C viral infections are
- 3 associated with earlier deaths and higher death rates in Hawaii.
- 4 From 2000 to 2020, yearly mortality rates associated with
- 5 hepatitis B were higher in Hawaii compared to the entire United
- 6 States, with three times higher death rates in 2019 alone.
- 7 These death rates were notably higher among Asian and Pacific
- 8 Islander residents compared to the rest of the State.
- 9 Furthermore, from 2018 to 2021, eighty-eight per cent of
- 10 Hawaii's residents with hepatitis C died before reaching the
- 11 average life expectancy for the rest of the State. These deaths
- 12 continue to occur in Hawaii despite the availability of
- 13 effective tools to prevent, treat, and even cure these
- 14 infections. To address the burden of viral hepatitis in Hawaii,
- 15 the department of health has successfully leveraged community
- 16 and state partnerships to convene the "Hep Free 2030: The
- 17 Hawai'i Hepatitis Elimination Strategy 2020-2030". The coalition

- 1 has made progress towards eliminating viral hepatitis by
- 2 focusing on five priority areas: awareness and education; access
- 3 to services; advocacy at all levels; equity in everything; and
- 4 data for decision-making. In 2021, the legislature adopted
- 5 House Concurrent Resolution No. 59, H.D. 1, which found that
- 6 continued coordination and ongoing efforts are needed to further
- 7 implement the statewide strategy to eliminate viral hepatitis
- 8 types A, B, and C in Hawaii. However, there has been no state
- 9 funding dedicated to the prevention, management, and treatment
- 10 of viral hepatitis infections.
- 11 Accordingly, the purpose of this Act is to expand the
- 12 State's capacity to address preventable morbidity and mortality
- 13 from viral hepatitis B and hepatitis C among Hawaii residents
- 14 through established and innovative public health interventions.
- 15 SECTION 2. Chapter 325, Hawaii Revised Statutes, is
- 16 amended by adding four new sections to part V to be
- 17 appropriately designated and to read as follows:
- 18 "§325- Definitions. As used in this part, "department"
- 19 means the department of health.
- 20 §325- Hepatitis prevention program. (a) The
- 21 department may establish and administer a hepatitis prevention

16	program, the department may assist and cooperate with any or all	
17	territorial, state, and national organizations conducting	
18	educational programs for the prevention and control of hepatitis	
19	B and hepatitis C.	
20	§325- Comprehensive hepatitis B and hepatitis C	
21	prevention plan; screening; treatment support. The department	

1 shall develop a statewide, comprehensive hepatitis B and hepatitis C prevention plan. The plan shall include hepatitis B 2 3 and hepatitis C screening and services to support individuals 4 with hepatitis to access care and treatment. The department may work with other government agencies, health care providers, 5 6 health insurers, and community stakeholders to improve overall 7 rates of screening, diagnosis, and treatment of hepatitis B and 8 hepatitis C." 9 SECTION 3. Section 325-92, Hawaii Revised Statutes, is 10 amended to read as follows: 11 "[{]§325-92[}] Prenatal hepatitis B screening and 12 treatment of newborns. The department [of health] may adopt 13 rules necessary to provide appropriate hepatitis B screening of 14 pregnant women, including reporting and follow-up procedures for 15 newborns of hepatitis B carrier mothers. [The department may 16 provide medications necessary for the treatment of newborns of 17 indigent and medically indigent carrier mothers.]" SECTION 4. Section 325-91, Hawaii Revised Statutes, is 18 19 repealed.
