# A BILL FOR AN ACT

RELATING TO CONTROLLED-ENVIRONMENT AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there is a need for
- 2 a comprehensive approach to controlled-environment agriculture,
- 3 which can be accomplished through the construction of a
- 4 state-of-the-art controlled-environment agriculture research and
- 5 demonstration facility. This type of facility can be
- 6 established at a commercial scale with research and teaching
- 7 capabilities at the university of Hawaii at Manoa college of
- 8 tropical agriculture and human resilience's Magoon research and
- 9 teaching site in Manoa, Oahu. Upon completion, the facility and
- 10 associated activities can serve as a platform for research,
- 11 extension, education, and demonstration activities at commercial
- 12 scale to develop the next generation of researchers, industry
- 13 leaders, and practitioners.
- 14 The purpose of this Act is to authorize the issuance of
- 15 general obligation bonds and appropriate funds for the
- 16 development of a controlled-environment agriculture research and
- 17 demonstration facility.
