A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Electric bicycles have become widely available
- 2 for personal transportation and are popular among citizens of
- 3 all ages. In March 2023, there were five thousand three hundred
- 4 registered electric bicycles. This figure is potentially higher
- 5 considering that many owners do not register their bikes,
- 6 especially if they are purchased online.
- 7 Hawaii's law defines electric bicycles as a "low-speed
- 8 bicycle" with an assisted maximum speed of less than twenty
- 9 miles per hour. While electric bicycles are more convenient and
- 10 affordable than automobiles, they are a safety hazard when
- 11 ridden on sidewalks and in the middle of traffic lanes. Riders
- 12 often make modifications to electric bicycles with an
- 13 aftermarket delimiter allowing them to reach speeds of over
- 14 thirty miles per hour, which is nearly ten times faster than the
- 15 average walking speed of a person. Currently, persons under the
- 16 age of fifteen cannot operate an electric bicycle by law; yet

- 1 most e-bikes are ridden by adolescents between the ages of
- 2 twelve and seventeen.
- 3 In December of 2023, the department of transportation
- 4 reported nine bicyclist fatalities, the highest recorded number
- 5 of deaths among bicyclists in Hawaii to date. Furthermore,
- 6 electric bicycles can seriously injure pedestrians in a
- 7 collision and operators are at risk from motorists who do not
- 8 expect a small, silent, and motorized device riding near them.
- 9 The legislature finds, in the wake of a recent surge in
- 10 ridership accidents, it is critical to address this issue with a
- 11 comprehensive approach of public outreach in combination with
- 12 educational campaigns and stricter enforcement against the
- 13 unlawful use of electric bicycles.
- 14 The purpose of this Act is to:
- 15 (1) Categorize electric bicycles into three classes based
- on speed and operation;
- 17 (2) Establish more stringent regulations for electric
- 18 bicycles;
- 19 (3) Require electric bicycle manufacturers and
- distributors to apply a label to each electric bicycle

1		specifying the classification number, top assisted
2		speed, and motor wattage of the electric bicycle;
3	(4)	Impose a requirement that counties inform individuals
4		of the applicable traffic code, safety information,
5		and penalties for violations at the time of
6		registering a bicycle;
7	(5)	Authorize county police to confiscate bicycles for
8		certain offenses; and
9	(6)	Increase penalty fee paid upon redemption.

10	in disregard of the safety of persons or property shall be
11	assessed penalties as set forth in section 291C-161(b).
12	(f) No person shall operate an electric bicycle at a speed
13	other than is reasonable and prudent and having regard to the
14	actual and potential hazards and conditions then existing;
15	provided that no person shall operate an electric bicycle at a
16	speed greater than twenty-eight miles per hour.
17	(g) Any electric bicycle shall meet the specifications of
18	and requirements for lamps and other equipment on bicycles as
19	set out in section 291C-147; provided that in lieu of the
20	requirement of section 291C-147(b), every electric bicycle shall
21	be equipped with a lighted lamp that is visible from the rear.

1	(n) No person shall operate an electric bicycle unless the
2	person wears a safety helmet securely fastened with a chin
3	strap. The safety helmet shall meet the specifications of and
4	requirements for a bicycle helmet as set out in section 291C-
5	<u>150.</u>
6	(i) No electric bicycle shall be operated on a sidewalk,
7	sidewalk area, pedestrian overpass, or pedestrian underpass,
8	except as may be authorized by ordinances or rules adopted by
9	the county.
10	(j) No person shall tamper with or modify an electric
11	bicycle so as to change the motor-powered speed capability or
12	engagement of an electric bicycle, or the label indicating the
13	classification number.
14	(k) No person shall operate an electric bicycle after
15	January 1, 2029 unless the electric bicycle has affixed thereto
16	in a prominent location, a manufacturer's label providing the
17	classification number, top assisted speed, and motor wattage of
18	the electric bicycle.
19	(1) The counties by ordinance may impose restrictions and
20	conditions for the regulation and safe operation of electric
21	bicycles with regard to, but not limited to, the following:

redemption by its owner on payment of the cost of confiscation,



1 the registration fee due if applicable, the \$100 speed limiter removal penalty if applicable, and a penalty of [\$25] \$100. All 2 3 bicycles and mopeds not so redeemed shall be sold by the county 4 chief of police or director of finance or their authorized 5 representative, at public auction after first giving five days 6 public notice of the time and place of sale in the county where the sale is to be held. Sale shall be made for the best price 7 8 obtainable, which amount shall be forthwith paid over to the 9 director of finance, accompanied by a statement containing a 10 description of the bicycles or mopeds, their serial number, 11 makes, and any other marks of identification. The director of 12 finance, after deducting from the amount so received the amount 13 of the fee and penalty due and costs of giving public notice, 14 shall pay any surplus to the previous registered owners of the 15 bicycles or mopeds. If at the expiration of ninety days the 16 previous registered owners remain unknown, the surplus shall be **17** paid into the treasury of the county, as a government 18 realization, and all claims to the sums shall be forever 19 barred." 20 SECTION 10. The department of transportation shall develop

statewide safety and training programs to educate the public



- 1 about general electric bicycle riding safety, rules of the road,
- 2 and laws pertaining to electric bicycles, no later than twenty
- 3 days prior to the convening of the regular session of 2026. The
- 4 safety and training programs shall be developed in collaboration
- 5 with relevant stakeholders. The department shall inform
- 6 individuals of the applicable traffic code, safety information,
- 7 and penalties for violations at the time of registering an
- 8 electric bicycle.
- 9 SECTION 11. This Act does not affect rights and duties
- 10 that matured, penalties that were incurred, and proceedings that
- 11 were begun before its effective date.
- 12 SECTION 12. Statutory material to be repealed is bracketed
- 13 and stricken. New statutory material is underscored.
- 14 SECTION 13. This Act shall take effect on July 1, 2025;
- 15 provided that:
- 16 (1) Section 2(k) shall take effect on January 1, 2029; and
- 17 (2) Section 3 shall take effect on January 1, 2027.
