

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
THIRTEENTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The director of finance is authorized to issue general obligation bonds in the sum of \$80,500,000 or so much thereof as may be necessary and the same sum or so much thereof as may be necessary is appropriated for fiscal year 2025-2026 for the purpose of capital improvement projects for the thirteenth representative district, as follows:

20 deteriorated due to flooding, river



1 diversions, erosion, and sea level

2 rise.

17 6. Paia bypass

18 Plans, design, and construction for
19 Paia bypass.

20 Plans \$5,000,000

21 Design \$5,000,000





5 SECTION 2. The appropriation made for the capital
6 improvement projects authorized by this Act shall not lapse at
7 the end of the fiscal year for which the appropriation is made;
8 provided that all moneys from the appropriation unencumbered as
9 of June 30, 2028, shall lapse as of that date.

10 SECTION 3. This Act shall take effect on July 1, 2025.
