A BILL FOR AN ACT

RELATING TO TRAIL ACCESSIBILITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that individuals with 2 disabilities face unique challenges when seeking to access and 3 enjoy public lands, state parks, and wilderness areas. 4 ability to connect with nature is a fundamental right that 5 fosters physical well-being, mental health, and community 6 inclusion. Accessible trail programs designed to enhance the 7 experiences of disabled individuals in outdoor recreational 8 areas have proven effective in fostering inclusivity, enriching 9 lives, and promoting equity. Research demonstrates the positive 10 impacts of programs such as the Colorado parks and wildlife 11 system, which offers adaptive equipment and accessible trails 12 through its "track-chair program". This initiative provides 13 individuals with mobility impairments access to state park 14 trails previously deemed inaccessible. The program has received 15 widespread acclaim for improving physical and emotional health 16 outcomes among participants and exemplifies a successful 17 partnership between public funding and private sponsorship.

- 1 Similarly, the Mount Shasta trail association in California has
- 2 implemented a series of wheelchair-accessible wilderness trails.
- 3 These include widened paths, specially designed viewpoints, and
- 4 signage to cater to a wider range of individuals with
- 5 disabilities. These efforts have significantly increased
- 6 participation rates of individuals with disabilities in
- 7 wilderness activities and established a model for other states
- 8 to emulate.
- **9** The legislature recognizes that the State is renowned for
- 10 its natural beauty and recreational opportunities and must
- 11 ensure that its public lands are accessible to all of its
- 12 residents and visitors. Establishing an inclusive program to
- 13 enhance accessibility will provide individuals with disabilities
- 14 an opportunity to engage with Hawaii's diverse ecosystems while
- 15 promoting values of equity and sustainability. Further, by
- 16 leveraging existing successful models from other states,
- 17 including these in Colorado and California, the State can ensure
- 18 its own program will be efficient and effective.
- 19 It is the legislature's intent that this Act shall serve as
- 20 a commitment to ensuring that all individuals, regardless of

2	benefit f	rom Hawaii's unique natural landscapes.
3	Acco	rdingly, the purpose of this Act is to:
4	(1)	Establish an accessible wilderness and state parks
5		trails program to enhance outdoor recreational
6		opportunities for individuals with disabilities;
7	(2)	Promote partnerships with public and private
8		organizations to fund and sustain the program, and
9		enshrine the principles of inclusivity, equity, and
10		environmental stewardship in the design and
11		implementation of the program; and
12	(3)	Establish the accessible wilderness and state parks
13		trails program special fund.
14	SECT	ION 2. Chapter 198D, Hawaii Revised Statutes, is
15	amended by adding a new part to be appropriately designated and	
16	to read as follows:

19	§198	D- Definitions. For the purposes of this part:
20	"Acc	essible trail" means a designated pathway in a
21	wildernes	s area or state park that is constructed or modified to

- 1 meet the needs of individuals with disabilities in compliance
- 2 with applicable federal and state accessibility standards.
- 3 "Adaptive equipment" means a specialized device or
- 4 technology designed to enable an individual with a disability to
- 5 access and utilize outdoor recreational facilities, including
- 6 but not limited to wheelchairs, track-chairs, and other mobility
- 7 aids.
- 8 "Division" means the division of state parks of the
- 9 department of land and natural resources.
- 10 §198D- Accessible wilderness and state parks trails
- 11 program; established; duties; report; rules. (a) There is
- 12 established within the division an accessible wilderness and
- 13 state parks trails program to be administered by the department.
- 14 The program shall:
- 15 (1) Develop, construct, and maintain accessible trails
- within the State's wilderness areas and state parks;
- 17 (2) Provide adaptive equipment for individuals with
- disabilities to enhance accessibility to state park
- 19 facilities; and
- 20 (3) Promote equity in access to the State's natural
- resources and recreational opportunities.

1	(b)	The department shall:
2	(1)	Identify and prioritize trails and park areas for
3		accessibility upgrades;
4	(2)	Procure and maintain adaptive equipment for public
5		use;
6	(3)	Collaborate with stakeholders, including disability
7		advocacy groups, local communities, and private
8		organizations to ensure that program goals align with
9		community needs;
10	(4)	Secure funding via legislative appropriations, federal
11		grants, and public-private partnerships; and
12	(5)	Ensure that all projects under the accessible
13		wilderness and state parks trails program comply with
14		applicable federal law, including the Americans with
15		Disabilities Act, and state accessibility standards.
16	(c)	The department shall submit a report, including any
17	proposed	legislation, to the legislature no later than twenty
18	days prio	r to the convening of each regular session, detailing:
19	(1)	Program activities and accomplishments;
20	(2)	Total expenditures and funding sources; and

1	(3)	ruture plans for the expansion of trail accessibility
2		and adaptive equipment availability.
3	(d)	The department may adopt rules pursuant to chapter 91
4	necessary	to implement this part, including but not limited to:
5	(1)	Procedures for the use of adaptive equipment;
6	(2)	Scheduling and reservations for accessible trails; and
7	(3)	Standards for new or upgraded facilities.
8	§198I	O- Accessible wilderness and state parks trails
9	program sp	pecial fund; established. (a) There is established in
10	the state	treasury an accessible wilderness and state parks
11	trails pro	ogram special fund into which shall be deposited:
12	(1)	Appropriations by the legislature into the special
13		fund;
14	(2)	Gifts, donations, and grants from public agencies,
15		including the United States government and private
16		persons; and
17	(3)	All interest earned on or accrued to moneys deposited
18		in the special fund.
19	(b)	The special fund shall be administered by the

1	(0)	Subject to registative oversight, the moneys in the	
2	special f	und shall be expended for:	
3	(1)	Permanent and temporary staff positions to administer	
4		the special fund;	
5	(2)	Administrative and operational costs of the accessible	
6		wilderness and state parks trails program; and	
7	(3)	The construction or modification of a wilderness area	
8		or state park to meet the needs of individuals with	
9		disabilities in compliance with applicable federal and	
10		state accessibility standards."	
11	SECT	ION 3. There is appropriated out of the general fund	
12	the sum o	f \$ or so much thereof as may be necessary	
13	for fisca	l year 2025-2026 and the same sum or so much thereof as	
14	necessary	for fiscal year 2026-2027 to be deposited into the	
15	accessible wilderness and state parks trails program special		
16	fund.		
17	SECT	ION 4. There is appropriated out of the accessible	
18	wildernes	s and state parks trails program special fund the sum	
19	of \$	or so much thereof as may be necessary for fiscal	
20	year 2025	-2026 and the same sum or so much thereof as necessary	
21	for fisca	l year 2026-2027 for the expansion of trail	

- 1 accessibility and adaptive equipment availability at wilderness
- 2 areas and state parks pursuant to this Act.
- 3 The sums appropriated shall be expended by the department
- 4 of land and natural resources for the purposes of this Act.
- 5 SECTION 5. This Act shall take effect on July 1, 2025.
