### A BILL FOR AN ACT

RELATING TO A HAWAII TEACHER REGISTERED APPRENTICESHIP PROGRAM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State's public 2 schools have been facing severe teacher shortages for years with 3 little support to address this issue. The department of 4 education, along with the Hawaii teacher standards board as 5 sponsor, seeks to create and bolster the state teacher 6 apprenticeship program through mentor training, creating mentor 7 apprenticeship curriculum, monitoring, and providing 8 coordination for the creation of multiple pathways for 9 apprentices to become teachers.

10 The legislature further finds that the lack of 11 apprenticeship programs to assist future teachers in obtaining 12 the necessary licenses and gaining workforce experience 13 contributes to poor retention, lack of diversity, and lack of more recruitment in local communities for individuals to become 14 teachers in state public schools. Hawaii needs a structured 15 16 teacher registered apprenticeship program to boost retention, diversity, and recruitment among the State's teachers in public 17

1 schools. The department of education will need positions to 2 manage, create, and evaluate metrics for federal and state 3 reporting requirements of such a teacher registered 4 apprenticeship program. 5 The purpose of this Act is to establish and appropriate 6 funds for a teacher registered apprenticeship program to 7 support, recruit, develop, and retain teachers for Hawaii's 8 public schools. 9 SECTION 2. Chapter 302A, Hawaii Revised Statutes, is 10 amended by adding a new section to part III, subpart D, to be 11 appropriately designated and to read as follows: "§302A- Hawaii teacher registered apprenticeship 12 13 program. (a) The board shall develop and implement a Hawaii teacher registered apprenticeship program, the purpose of which 14 15 shall be to recruit, retain, and increase the number of teachers 16 throughout the State. (b) The board shall work with the department of labor and 17 industrial relations to develop the program. The board may work 18 19 with board-approved institutions of higher education that are 20 authorized Hawaii post-secondary education programs with a 21 physical presence in the State and other education stakeholders

1 registered apprenticeship program requirements and meets all 2 other teaching licensing requirements. (f) The board shall determine mentor qualifications and 3 4 requirements in compliance with federal Department of Labor 5 regulations, including mentor professional development, length 6 of time apprentices are required to be in their classrooms, and 7 meetings to update the educational providers and the board with assistance apprentices may need. Mentors shall receive a 8 9 stipend of \$4,000 when requirements established pursuant to this 10 subsection are met." 11 SECTION 3. There is appropriated out of the general 12 revenues of the State of Hawaii the sum of \$426,848 or so much 13 thereof as may be necessary for fiscal year 2025-2026 to 14 establish the Hawaii teacher registered apprenticeship program pursuant to section 302A- , Hawaii Revised Statutes; provided 15 16 that the funds appropriated shall be used as follows: 17 \$200,000 for stipends for mentors in the program; (1)\$116,712 for one full-time equivalent (1.0 FTE) 18 (2) 19 business manager officer II position; and 20 (3) \$110,136 for one full-time equivalent (1.0 FTE) 21 institutional analyst II position.
