### A BILL FOR AN ACT

RELATING TO HAZARDOUS TREE REMOVAL.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of 2 land and natural resources' division of forestry and wildlife
- 3 oversees nearly one million acres of public land across the
- 4 State, including forest areas that abut residential property.
- 5 According to the 2023 State of Hawaii hazard mitigation plan,
- 6 between January 2018 and December 2021, windstorm events alone
- 7 significantly contributed to downed trees, which caused power
- 8 outages, road closures, significant traffic delays, serious
- 9 injuries, and several hundred thousand dollars' worth of damage
- 10 to crops and property across the State. Furthermore, the hazard
- 11 mitigation plan asserts that natural habitats, such as forests,
- 12 are some of the most vulnerable to damage from natural weather
- 13 events.
- 14 The legislature further finds that state-owned forests
- 15 adjacent to residential areas must be maintained to protect the
- 16 health and safety of communities from the possibility of downed
- 17 trees during storms, wildfires, high winds, or other natural

- 1 events, because fallen trees and branches from inadequately
- 2 managed forest areas can cause severe damage to homes, vehicles,
- 3 and critical infrastructure and endangers the lives of residents
- 4 and first responders. Effective monitoring and management of
- 5 state forests abutting residential areas, including routine
- 6 assessments and removal of dangerous tress, are necessary
- 7 functions of the division of forestry and wildlife.
- 8 Therefore, the purpose of this Act is to appropriate funds
- 9 to the department of land and natural resources' division of
- 10 forestry and wildlife for the assessment and removal of
- 11 hazardous trees on state lands.
- 12 SECTION 2. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$ or so
- 14 much thereof as may be necessary for fiscal year 2025-2026 and
- 15 the same sum or so much thereof as may be necessary for fiscal
- 16 year 2026-2027 for the division of forestry and wildlife of the
- 17 department of land and natural resources to assess and remove
- 18 hazardous trees on state lands across Hawaii; provided that the
- 19 sum shall be allocated for the following islands:
- 20 (1) \$ for Kauai;
- 21 (2) \$ for Oahu;

1	(3) \$ for Maui; and
2	(4) \$ for Hawaii island.
3	The sums appropriated shall be expended by the departmen
4	of land and natural resources for the purposes of this Act.

SECTION 3. This Act shall take effect on July 1, 3000.
