

A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
THIRTY-SIXTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The director of finance is authorized to issue
general obligation bonds in the sum of \$46,524,000 or so much
thereof as may be necessary and the same sum or so much thereof
as may be necessary is appropriated for fiscal year 2025-2026
for the purpose of capital improvement projects for the thirty-
sixth representative district, as follows:

10 provided that all moneys from the appropriation unencumbered as
11 of June 30, 2028, shall lapse as of that date.

12 SECTION 3. This Act shall take effect on July 1, 2025.
