

A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE SECOND REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The director of finance is authorized to issue
- 2 general obligation bonds in the sum of \$8,001,000 or so much
- 3 thereof as may be necessary and the same sum or so much thereof
- 4 as may be necessary is appropriated for fiscal year 2025-2026
- 5 for the purpose of capital improvement projects for the second
- 6 representative district, as follows:
- 7 1. Waiakea Intermediate School
- 8 Plans and equipment and appurtenances
- for general maintenance and facility 9
- 10 improvements.
- 11 Plans \$1,000
- 12 Equipment \$2,500,000
- 13 Total funding \$2,501,000
- 14 The sum appropriated for this capital improvement project
- 15 shall be expended by the department of education.
