A BILL FOR AN ACT

RELATING TO CESSPOOL CLOSURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The legislature finds that there are more than 1 SECTION 1. 2 eighty thousand cesspools across the State that pollute 3 groundwater and nearshore water and threaten environmental and human health, and that there is a compelling state interest to 4 5 close such cesspools. Pursuant to Act 125, Session Laws of 6 Hawaii 2017 (Act 125), cesspools must be closed by January 1, 7 2050, and replaced with approved systems or connected to sewer 8 infrastructure, however the cost impediments to homeowners to 9 comply with Act 125 have made the conversions and connections **10** financially challenging. 11 The legislature further finds that in some areas that 12 currently have cesspools, counties are planning to install new 13 wastewater infrastructure to connect existing homes to county 14 sewers. The legislature also finds that connecting homes to 15 sewers to meet the requirements of Act 125 is a solution that 16 should be encouraged in all areas where this is feasible because

it is cost-effective for homeowners and treats wastewater to a

- 1 higher standard than the most common individual wastewater
- 2 systems that might replace cesspools in more rural areas, such
- 3 as septic systems.
- 4 The legislature believes that offering a subsidy to
- 5 homeowners for their portion of the sewer lateral connections
- 6 and to help cover the cost of cesspools closures for specific
- 7 projects will encourage counties to plan more sewer
- 8 infrastructure expansions in the future, ease the burden on
- 9 homeowners, and protect the health of Hawaii's environment and
- 10 people. Certain projects already in progress in Ewa Beach on
- 11 Oahu and in Keaukaha on Hawaii island are good candidates to
- 12 pilot a program that offers this type of assistance in order to
- 13 determine if such a program should be established on an ongoing
- 14 basis to help homeowners within sewer improvement districts with
- 15 their portion of the costs.
- 16 Such a program would provide an incentive for counties to
- 17 look for additional future projects that might be facilitated by
- 18 the availability of these funds.
- 19 The purpose of this Act is to appropriate funds to create
- 20 residential sewer connection and cesspool closure subsidy pilot

- 3 SECTION 2. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ or so

- 18 legislation, to the legislature no later than twenty days prior
- 19 to the convening of the regular session of 2026.
- 20 SECTION 5. This Act shall take effect on July 1, 3000.
