A BILL FOR AN ACT

RELATING TO GOVERNMENT PROCEDURES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Intergovernmental task force for permit
- 2 simplification. (a) There shall be established within the
- 3 house of representatives the intergovernmental task force for
- 4 permit simplification to identify actions taken, challenges
- 5 encountered, and legislative measures necessary to facilitate,
- 6 expedite, and coordinate state and intergovernmental development
- 7 permit processes.
- **8** (b) The speaker of the house of representatives shall
- 9 appoint one member of the house of representatives to serve as
- 10 chair of the intergovernmental task force for permit
- 11 simplification.
- 12 (c) The membership of the intergovernmental task force for
- 13 permit simplification shall include representatives of the
- 14 following bodies, to be designated by the body's head or, in the
- 15 case of a board or commission, by the chairperson:
- 16 (1) The office of the governor;

- 1 (e) Representatives shall be designated no later than
- 2 August 1, 2025.
- 3 (f) The task force shall hold its first meeting no later
- 4 than sixty days after the finalization of its members or
- 5 October 1, 2025, whichever is earlier.
- 6 (g) The members of the intergovernmental task force for
- 7 permit simplification shall serve without compensation for their
- 8 service on the task force.
- 9 (h) The task force shall cease on June 30, 2027.
- 10 SECTION 2. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2025-2026 and
- 13 the same sum or so much thereof as may be necessary for fiscal
- 14 year 2026-2027 for the staffing and administrative costs of the
- 15 intergovernmental task force for permit simplification.
- 16 The sums appropriated shall be expended by the house of
- 17 representatives for the purposes of this Act.
- 18 SECTION 3. This Act shall take effect on July 1, 3000.
