

A BILL FOR AN ACT

RELATING TO HOMELESSNESS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that homelessness has and
- 2 continues to remain a persistent problem throughout the State.
- 3 To address homelessness in the State, the department of human
- 4 services' homeless programs office contracts with homeless
- 5 service providers to provide homeless outreach, shelter, case
- 6 management, and all of the attendant services to transition
- 7 homeless individuals from the street to transitional housing and
- 8 ultimately to some form of supportive or permanent housing.
- 9 The legislature further finds that except for an
- 10 appropriation made in the regular session of 2024 for a five per
- 11 cent budget increase, there has been no increase in funding for
- 12 the department of human services' homeless service contracts for
- 13 over ten years, even as costs for wages, utilities, and all
- 14 administrative services of running all businesses have
- 15 increased. Additionally, the five per cent increase into the
- 16 base budget of the homeless programs office in 2024 was

- 1 insufficient to cover full program costs and the rising costs of
- 2 living for providers.
- 3 As a result, homeless service providers contracted with the
- 4 homeless programs office have attempted to fill funding
- 5 shortfalls through their own fundraising efforts but can no
- 6 longer bridge the expanding gap. If state funding is not
- 7 increased to meet actual service delivery costs, contracted
- 8 homeless service providers will be forced to either decline
- 9 contracts or reduce essential services, despite rising community
- 10 needs.
- 11 The purpose of this Act is to increase the base budget of
- 12 the department of human services' homeless programs office to
- 13 address the need for homeless services and ensure that these
- 14 organizations can address the high cost of living for their
- 15 employees so that the critical work with Hawaii's homeless
- 16 populations is maintained.
- 17 SECTION 2. There is appropriated out of the general
- 18 revenues of the State of Hawaii the sum of \$8,175,000 or so much
- 19 thereof as may be necessary for fiscal year 2025-2026 and the
- 20 same sum or so much thereof as may be necessary for fiscal year
- 21 2026-2027 for homeless programs in the State; provided that the

- 1 appropriated amount shall be in addition to the homeless
- 2 programs office's base budget of \$27,250,000 for fiscal year
- **3** 2025-2026.
- 4 The sums appropriated shall be expended by the department
- 5 of human services for the purposes of this Act.
- 6 SECTION 3. This Act shall take effect on July 1, 2025.
