A BILL FOR AN ACT

RELATING TO GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that existing law
- 2 specifies the circumstances under which an employees' retirement
- 3 system retirant may be reemployed without the suspension of the
- 4 retirant's benefits and to provide remedies for the employees'
- 5 retirement system if a retirant is reemployed in violation of
- 6 chapter 88, Hawaii Revised Statutes, and any administrative rule
- 7 adopted thereunder.
- 8 The legislature further finds that there is a labor
- 9 shortage that makes it difficult to fill investigator positions
- 10 in the department of the attorney general and school resource
- 11 officer positions.
- Accordingly, the purpose of this Act is to establish
- 13 additional categories of retirants who may be employed without
- 14 reenrollment in the employees' retirement system and without
- 15 loss or interruption of benefits.
- 16 SECTION 2. Section 88-9, Hawaii Revised Statutes, is
- 17 amended as follows:

2	"(d)	A retirant may be employed without reenrollment in					
3	the system and suffer no loss or interruption of benefits						
4	provided by the system or under chapter 87A if the retirant is

6	(1)	As an elective officer pursuant to section 88-42.6(c)					
7		or as a member of the legislature pursuant to section					
8		88-73(d);					
9	(2)	As a juror or precinct official;					
10	(3)	As a part-time or temporary employee excluded from					
11		membership in the system pursuant to section 88-43, as					
12		a session employee excluded from membership in the					
13		system pursuant to section 88-54.2, as the president					
14		and chief executive officer of the Hawaii tourism					
15		authority excluded from membership in the system					
16		pursuant to section 201B-2, or as any other employee					
17		expressly excluded by law from membership in the					
18		system; provided that:					
19		(A) The retirant was not employed by the State or a					
20		county during the six calendar months prior to					
21		the first day of reemployment; and					

1		(B)	No agreement was entered into between the State
2			or a county and the retirant, prior to the
3			retirement of the retirant, for the return to
4			work by the retirant after retirement;
5	(4)	In a	position identified by the appropriate
6		juri	sdiction as a labor shortage or difficult-to-fill
7		posi	tion; provided that:
8		(A)	The retirant was not employed by the State or a
9			county during the twelve calendar months prior to
10			the first day of reemployment;
11		(B)	No agreement was entered into between the State
12			or a county and the retirant, prior to the
13			retirement of the retirant, for the return to
14			work by the retirant after retirement; and
15		(C)	Each employer shall contribute to the pension
16			accumulation fund the required percentage of the
17			rehired retirant's compensation to amortize the
18			system's unfunded actuarial accrued liability;
19			[or]
20	(5)	As a	teacher or an administrator in a teacher shortage
21		area	identified by the department of education or in a

1		char	ter school or as a mentor for new classroom		
2		teachers; provided that:			
3		(A)	The retirant was not employed by the State or a		
4			county during the twelve calendar months prior to		
5			the first day of reemployment;		
6		(B)	No agreement was entered into between the State		
7			or a county and the retirant prior to the		
8			retirement of the retirant, for the return to		
9			work by the retirant after retirement; and		
10		(C)	The department of education or charter school		
11			shall contribute to the pension accumulation fund		
12			the required percentage of the rehired retirant's		
13			compensation to amortize the system's unfunded		
14			actuarial accrued liability[-];		
15	<u>(6)</u>	<u>As a</u>	school resource officer identified by the		
16		depa	rtment of law enforcement as a labor shortage or		
17		diff	icult-to-fill position; provided that:		
18		(A)	The retirant was not employed by the State or a		
19			county during the six calendar months prior to		
20			the first day of reemployment;		

1		<u>(B)</u>	No agreement was entered into between the State
2			or a county and the retirant prior to the
3			retirement of the retirant, for the return to
4			work by the retirant after retirement; and
5		<u>(C)</u>	The department of law enforcement shall
6			contribute to the pension accumulation fund the
7			required percentage of the rehired retirant's
8			compensation to amortize the system's unfunded
9			actuarial accrued liability; or
10	(7)	<u>As a</u>	n investigator identified by the department of the
11		atto	rney general as a labor shortage or difficult-to-
12		fill	position; provided that:
13		(A)	The retirant was not employed by the State or a
14			county during the six calendar months prior to
15			the first day of reemployment;
16		(B)	No agreement was entered into between the
17			retirant and the State or a county, prior to the
18			retirement of the retirant, for the return to
19			work by the retirant after retirement; and
20		(C)	The department of the attorney general shall
21			contribute to the pension accumulation fund the

1	required percentage of the rehired retirant's
2	compensation to amortize the system's unfunded
3	actuarial accrued liability."
4	2. By amending subsection (f) to read:
5	"(f) No later than twenty days prior to the convening of
6	each regular legislative session, the director of human
7	resources of the appropriate state jurisdiction or the human
8	resources management chief executive of each county shall submit
9	an annual report to the legislature detailing the employment of
10	retirants under [paragraphs (4) and (5) of subsection (d),
11	subsection (d) (4) , (5) , (6) , and (7) , including the number and
12	positions of retirants."
13	SECTION 3. Statutory material to be repealed is bracketed
14	and stricken. New statutory material is underscored.
15	SECTION 4. This Act shall take effect on July 1, 3000.

Description:

Allows a retirant to be employed without reenrollment in the Employees' Retirement System and without loss or interruption of retirement benefits if the retirant is employed as a school resource officer or investigator in positions identified by the Department of Law Enforcement or the Department of the Attorney General, respectively, as a labor shortage or difficult-to-fill positions, subject to certain conditions. Requires the Director of Human Resources of the appropriate state jurisdiction or the human resources management chief executive of each county to include in their annual reports to the Legislature, details on the employment of retirants as school resource officers or investigators. Effective 7/1/3000. (HD1)
