### A BILL FOR AN ACT

RELATING TO TRAFFIC CITATIONS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 291C-165, Hawaii Revised Statutes, is amended by amending subsection (b) to read as follows: 2 3 In every case when a citation is issued, the original of the citation shall be given to the violator[+] and a carbon 4 copy of the citation shall be sent by certified or registered 5 6 mail, with a return receipt that is postmarked within five 7 business days of the time of the incident, to the registered 8 owner of the vehicle at the address on record at the vehicle licensing division; provided that: 9 (1) In the case of an unattended vehicle, the original of 10 the citation shall be affixed to the vehicle as 11 12 provided for in section 291C-167; or 13 In the case of: (2) 14 A vehicle utilizing the high occupancy vehicle 15 lane illegally; or

1	(B) A vehicle illegally utilizing a parking space
2	reserved for persons with disabilities, where the
3	violator refuses the citation,
4	the original of the citation shall be sent by certified or
5	registered mail, with a return receipt that is postmarked within
6	forty-eight hours of the time of the incident, as provided in
7	section 291C-223 for vehicles illegally utilizing the high
8	occupancy vehicle lane, or within seventy-two hours of the time
9	of the incident for vehicles illegally utilizing a parking space
10	reserved for persons with disabilities, to the registered owner
11	of the vehicle at the address on record at the vehicle licensing
12	division. If the end of the applicable forty-eight or seventy-
13	two hour period or five business days falls on a Saturday,
14	Sunday, or holiday, then the ending period shall run until the
15	end of the next day that is not a Saturday, Sunday, or holiday;
16	provided that the administrative judge of the district courts
17	may allow a carbon copy of the citation to be given to the
18	violator or affixed to the vehicle and provide for the
19	disposition of the original and any other copies of the
20	citation."
