A BILL FOR AN ACT

RELATING TO ENVIRONMENTAL PROTECTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the State is
- 2 committed to maintaining the stringent environmental standards
- 3 that govern the operations of waste-to-energy facilities and
- 4 preventing any backsliding on existing emission limits that may
- 5 be proposed by the United States Environmental Protection
- 6 Agency.
- 7 Therefore, to protect against any weakening of applicable
- 8 emission limits by the United States Environmental Protection
- 9 Agency, the purpose of this Act is to require an owner or
- 10 operator of a waste-to-energy facility to comply with certain
- 11 United States Environmental Protection Agency regulations as
- 12 they existed on December 31, 2024, unless the emission limits
- 13 are made more stringent by federal regulations or by the state
- 14 air pollution control permit issued to that owner or operator by
- 15 the department of health.
- 16 SECTION 2. An owner or operator of a waste-to-energy
- 17 facility shall comply with the emission limitations of the

Sunsets 6/30/2027. Effective 7/1/3000. (HD2)
