A BILL FOR AN ACT

RELATING TO FISHPONDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that before Western
- 2 contact, researchers estimate that there were approximately four
- 3 hundred eighty-eight loko i'a (fishponds) in Hawaii. An
- 4 inventory conducted in 1901 found around three hundred sixty
- 5 loko i'a across the State, with about ninety-nine of them in
- 6 active use at the time.
- Over the past two centuries, a range of factors, including
- 8 changes in economic and social systems, land use and
- 9 development, tsunamis, sedimentation, climate change, and the
- 10 introduction of invasive species, have impacted loke i'a to
- 11 varying degrees. While some loko i'a remain relatively intact,
- 12 others have fallen into disrepair, are in ruins, or have been
- 13 destroyed to make way for development.
- 14 In recent years, a statewide movement to restore and
- 15 revitalize fishponds has gained momentum, with around forty-nine
- 16 fishponds currently managed by local community organizations and
- 17 kia'i loko (fishpond quardians).



1 Loko i'a are not only essential for preserving traditional 2 native Hawaiian culture and practices, but also play a vital 3 role in enhancing the State's ecological well-being and offer 4 opportunities to protect cultural resources and expand food 5 security and community-based resource management. 6 Many fishponds in Hawaii are publicly owned. However, no 7 comprehensive database exists to inventory these fishponds, assess their conditions, or evaluate their potential for 8 9 restoration. To fulfill its responsibility as a steward of the 10 'āina and ensure that future generations can benefit from the 11 opportunities fishponds provide, the legislature believes that 12 the State must have more complete data on these important 13 resources and deems this Act to be a law of statewide concern. 14 Accordingly, the purpose of this Act is to establish a 15 working group within the university of Hawaii sea grant program 16 to develop an inventory of all fishponds on state land. 17 SECTION 2. (a) There is established a fishpond inventory

working group within the university of Hawaii sea grant college

program for administrative purposes.

1 (b) The working group shall create an inventory of all 2 fishponds on state land that includes the following information 3 for each fishpond: 4 (1)The traditional name; 5 (2) The type, style, or function; 6 (3) The approximate acreage, including submerged lands within the fishpond; (4) The tax map key, if available; 8 9 (5) An analysis of the current and historical condition, 10 including sites in ruin or destroyed; 11 Historical uses and permits associated with the (6) 12 fishpond; 13 The surrounding land uses; and (7) 14 Any other relevant data as determined by the working (8) 15 group. The working group shall create: 16 (c) 17 (1)A map of all fishponds on state land; and 18 (2) A literature review, including a review of Hawaiian 19 language newspapers that includes any relevant sources 20 used for collecting the inventory data.

6	(2)	The administrator of the office of conservation and

11	(e)	The chair of the working group shall invite the
12	following	individuals to serve as members of the working group:
13	(1)	One representative from Hui Mālama Loko I'a; and
14	(2)	Any other persons deemed relevant by the chair.
15	(f)	Members of the working group shall serve without
16	compensati	ion but shall be reimbursed for expenses, including
17	travel exp	penses, necessary for the performance of their duties.
18	(g)	The working group shall submit an interim report of
19	its findir	ngs and recommendations, including any proposed
20	legislatio	on, to the legislature no later than November 1, 2026.

- 1 (h) The working group shall submit a final report of its
- 2 findings and recommendations, including any proposed
- 3 legislation, to the legislature no later than November 1, 2027.
- 4 (i) The working group shall be dissolved on June 30, 2028.
- 5 SECTION 3. There is appropriated out of the general
- 7 much thereof as may be necessary for fiscal year 2025-2026 and
- 8 the same sum or so much thereof as may be necessary for fiscal
- 9 year 2026-2027 to create an inventory of all fishponds on state
- 10 land.
- 11 The sums appropriated shall be expended by the university
- 12 of Hawaii for the purposes of this Act.
- 13 SECTION 4. This Act shall take effect on July 1, 3000.
