A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
2	amended by adding a new section to subpart C of part II to be
3	appropriately designated and to read as follows:
4	"§302A- Free school lunch pilot program. (a) The
5	department shall develop and implement a pilot program that,
6	beginning with the 2025-2026 school year, provides free school
7	lunches to all students enrolled at a department school.
8	(b) The department shall adopt rules pursuant to
9	chapter 91 for the administration and operation of the free
10	school lunch pilot program.
11	(c) The department shall submit an interim report on:
12	(1) The department's progress in implementing the free
13	school lunch pilot program;
14	(2) Preliminary results of the free school lunch pilot
15	program; and
16	(3) The department's findings and recommendations,

1	to the legislature no later than twenty days prior to the
2	convening of the regular session of 2026.
3	(d) The department shall submit a final report of its
4	findings and recommendations, including any proposed
5	legislation, to the legislature no later than twenty days prior
6	to the convening of the regular session of 2027. The report
7	shall include the results of the free school lunch pilot program
8	and a recommendation as to whether the program should be made
9	permanent, with or without modifications.
10	(e) The free school lunch pilot program shall terminate on
11	June 30, 2027."
12	SECTION 2. Section 302A-404, Hawaii Revised Statutes, is
13	amended to read as follows:
14	"§302A-404 School meals[-]; free school lunch. (a)
15	School meals shall be made available under the school meals
16	program in every school where the students are required to eat
17	meals at school.
18	(b) Beginning with the 2025-2026 school year, free school
19	lunch shall be provided to every student enrolled at a
20	department school. Free school lunch shall meet the meal

1 requirements for lunches established pursuant to title 7 Code of 2 Federal Regulations section 210.10. 3 [(b)] (c) No student shall be denied a meal solely for 4 failure to pay: 5 (1)Within the first twenty-one days of the first semester 6 of a school year while the student's application for 7 free or reduced lunch is being processed; or 8 (2) Within seven days after a student's meal fund account 9 reaches a zero or negative balance. 10 [(c)] (d) The department may adopt rules or policies 11 governing the collection of funds for student meal accounts with a negative fund balance; provided that no rule or policy shall 12 13 prohibit feeding a student as required pursuant to 14 subsection (b). 15 (e) It is the intent of this section not to jeopardize the 16 receipt of any federal aid and to the extent, and only to the 17 extent necessary to effectuate this intent, the governor may 18 modify the strict provisions of this section, but shall promptly 19 report any modification with the governor's reasons therefor to 20 the next succeeding session of the legislature for review."

1 SECTION 3. Section 302A-405, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: 3 "(a) [The] Except as provided in section 302A-404(b), the 4 price for school meals shall be set by the department to ensure 5 that moneys received from the sale of the meals shall be not 6 less than one-half of the cost of preparing the meals. The 7 prices for school meals may be adjusted annually based on the 8 previous year's costs rounded to the nearest five cents; 9 provided that the department by rule shall provide a lower rate 10 or free meals to children based on their economic need." 11 SECTION 4. There is appropriated out of the general 12 revenues of the State of Hawaii the sum of \$ or so 13 much thereof as may be necessary for fiscal year 2025-2026 and 14 the same sum or so much thereof as may be necessary for fiscal 15 year 2026-2027 for the school food services branch of the 16 department of education for total plate costs associated with 17 the free school lunch pilot program established by this Act, 18 after federal funding has been accounted. 19 The sums appropriated shall be expended by the department
