#### A BILL FOR AN ACT

RELATING TO EMERGENCY MANAGEMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 127A, Hawaii Revised Statutes, is

11	framework for managing all emergencies and preplanned events.
12	This application shall ensure standardized organization
13	structures, action planning, chain of command, unity of command,
14	and communication protocols that are in alignment with the
15	National Incident Management Incident Command System principles.
16	(c) The agency shall designate a National Incident
17	Management System coordinator to oversee implementation, serve

1	as a point of contact for local jurisdictions, and ensure
2	interagency coordination within the State.
3	(d) All personnel involved in incident response shall
4	complete National Incident Management System compliant training
5	specific to their roles, including Incident Command System and
6	resource management courses. The agency shall implement ongoing
7	training to meet National Incident Management System standards,
8	with periodic reviews and refresher courses to maintain
9	proficiency.
10	(e) The agency shall maintain a comprehensive inventory of
11	deployable resources using standardized National Incident
12	Management System typing definitions, including developing
13	mutual aid agreements and contracts with local and private
14	entities, as applicable, to ensure resource availability and
15	efficient resource deployment during incidents.
16	(f) The agency shall establish interoperable communication
17	systems across agencies, employing National Incident Management
18	System protocols for clear, plain language communications,
19	facilitating effective interagency coordination during emergency
20	responses.

1	(g) The agency shall conduct annual audits on National
2	Incident Management System compliance, including training
3	completion rates, resource management effectiveness, and system
4	integration success. The results of the audit shall be

7	the public, and posted to the agency's website.
8	<pre>§127A- After-action review; publication; liability</pre>
9	<b>protection.</b> (a) The agency shall complete an after-action
10	review for all significant emergency incidents or exercises
11	within six months following the emergency incident or exercise.
12	Each after-action review shall include key findings, including:
13	(1) A detailed account of effective actions and areas for
14	improvement; and
15	(2) Recommended actions to enhance future response
16	capabilities with each action having an assigned
17	responsible party, due date, and management oversight.
18	(b) The agency shall adhere to a structured timeline for
19	drafting, reviewing, and finalizing each after-action review to
20	ensure prompt availability. Finalized after-action reviews

#### Description:

Requires the Hawaii Emergency Management Agency to: (1) Adopt the National Incident Management System as the standard for all incident management and emergency response operations; (2) Complete an after-action review for all significant emergency incidents or exercises; (3) Develop and manage position task books; (4) require the use of standardized Incident Command System forms; (5) Maintain accreditation through the Emergency Management Accreditation Program; and (6) Define specific roles and responsibilities for all Incident Command System and emergency operations center positions. Expands training and education qualifications and responsibilities for the Administrator of Emergency Management and county-level administrators or directors of emergency management. Amends the contents of the state comprehensive emergency management plan.
