A BILL FOR AN ACT

RELATING TO CAMPAIGN CONTRIBUTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 11-302, Hawaii Revised Statutes, is
- 2 amended by amending the definition of "immediate family" to read
- 3 as follows:
- 4 ""Immediate family" means a [candidate's] spouse or
- 5 reciprocal beneficiary, as defined in section 572C-3, and any
- 6 child, parent, grandparent, brother, or sister [of the
- 7 candidate], and the spouses or reciprocal beneficiaries of such
- 8 persons."
- 9 SECTION 2. Section 11-355, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- "[+]\$11-355[+] Contributions by state [and] or county
- 12 contractors, state or county grantees, officers or immediate
- 13 family members of state or county contractors, officers or
- 14 immediate family members of state or county grantees;
- 15 prohibited. (a) It shall be unlawful for any person who enters
- 16 into any contract with the State, any of the counties, or any
- 17 department or agency thereof either for the rendition of

- 8 thirty calendar days of receipt, the unlawful contribution shall
- 9 escheat to the Hawaii election campaign fund.
- 10 [\(\frac{(b)}{}\)] (f) Except as provided in subsection (a), this
- 11 section [does] shall not prohibit or make unlawful the
- 12 establishment or administration of, or the solicitation of
- 13 contributions to, any noncandidate committee by any person other
- 14 than the state or county contractor for the purpose of
- 15 influencing the nomination for election, or the election of any
- 16 person to office.
- 17 $\left[\frac{(c)}{(c)}\right]$ (g) For purposes of this section, "completion of the
- 18 contract" means that the parties to the government contract have
- 19 either terminated the contract [prior to] before completion of
- 20 performance or fully performed the duties and obligations under
- 21 the contract, no disputes relating to the performance and

- 1 payment remain under the contract, and all disputed claims have
- 2 been adjudicated and are final.
- 3 (h) Each state and county agency shall report to the
- 4 commission the names of any state or county contractor or
- 5 grantee and the names of the contractor's and grantee's officers
- 6 and adult immediate family members. The commission shall
- 7 periodically publish the names of the state and county
- 8 contractors and grantees, and their officers and adult immediate
- 9 family members, on its website, as reported by the state and
- 10 county agencies."
- 11 SECTION 3. Section 11-364, Hawaii Revised Statutes, is
- 12 amended by amending subsection (a) to read as follows:
- 13 "(a) Any candidate, candidate committee, or noncandidate
- 14 committee that receives in the aggregate more than the
- 15 applicable contribution limit in section 11-357, 11-358, 11-359,
- 16 or 11-360 shall return any excess contribution to the
- 17 contributor within thirty calendar days of receipt of the excess
- 18 contribution. Any candidate, candidate committee, or
- 19 noncandidate committee that receives in the aggregate more than
- 20 the applicable contribution limit in section 11-362 shall return
- 21 any excess contribution to the contributor within thirty

- 1 calendar days of the end of the election period; provided that
- 2 the candidate, candidate committee, or noncandidate committee
- 3 may choose which contributions to return. Any excess
- 4 contribution not returned to the contributor within thirty
- 5 calendar days shall escheat to the Hawaii election campaign
- 6 fund."
- 7 SECTION 4. This Act does not affect rights and duties that
- 8 matured, penalties that were incurred, and proceedings that were
- 9 begun before its effective date.
- 10 SECTION 5. Statutory material to be repealed is bracketed
- 11 and stricken. New statutory material is underscored.
- 12 SECTION 6. This Act shall take effect on July 1, 3000.

Report Title:

CSC; State or County Contractors; State or County Grantees; Officers; Immediate Family Members; Prohibited Contributions

Description:

Prohibits state or county grantees and officers and immediate family members of state or county contractors or grantees from contributing to candidate or noncandidate committees, candidates, or any person for any political purpose for the duration of the contract. Requires any unlawful contribution to be returned to the contributor or it will escheat to the Hawaii Election Campaign Fund. Requires the Campaign Spending Commission to publish the names of the state and county contractors and grantees, and their officers and adult immediate family members, on its website, as reported by the state and county agencies. Effective 7/1/3000. (HD1)
