### A BILL FOR AN ACT

RELATING TO THE REGULATION OF TOBACCO PRODUCTS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that tobacco use remains

2 the leading cause of preventable death in the United States and

3 in Hawaii. Recent years have brought a precipitous increase in

4 consumer sales of electronic smoking devices, sometimes called

5 "vapes", and one inhalation of these products can contain many

6 times more nicotine than a conventional cigarette. Electronic

7 smoking devices have played a major role in increased rates of

8 youth nicotine addiction, which had been previously on the

9 decline.

10 This increased youth tobacco use prompted Hawaii to adopt

11 laws to increase the minimum smoking age to twenty-one years old

12 and treat electronic cigarettes in the same manner as the State

treats conventional cigarettes for purposes of clean indoor air

14 laws. The State and the county of Hawaii, county of Maui, and

15 city and county of Honolulu have also adopted policies to ban

16 smoking, including electronic cigarette use, at state and county

17 beaches and parks.

### H.B. NO. H.D. 1

In 2018, in order to ensure uniform regulations on tobacco 1 sales, the legislature passed Act 206, Session Laws of Hawaii, 2 which, in part, declared the sale of cigarettes, tobacco 3 products, and electronic smoking devices a matter of statewide 4 concern, and nullified any existing local ordinances or policies 5 that restricted the sale of these products. However, the 6 legislature finds that since the Act's passage, youth tobacco 7 use has continued to increase to epidemic levels. According to 8 the 2019 Hawaii Youth Risk Behavior Survey, thirty-one per cent 9 of middle school students and forty-eight per cent of public 10 high school students had tried electronic smoking devices. The 11 2019 Hawaii Youth Risk Behavior Survey also indicates that 12 eighteen per cent of middle school students and thirty-one per 13 14 cent of high school students currently vape. The legislature further finds that in order to end this 15 youth vaping epidemic, the State must work in concert with 16 youth, parents, and educational institutions, and laws must be 17 changed at all levels of government to establish reasonable 18 19 restrictions on the sale of and access to these addictive 20 products.

14	regulate the sale of cigarettes, tobacco products, and	
15	electronic smoking devices in a uniform and exclusive manner.	
16	(b) All local ordinances or regulations that regulate the	
17	sale of cigarettes, tobacco products, and electronic smoking	
18	devices are preempted, and existing local laws and regulations	
19	conflicting with this chapter are null and void.	
20	(c) Nothing in this chapter shall be construed to limit a	
21	county's authority under section 328J-15."]
