### A BILL FOR AN ACT

RELATING TO FIREWORKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the use of consumer
- 2 fireworks causes fires and burn injuries, mostly to children.
- 3 Widespread use of fireworks is an ignition source for fires in
- 4 Hawaii. Fireworks produce excessive smoke that makes breathing
- 5 difficult. Noise from loud fireworks traumatizes many
- 6 residents, including war veterans and pets. With the increase
- 7 in fireworks-related calls, public safety agencies are strained
- 8 to maintain adequate response levels for other critical
- 9 emergencies. The legislature further finds that people in the
- 10 State and its communities deserve to live in peace and security
- 11 without the public safety risk and disruptive impact of consumer
- 12 fireworks.
- 13 The purpose of this Act is to limit the use of consumer
- 14 fireworks by:
- 15 (1) Authorizing the sale and use of consumer fireworks
- only for cultural purposes; and

1	(2) Discontinuing the authorization of the use of consumer		
2	fireworks on New Year's Eve, the Fourth of July, and		
3	Chinese New Year's Day.		
4	This Act is not intended to prohibit licensed		
5	professionals' use of display fireworks, articles pyrotechnic,		
6	and aerial devices.		
7	SECTION 2. Section 132D-2, Hawaii Revised Statutes, is		
8	amended by amending the definitions of "consumer fireworks" and		
9	"cultural" to read as follows:		
10	""Consumer fireworks" [means]:		
11	(1) Means any fireworks designed primarily for retail sale		
12	to the public [during authorized dates and times,		
13	that produces visible or audible effects by		
14	combustion, and that is designed to remain on or near		
15	the ground and, while stationary or spinning rapidly		
16	on or near the ground, emits smoke, a shower of		
17	colored sparks, whistling effects, flitter sparks, or		
18	balls of colored sparks, and includes combination		
19	items that contain one or more of these effects.		
20	"Consumer fireworks" shall comply with the		
21	construction, chemical composition, and labeling		

1		regulations of the United States Consumer Product
2		Safety Commission as set forth in Title 16 Code of
3	. 4	Federal Regulations and fireworks classified as UN0336
4		and UN0337 by the United States Department of
5		Transportation as set forth in Title 49 Code of
6		Federal Regulations[. "Consumer fireworks" include];
7		and
8	(2)	Include firework items commonly known as firecrackers
9		that are single paper cylinders not exceeding one and
10		one-half inches in length excluding the fuse and
11		one-quarter of an inch in diameter and contain a
12		charge of not more than fifty milligrams of
13		pyrotechnic composition, snakes, sparklers, fountains,
14		and cylindrical or cone fountains that emit effects up
15		to a height not greater than twelve feet above the
16		ground, illuminating torches, bamboo cannons,
17		whistles, toy smoke devices, wheels, and ground
18		spinners that when ignited remain within a circle with
19		a radius of twelve feet as measured from the point
20		where the item was placed and ignited, novelty or
21		trick items, combination items, and other fireworks of

1	like construction that are designed to produce the
2	same or similar effects.
3	"Cultural" means relating to the arts, customs, traditions,
4	mores, and history of $[all of]$ the various ethnic groups of
5	Hawaii."
6	SECTION 3. Section 132D-3, Hawaii Revised Statutes, is
7	amended to read as follows:
8	"§132D-3 [ <del>Permissible uses</del> ] <u>Use</u> of consumer fireworks[-];
9	prohibition; except for cultural use. [Consumer fireworks may
10	be] It shall be unlawful for any person to set off, [ignited,
11	discharged, ignite, discharge or otherwise [caused] cause to
12	explode any consumer fireworks within the State [only:
13	(1) From 9:00 p.m. on New Year's Eve to 1:00 a.m. on New
14	Year's Day; from 7:00 a.m. to 7:00 p.m. on Chinese New
15	Year's Day; and from 1:00 p.m. to 9:00 p.m. on the
16	Fourth of July; or
17	(2) From 9:00 a.m. to 9:00 p.m. as allowed by permit
18	pursuant to section 132D-10 if the proposed cultural
19	use is to occur at any time other than during the
20	periods prescribed in paragraph (1);

3	SECTION 7. This Act does not affect rights and duties that
4	matured, penalties that were incurred, and proceedings that were
5	begun before its effective date.
6	SECTION 8. Statutory material to be repealed is bracketed
7	and stricken. New statutory material is underscored.
8	SECTION 9. This Act shall take effect upon its approval.

#### Report Title:

State Fire Council Package; Fireworks

#### Description:

Amends the definition of "cultural". Prohibits the use of consumer fireworks except for cultural use by permit. Repeals the wording of section 132D-3(1), HRS, that generally allows the use of consumer fireworks without a permit on New Year's Eve, New Year's Day, and the Fourth of July. Makes it unlawful to offer, display for sale, sell, or furnish consumer fireworks to any person except for cultural use by permit. Prohibits the sale of fireworks to a person more than 5 calendar days before a permitted cultural use. Imposes a fee of \$25 per permit for the purchase and cultural use of consumer fireworks. Imposes a statewide limitation on consumer fireworks, except by permit for cultural use.
