A BILL FOR AN ACT

RELATING TO DOULAS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The Hawaii Revised Statutes is amended by 2 adding a new chapter to be appropriately designated and to read 3 as follows: 4 "CHAPTER 5 **DOULAS** -1 Definitions. As used in this chapter: "Certified doula" means an individual who has received a 7 8 certification to perform doula services from the Childbirth and 9 Postpartum Professional Association, Childbirth International, 10 DONA International, International Childbirth Education 11 Association, or an organization approved by the director. 12 "Client" means any person who receives doula services from 13 a certified doula. "Department" means the department of commerce and consumer 14 15 affairs. "Director" means the director of commerce and consumer 16 17 affairs.

- 9 S -2 Registration required; certified doulas. (a) A
- 10 person who provides doula services for compensation or
- 11 advertises or holds the person's self out as a certified doula
- 12 shall register with the department by filing an application for
- 13 registration on a form prescribed by the director and paying any
- 14 applicable fees established by the director.
- 15 (b) The director shall maintain a registry of certified
- 16 doulas who have met the requirements of this section and rules
- 17 adopted by the director. The director shall provide a link to
- 18 the registry on the department's website.
- 19 § -3 Rights. A certified doula registered under this
- 20 chapter may be present at all times during a client's labor and

 21 or hold the person's self out as a certified doula.

Description:

Requires any person providing doula services for compensation or representing or advertising themselves as a certified doula to register with the Director of Commerce and Consumer Affairs. Establishes certain rights for certified doulas, including being present during delivery and in any recovery rooms, if requested by the client. Requires the Director to maintain a link to the registry on the Department of Commerce and Consumer Affairs' website. Effective 1/1/2026.
