### A BILL FOR AN ACT

RELATING TO AQUACULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 141, Hawaii Revised Statutes, is 2 amended by adding a new section to part IV to be appropriately 3 designated and to read as follows: 4 "\$141- Aquatic livestock import assessment and approval
- 5 process; rules. The division of animal industry may adopt,
- 6 amend, and repeal rules not inconsistent with law to develop an
- 7 assessment and approval process to import and move aquatic
- 8 livestock in the State. This process shall:
- 9 Be based on the framework maintained by the department (1) 10 pursuant to this chapter and chapter 142;
- 11 (2) Include pre-arrival disease testing requirements, 12 entry inspection, and post-arrival inspection; and
- 13 (3) Require quarantine or depopulation of any aquatic 14 animals as necessary."
- 15 SECTION 2. Section 141-51, Hawaii Revised Statutes, is 16 amended by adding three new definitions to be appropriately
- 17 inserted and to read as follows:

1 ""Aquatic livestock" means various species of domestic and 2 non-domestic fish, crustaceans, and mollusks that are propagated 3 and raised for food, restorative activities, or similar 4 commercial purposes. 5 "Biocontainment" means the methods, procedures, facility 6 features, and containment or safety equipment for infectious 7 materials and animals in the aquatic livestock environment where 8 these materials and animals are potentially handled or 9 maintained. "Biocontainment" includes preventing the release of 10 infectious animal species and associated pathogens into the 11 environment. 12 "Biological aquatic risk" means the combination of the 13 consequences of an event and the associated likelihood of its 14 occurrence, where biological material is the source of harm, 15 whether from an escaped aquatic livestock species or associated 16 pathogens or disease." 17 SECTION 3. Section 141-52, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows: 18 19 "(a) There is established within the department an 20 aquaculture program that shall:

1 SECTION 5. The division of animal industry shall develop a 2 biological aquatic risk-based framework for the assessment and 3 approval process to import and move aquatic livestock in the 4 State. In developing the framework, the division of animal 5 industry shall consider: 6 Relevant standards established by the United States (1)7 Department of Agriculture; 8 (2) Current aquatic livestock policies and development 9 issues; 10 (3) Best practices of the aquaculture industry; and 11 (4)The protection of indigenous species as defined in 12 section 195D-2, Hawaii Revised Statutes. 13 Furthermore, the framework shall provide that each aquatic 14 animal import permit valid on the effective date of this Act and 15 that were vetted in public hearing and approved by the plant and 16 animal committee and the board of agriculture shall be carried 17 over to the division of animal industry and remain in force. 18 SECTION 6. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$ 20 much thereof as may be necessary for fiscal year 2025-2026 and 21 the same sum or so much thereof as may be necessary for fiscal

- 1 year 2026-2027 for the division of animal industry to develop a
- 2 biological aquatic risk-based framework pursuant to the
- 3 requirements of this Act.
- 4 The sums appropriated shall be expended by the department
- 5 of agriculture for the purposes of this Act.
- 6 SECTION 7. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 8. This Act shall take effect on July 1, 3000.
