A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that establishing a permanent educational support associate position placed within 2 3 the university of Hawai'i college of tropical agriculture and 4 human resources (CTAHR) is needed to successfully implement the 5 following goals of the college's cooperative extension program: 6 Providing non-formal science-based education; (1)7 (2)Acting as the outreach component of CTAHR; and 8 (3) Extending practical applications of science to support 9 local food systems, healthy living, youth development, 10 and the stewardship of natural resources for future 11 generations. 12 The legislature further finds that CTAHR's Kona cooperative

13 extension, which houses the Kona research station, provides 14 crucial support for local coffee farmers statewide, who 15 currently face dire threats to their crops from the recently 16 discovered coffee berry borer and from coffee leaf rust. With a 17 utilized production value of approximately \$48.2 million in the

2023 to 2024 season, the coffee industry represents the State's
most valuable agricultural commodity according to the United
States Department of Agriculture (USDA). Despite this, the
coffee industry is currently served statewide by just one CTAHR
extension agent.

The legislature further finds that CTAHR's sole extension 6 7 agent is currently supported by just one educational support 8 associate position, which has historically been one hundred per cent grant funded. Due to varying grant provisions, the 9 10 position is limited to work only within the scope of funded 11 projects and is unable to address the needs and challenges of 12 other industries supported by CTAHR's cooperative extension 13 program. Additionally, upwards of thirty to forty-seven per 14 cent of current grant funding is dedicated to salary and fringe 15 benefits for project support staff, which reduces funding for 16 educational events, applied research, travel for statewide 17 outreach, equipment, and materials and supplies that could directly benefit local farmers and producers. 18

19 The legislature further finds that establishing a permanent 20 educational support associate position will provide much needed 21 support to extension faculty; enable the prioritization of

research and community outreach projects throughout the State;
and support the Kona research station, which, among other
projects, encompasses eighteen acres of projects related to
coffee, including coffee leaf rust and coffee berry borer
mitigation.

6 Accordingly, the purpose of this Act is to establish and 7 fund a permanent educational support associate position, within 8 the university of Hawai'i college of tropical agriculture and 9 human resources' Kona cooperative extension and applied research 10 program, to provide administrative, professional, and technical 11 support to the college's cooperative extension program and Kona 12 research station.

13 SECTION 2. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$76,570 or so much 15 thereof as may be necessary for fiscal year 2025-2026 and the 16 same sum or so much thereof as may be necessary for fiscal year 2026-2027 for the establishment of one full-time equivalent (1.0 17 18 FTE) permanent educational support associate position within the 19 university of Hawaii college of tropical agriculture and human 20 resources' Kona cooperative extension to support the coffee and

orchard crops extension and applied research program and the
Kona research station in the county of Hawaii.
The sums appropriated shall be expended by the university
of Hawaii for the purposes of this Act.
SECTION 3. This Act shall take effect on July 1, 2025.
